#### **Note 1 - Description of Plan**

The following description of The Hamilton Company, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

a) General

The Plan is a defined contribution plan for all nonunion employees of the Hamilton Company, Inc. ("Company") who are age 21 and older and have completed three months of service as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b) Contributions

The Plan provides for both pre-tax and Roth deferral contributions. Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan document, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan includes an auto-enrollment provision whereby all new eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate.

The Plan Sponsor makes contributions to the Plan on behalf of eligible participants who participate in the plan. The employer contribution is based on a participant's length of service with the company and the participant's base compensation. Individuals who have completed three months of service for the company and have attained the age of 21 are eligible to receive the employer contribution. Qualified participants are eligible to receive an employer contribution equal to the lesser of 50% of the participant's deferral limited to 3% of the participant's compensation. The total amount of participant deferrals and employer contributions is subject to IRS limitations.

c) Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Company's contribution and the participant's account earnings. Allocation of Company contributions are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d) Vesting

Participants are immediately vested in their contributions plus earnings thereon. Participants are vested in Company discretionary contributions according to the following schedule:

Forfeited balances of terminated participants are used to reduce Company contributions or administrative expenses.

e) Notes Receivable from Participants

Participants may have up to three active loans at one time, only one of which may be a Primary Residence Loan. The Plan allows for hardship loans. Loans are limited to 50% of a participant's vested account balance or \$50,000 reduced by outstanding loans. Loans must be a minimum of \$500. Loans are secured by the participant's account and bear interest at the prime rate plus 2%. Loans are repaid through payroll deductions. The term of the loan generally may not extend for more than five years. Loans used to purchase a primary residence must be repaid within thirty years. A processing fee is charged to the participant's account for each new loan.

f) Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive their vested account balance in a lump-sum or in installments. For other terminations, distributions are made in a lump sum. Benefits payments are recorded when paid.

g) Plan Expenses

The Plan is sponsored by The Hamilton Company, Inc. Administrative expenses are paid by the sponsor.

#### **Note 2 - Summary of Significant Accounting Policies**

##### *Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America, except for distributions paid to participants which are prepared on the cash basis of accounting.

##### *Accounting Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### *Risks and Uncertainties*

The Plan invests in various investments, all of which are participant directed. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value.

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Participant borrowings made through the Plan comprise the balance of participant notes receivable which are included with receivables in the accompanying statements of net assets available for benefits. Interest income earned on participant notes receivable is accounted for and presented on a separate line item on the accompanying statement of changes in net assets available for benefits. The principal balance of participant loans was \$214,029 and \$184,947 as of December 31, 2024 and 2023, respectively. Loans outstanding bear annual interest at 5.25%- 10.50% at December 31, 2024 and an annual interest at 5.25% - 10.50% at December 31, 2023.

##### *Uncertain Tax Positions*

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

Plan management along with the plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for three years prior.

##### *Subsequent Events*

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 6, 2025 the date the financial statements were available to be issued.

#### **Note 3 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note 5 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered Investment Company Funds:* Valued at quoted market prices which are the net asset value ("NAV") of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 - Transactions with Related Parties**

The Plan pays transaction fees to the custodian in connection with the management of investments that have been included with the appreciation (depreciation) of fair value of investments.

The Plan invests in funds sponsored by Fidelity, administrator and custodian of the Plan.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

These transactions qualify as exempt party-in-interest transactions.

**Note 7 - Income Tax Status**

The Plan is an adoption of a prototype plan. The prototype plan received a favorable determination letter, dated August 30, 2001, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the financial statements.
