INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the
Heartland Family Service Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heartland Family Service Retirement Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”)
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Heartland Family Service Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

General – The Plan was established effective May 15, 2018 and is a defined contribution plan covering eligible employees of Heartland Family Service (the “Agency”), as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Upon reaching age twenty-one, employees are immediately eligible to participate in the Plan and make elective contributions to the Plan. Employees who have completed one year of service, during which at least 1,000 hours of service have been completed, as defined in the Plan document, are eligible to receive safe harbor matching contributions and qualified matching contributions from the Agency. Age and service requirements are waived if an employee was employed by the Agency at the effective date of the Plan, provided they are at least 18 years of age.

Contributions – Participants may contribute up to 100% of their annual compensation, as defined by the Plan, not to exceed the maximum allowed by the Internal Revenue Code, through either pre-tax or after-tax Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute rollover distributions from other qualified benefit plans. The Agency makes safe harbor matching contributions equal to 100% of participant contributions up to 5% of total compensation. In addition, the Agency can make additional discretionary matching contributions. For the years ended December 31, 2024 and 2023, Agency made an additional discretionary matching contribution equal to 140% of the participant's deferral up to 5% of eligible compensation. Participants direct the investment of all contributions into various options offered by the Plan.

Participants Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Agency’s contribution and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants immediately vest in their contributions and agency safe harbor contributions plus earnings thereon. Vesting in other discretionary Agency contributions is subject to the following schedule.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are not to have more than two outstanding loans at any time. The loans are secured by the balance in the participant's account. The loan interest rate is set at the Wall Street Journal prime rate plus 1%, as defined. Interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through periodic payroll deductions.

Payment of Benefits – Upon reaching the age of 59 1/2, retirement, disability, or death, participants or beneficiaries may elect to receive a lump sum payment or non-recurring partial payments equal to the value of the participant's vested account balance. If no election is made by the participant, vested accounts of \$1,000 or less will be paid in a single lump sum and vested accounts greater than \$1,000 but not exceeding \$5,000 will be rolled over to an individual retirement account.

Forfeited Accounts – Forfeited participant balances are retained by the Plan and used to offset future Agency contributions or to pay Plan administrative expenses. There were no forfeitures used to offset Agency contributions during each of the years ended December 31, 2024 and 2023. In 2024, \$8,724 of forfeitures were used to pay plan expenses and \$7,000 in 2023. There was \$18,306 and \$13,749 of forfeited account balances as of December 31, 2024 and 2023, respectively.

2. Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract.

Purchases and sales of securities are recorded on the trade-date. Dividend are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

2. Summary of Accounting Policies - Continued

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Interest income is recorded on the accrual basis. Delinquent participant loans, if applicable, are recorded as distributions based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Trustee fees and administrative costs are paid by the Plan, except the Agency, at its discretion, may pay for certain administrative costs. Costs directly related to notes receivable from participants are charged to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events – Management evaluated transactions and events occurring subsequent to December 31, 2024, and through October 1, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment funds (CIF's): Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Pooled Separate Account (PSA): Valued at the net asset value (NAV), based upon the market value of its underlying investments, which may include equities, bonds, real estate, mutual funds, separate accounts and collective trust funds. PSA NAV is provided by the issuer, United, and is not a publicly quoted price in an active market.

5. Plan Termination – Subsequent Event

The Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. The Agency approved the termination of the Plan effective May 31, 2025 and the Agency began participating in a pooled employer plan. Participants became fully vested and their accounts were transferred to the pooled employer plan.

6. Tax Status - Continued

The Plan is a preapproved plan created by United and adopted by the Agency on May 15, 2018. On September 21, 2020, the Internal Revenue Service stated the preapproved plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by tax authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-interest Transactions

The Plan engages Ascensus and previously United as recordkeepers for the Plan. Administrative expenses paid to Ascensus and United totaled \$14,490 and \$6,425 during 2024 and 2023, respectively.

8. Risks and Uncertainties

The Plan provides for investment options in various investment securities which are exposed to interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in value of investments will occur, and such changes could materially affect participant account balances, and the amounts reported in the statements of net assets available for benefits.
