Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Riggs Oil Co., Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 - DESCRIPTION OF PLAN

The following description of the Riggs Oil Co., Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - Riggs Oil Company is located in southwest Virginia and distributes motor vehicle fuels and operates a chain of convenience stores which serve as retail outlets for motor vehicle fuels. The Plan is a defined contribution plan with a profit sharing component, covering all employees who have reached 21 years of age and completed one year of service with at least 1,000 hours of service during the twelve consecutive months following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective November 1, 2021, to bring the Plan into compliance with the requirements of the 2017 Cumulative List (Notice 2017-37).

Contributions - Each year, participants may contribute up to 100% of their annual gross compensation, as defined in the Plan, subject to IRC limitations. Participants who have attained the age fifty before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified defined benefit or contribution plans.

The Company makes matching contributions dollar-for-dollar on the first 3% of earnings that employees contribute to the Plan. Additional pretax sharing contributions may be made at the option of the Company's Administrative Committee. Contributions are subject to certain limitations.

Participant Accounts - Each participant's account is credited with participant and employer contributions and allocations of Plan earnings and charged with allocations of administrative expenses. Allocations of Plan earnings and administrative expenses are based on investment earnings and administrative expenses in combination with account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. All contributions are participant directed, allowing participants to direct the investment of contributions into various investment options offered by the Plan. Participants are able to change their investment options via the internet.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service with each participant becoming 20% vested after the second year of service in which they are credited with 1,000 hours of service. A participant is 100% fully vested in their matching and discretionary after six years of credited service. Refer to the Summary Plan Description for a more complete description.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant (or participant's beneficiaries) will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Partial withdrawals or installments are only permitted for Participants or Beneficiaries who must receive required minimum distributions.

Administrative Expenses - Administrative expenses related to administration of the Plan are paid from forfeitures of participant's unvested portion of their account balances. Participant accounts are only charged for investment fees. Investment management fees are netted out of mutual fund income in arriving at the net investment income allocated to participants.

Forfeitures - Forfeitures may be used to pay plan expenses. Subsequent to paying plan expenses, for the Plan Year in which the forfeitures occur, forfeitures may be used to reduce nonelective and or employer matching contributions.

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Investment Valuation and Income Recognition - Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fixed account investment agreement with insurance company is reported at contract value. See Note 4 for a discussion of fair value measurements and Note 5 for the fixed account investment agreement with insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation/depreciation in the fair value of investments includes the Plan's investment earnings, gains and losses on investments bought and sold, and appreciation or depreciation in the value of the underlying assets in the mutual funds.

Payment of Benefits - Benefits paid to participants are recorded when paid.

Date of Management's Review - Management has evaluated events and transactions occurring subsequent to the statements of net assets available for benefits date for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through October 9, 2025, which is the date these financial statements were available to be issued.

NOTE 3 - TRUSTEE CERTIFICATION OF INVESTMENTS IN TRUST

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from the Trustee that the investment information provided by the Trustee to the Plan is complete and accurate.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified complete and accurate by the trustee, Empower Annuity Insurance Company of America ("Empower").

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements), and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 - FAIR VALUE MEASUREMENTS - (Continued)

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024.

Mutual funds - Fair value of the plan's investment in the mutual funds are based on the fair value of the underlying variable portfolios of mutual funds selected by plan participants. The fair value of the underlying portfolios at December 31, 2024 and 2023, are based on the closing net asset value ("NAV") of the corresponding fund shares held at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - FIXED ACCOUNT VIA GROUP VARIABLE FUNDING AGREEMENT

In 2019, the Plan entered into a Group Variable Funding Agreement with Massachusetts Mutual Life Insurance Company ("MassMutual"). As part of the Group Variable Funding Agreement, MassMutual maintains contributions in a general fixed account that is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative fees. The fixed account is included in the statements of changes in net assets available for benefits at contract value as reported to the Plan by MassMutual. Because the fixed account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fixed account. Contract value represents contributions plus credited interest less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The fixed account issuer is obligated by agreement to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the agreement issuer or otherwise. The average yield and crediting interest rate were approximately 2.80% and 1.70% for 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events limit the ability of the Plan to transact at contract value with MassMutual. Such events include the following: (1) the Plan or Plan trust fails to maintain its special tax qualified or exempt status under 401(a) of the Code, (2) plan sponsor fails to provide MassMutual information necessary for them to perform the Agreement and plan sponsor fails to remedy the failure within 31 days from the date MassMutual notifies the plan sponsor, (3) the Plan trust is amended in a way that adversely affects MassMutual's obligations under this Agreement, (4) all group variable funding agreements in this class of business are amended, changed or altered due to changes in any applicable laws and MassMutual determines that their obligations under this Agreement or ability to maintain this class of business are thereby materially affected, (5) the assets held or the Participants covered under the Agreement are less than the amount required for the Agreement to be a group funding agreement under any applicable insurance law, (6) plan sponsor changes such that plan sponsor is no longer considered to be an entity which is authorized or eligible to sponsor this Agreement, (7) no Contributions are made to MassMutual during any consecutive 12 month period, (8) at any time the Contributions or balances are less than the amount required for this class of business under MassMutual's underwriting standards in effect as of the Agreement Effective Date. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 - FORFEITURES

During the Plan years ended December 31, 2024 and 2023, participants forfeited non-vested employer matching and profit sharing contributions for a total of \$10,792 and \$5,913, respectively. As of December 31, 2024 and 2023, \$20,134 and \$25,659, respectively, were available to offset future employer contributions. The Plan used \$17,058 in 2024 and \$0 in 2023 to offset employer contributions.

NOTE 7 - TAX STATUS OF PLAN

The IRS has determined and informed the Plan sponsor via an opinion letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is no longer subject to tax examinations for years prior to 2020.

The Plan recognizes tax loss contingencies when it is probable that a liability had been incurred and the amount of the loss could be reasonably estimated. The amount recognized would be subject to estimates and management's judgment with respect to the likely outcome of each uncertain tax position. Although the tax years ending December 31, 2021 through December 31, 2024 remain open for examination by various taxing authorities, it is management's opinion that no significant uncertain tax positions remain open at December 31, 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - TRANSACTIONS WITH PARTY-IN-INTEREST

Certain Plan investments are mutual funds owned and managed by Mass Mutual Life Insurance Company (“Mass Mutual”), the Plan’s former third-party administrator. As such, these transactions qualify as party-in-interest transactions. In January 2021, Empower Retirement acquired mass Mutual.

The Company is the administrator of the Plan, and as such executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Company on behalf of the Plan. There were no financial transactions recorded between the Company and the Plan other than contributions made by the Company to the Plan.

ClearPoint CPAs, PC (formerly Rodefer Moss & Co, PLLC) audited the Plan for 2024 and 2023 and their fees were paid directly by the Plan sponsor.

NOTE 10 - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to discontinue contributions at any time and to terminate participation in Plan subject to the related provisions of ERISA. In the event of termination or permanent discontinuance of contributions, participants would become 100% vested in their accounts.
