Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Decorators and Displaymen Local 39-U Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment information of the Plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Plan Description

The following description of Decorators and Displaymen Local 39-U Annuity Plan (the "Plan") is provided for financial reporting purposes only. Participants of the Plan should refer to the plan document and summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined contribution retirement plan, established January 1, 1998, pursuant to a collective bargaining agreement ("CBA") between Decorators and Displaymen Local 39-U (the "Union") and the participating employers (the "Employers") to provide retirement, death, and disability benefits to eligible participants and beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Administration of the Plan is the responsibility of the Board of Trustees (the "Trustees") and is governed by a joint board consisting of equal representation from the Employers and the Union.

Eligibility

Employees who are engaged in covered employment by Employers become eligible to participate in the Plan when contributions are paid on their behalf pursuant to a CBA with the Union.

Contributions

Each Employer contributes to the Plan such amounts and at such times as required by the applicable provision of the CBA or such other agreements as are approved by the Trustees. Contributions are based on various contribution rates for each Employer. Contributions are made on a monthly basis throughout the year.

Participant Accounts

Each participant's account is credited with the Employers' contributions, made on their behalf, and credited directly to their account each month. The participant accounts are allocated to the Plan's earnings and are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balance, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants become fully vested in the Employer contributions upon accruing three years of credited service. Participants earn one year of credited service in which they are credited with at least 500 hours of service or have at least \$500 in Employer contributions made on their behalf. Participants are fully vested in their account upon attainment of normal retirement age, regardless of the number of credited years of service.

Employer contributions made on behalf of an employee that is not vested and has a break in service such that prior contributions may not be vested, or Employer contributions received on behalf of a participant that has not vested in any Plan year which do not result in a credited year of service may be forfeited. Forfeitures occur immediately upon the break of service for which prior contributions may not be vested, or at the end of the Plan year for which a non-vested participant does not receive a credited year of service. Any forfeitures will be used to pay necessary administrative expenses, fees, and costs of administration of the Plan. Excess forfeitures may be distributed on an equitable basis pursuant to determination of the Trustees for vested participants.

For the years ended December 31, 2024 and 2023, no amounts were forfeited.

Payment of Benefits

Benefits are paid to participants upon termination of service due to retirement, death, disability, or other reasons. Participants are eligible to receive normal retirement benefits upon reaching age 62, early retirement benefits upon the later of age 55 or their fifth anniversary of participation in the Plan, disability, or after twelve consecutive months of separation from covered employment. Participants may choose to receive either a lump-sum payment equal to their account balance or life annuity payments.

A detailed description of all available elections for the payment of benefits is available in the summary plan description, which is provided to each participant.

2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan have been prepared in accordance with the provisions of the Financial Accounting Standards Board ("FASB"), Accounting Standards Codification (the "FASB ASC"), which is the source of authoritative, non-governmental accounting principles generally accepted in the United States of America ("GAAP"). All references to authoritative accounting guidance contained in our disclosures are based on the general accounting topics within the FASB ASC.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair Value Measurements

The Plan follows guidance issued by the FASB on fair value measurements, which establishes a framework for measuring fair value, clarifies the definition of fair value within that framework, and expands disclosures about the use of fair value measurements. This guidance applies whenever fair value is the applicable measurement. The three general valuation techniques used to measure fair value are the market approach, cost approach, and income approach.

Employer Contributions Receivable

Employer contributions receivable represents Employer contributions due to the Plan for hours worked prior to the end of the Plan year, but not yet received by year-end. Employer contributions receivables are reported at their outstanding balances, net of an estimate made for credit losses. Management estimates the allowance for credit losses by regularly evaluating individual Employer receivables and considering an Employer's financial condition, payment history, current economic conditions, and management's expectations of conditions in the future. Employer contributions receivables are written off when deemed uncollectible and collection enforcement efforts have failed to produce payments and additional efforts are not warranted. Management is of the opinion that no allowance for credit losses is necessary as of December 31, 2024 and 2023.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan permits the payment of Plan expenses from Plan assets. Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

3. Information Certified by the Custodian

At December 31, 2024, the Plan's investments are held by John Hancock Life Insurance Company, (U.S.A.) ("John Hancock"), the custodian of the Plan. Financial information relating to those investments is included in the accompanying financial statements and supplemental schedule, including net appreciation in fair value of investments, interest and dividends based on information provided by the custodian. That information has been prepared and certified to as complete and accurate by John Hancock.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy which prioritizes the inputs to valuation techniques used to measure fair value into Levels 1, 2, and 3. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

The instruments' fair value measurement levels within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value.

Investments, at fair value, consist of pooled separate accounts which are directly invested in mutual funds, collective investment trusts, or exchange-traded fund. These securities are valued at the net asset value ("NAV") based on the observable underlying investments. The NAV is used as a practical expedient to estimate fair value.

5. Related Party Transactions

The Plan has an Administrative Agreement with Pension Planning Consultants, Inc. to perform engagement, administrative, and recordkeeping functions of the Plan. Pension Planning Consultants, Inc. is considered a party-in-interest. Total administrative fees paid to Pension Planning Consultants, Inc. for the years ended December 31, 2024 and 2023 were \$7,392 and \$6,106, respectively.

6. Plan Amendments

Effective January 1, 2023, the Plan has been amended to be in compliance with the SECURE 2.0 Act.

7. Plan Termination

Although it has not expressed any intent to do so, the Trustees have the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon such termination, the assets shall be used to provide benefits and pay administrative expenses in accordance with the provisions of ERISA. Participants' individual accounts will become non-forfeitable unless those benefits are already forfeited due to a permanent break in service at the time of termination.

8. Tax Status of Plan

The Internal Revenue Service has determined and informed management by a letter dated October 14, 2011, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the determination letter. Management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

In accordance with GAAP, management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. Management believes the Plan is no longer subject to income tax examinations for years prior to 2021. The Plan is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

9. Risks and Uncertainties

Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions

The majority of receivables are from Employers primarily located in or working in Missouri. The Plan generally does not require collateral, but in some cases can require a performance bond.

10. Subsequent Events

The Plan has evaluated subsequent events through October 01, 2025, the date the financial statements were available to be issued.

In January 2025, the Plan amended the criteria for a credited year of service as well as adjusting how the accumulated shares of participants who fail to make an election are handled. In addition, the Plan added language regarding involuntary distributions.
