### 1. Description of Plan

The following description of Westwood Professional Services, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan was adopted effective January 1, 1984 by Westwood Professional Services, Inc.; Westwood Surveying and Engineering, P.C.; and OMNNI Associates, Inc. (collectively, the Company or Employer). Westwood Professional Services, Inc. is the sponsor of the Plan. The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee and Administration of the Plan*

The trustee and recordkeeper of the Plan is Empower Trust Company (the Trustee). The administrator of the Plan is the Company. The trustee hold all assets of the Plan in accordance with the service provider contract with the Company. The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

All employees of the Company are eligible to participate in the Plan upon attainment of age 18. Participants are eligible for the nonelective discretionary profit-sharing contribution if they meet the eligibility requirements above, work 1,000 hours during the Plan year, and are employed on the last day of the Plan year.

The Plan excludes nonresident aliens, employees covered by a collective bargaining agreement, interns, and project employees. Field pipeline employees are excluded from the employer nonelective contribution profit-sharing provision of the Plan.

#### *Contributions*

Each year, participants may contribute up to 90% of eligible compensation, as defined in the Plan. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan Administrator and the Plan Document. The Plan also allows for Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company may also make a nonelective discretionary profit-sharing contributions to the Plan provided they have met the eligibility requirements. The discretionary non-elective contributions for 2024 total \$7,159,651 The participant's allocation of the profit-sharing contribution is based on the participant's individual compensation divided by total compensation for all eligible participants.

The Company may make safe harbor contributions to the Plan. For the year ended December 31, 2024 the Company safe harbor contribution was \$5,324,920 the contribution was 100% of the participant elective deferral which do not exceed 4% of compensation.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's matching contribution, an allocation of the Company's profit-sharing contribution, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided by the vested portion of their accounts.

### ***Vesting***

Participants are immediately vested in their individual contributions, Roth, rollover contributions and matching contributions plus actual earnings thereon. Vesting in the Company non-elective discretionary profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Regardless of the nonelective contribution vesting schedule noted above, participants whose entry Date is prior to January 1, 2018 will be 100% vested at all times in all accounts upon the attainment of age 55. Regardless of the vesting schedules noted above, participants who transferred to this Plan from the Pacheco Koch 401(k) Plan will be subject to the following vesting schedule: one Year of Service (YOS) - 25%, two YOS - 50%, three YOS - 75%, and four YOS - 100% with respect to nonelective and prior matching contributions. Regardless of the vesting schedules above, prior Safe Harbor matching contributions that were transferred to this Plan from the Pacheco Koch 401(k) Plan will be subject to the following vesting schedule: zero to one YOS - 0% and two YOS - 100%.

Regardless of the vesting schedule above, Participants who transferred to this plan from the Peloton Land Solutions 401(k) Plan will be subject to the following vesting schedule: zero to one YOS - 0%, two YOS - 20%, three YOS - 40%, four YOS - 60%, five YOS - 80%, six YOS - 100% for contributions prior to January 1, 2024. Regardless of the nonelective vesting schedule above, the following vesting schedule will apply for nonelective contributions made prior to January 1, 2024: zero to one YOS - 0%, two YOS - 20%, three YOS - 40%, four YOS - 60%, five YOS - 80%, six YOS - 100%. Regardless of the vesting schedule above, Participants who transferred to this plan from the O'Dell Engineering, Inc. 401(k) Profit Sharing Plan and Trust will be subject to the following vesting schedule: zero to one YOS - 0%, two YOS - 20%, three YOS - 40%, four YOS - 60%, five YOS - 80%, six YOS - 100% for contributions prior to January 1, 2025.

### ***Notes Receivable from Participants***

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loans are secured by the participant's account and bear an interest rate at the prime rate plus 1%, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years or less, or up to 15 years if used to purchase a principal residence. These loans are subject to certain

restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC). Also, each participant may not have more than one loan outstanding at any time.

### ***Benefit Payments***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution or installments. The Plan allows for in-service distributions for hardship and disability subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

### ***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$431,765 and \$88,161, respectively. These accounts may be used to pay administrative expenses and reduce future employer contributions. \$50,889 of the forfeited funds were used to pay administrative expenses and/or fund employer contributions in 2024.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Non-elective/profit sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Benefit Payments***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, a qualified institution.

## **4. Fair Value of Investments**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - These accounts comprise common stock, mutual funds, and cash and cash equivalents. The individual investments in the self-directed brokerage accounts are valued on the basis of readily determinable market prices.

*Stable Value Fund* - The Putnam Stable value is a common investment trust composed primarily of fully benefit-responsive investment contracts. The stable value fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions may occur daily with no advance notice. There are no unfunded commitments related to these investments. If the Plan initiates a full redemption of the stable value fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. This is a direct filing entity.

*Common/Collective Trusts (CCTs)* - Common/collective trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

## 5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee or their subsidiaries and affiliates. Participant loan and distribution processing fees are paid to the recordkeeper by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

## 6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

## 7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

### 8. Plan Tax Status

The Plan uses a pre-approved plan document sponsored by Empower Retirement LLC. Empower Retirement LLC received an opinion letter from the IRS, dated November 14, 2022, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the assets of O'Dell Engineering, Inc. 401(k) Profit Sharing Plan and Trust were transferred into the Plan. Effective April 2, 2025, the assets of Balzer & Associates 401(k) Profit Sharing Plan and Balzer & Associates Richmond 401(k) Profit Sharing Plan were transferred into the Plan.
