The following required communications summarize our responsibilities regarding the financial statement audit as well as observations from our audit that are significant and relevant to your responsibility to oversee the financial reporting process.

Our Responsibilities

Our responsibilities under auditing standards generally accepted in the United States of America have been described to you in our engagement letter dated March 6, 2025. Our audit of the financial statements does not relieve management or those charged with governance of their responsibilities, which are also described in that letter.

As management determined it is permissible in the circumstances and elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), the audit did not extend to any certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the applicable financial reporting framework.

Planned Scope and Timing of the Audit

We have issued a separate communication dated March 6, 2025, regarding the planned scope and timing of our audit and identified significant risks.

Accounting Policies and Practices

Preferability of Accounting Policies and Practices

Under accounting principles generally accepted in the United States of America, in certain circumstances, management may select among alternative accounting practices. In our view, in such circumstances, management has selected the preferable accounting practice.

Adoption of, or Change in, Accounting Policies

Management has the ultimate responsibility for the appropriateness of the accounting policies used by the Plan. The Plan did not adopt any significant new accounting policies, nor have there been any changes in existing significant accounting policies during the current period.

Accounting Policies and Practices (Continued)

Significant Accounting Policies

We did not identify any significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Unusual Transactions

We did not identify any significant unusual transactions.

Management's Judgments and Accounting Estimates

Accounting estimates are an integral part of the preparation of financial statements and are based upon management's current judgment. The process used by management encompasses their knowledge and experience about past and current events and certain assumptions about future events. There are no particularly sensitive accounting estimates in the financial statements which should be brought to your attention for approval.

Financial Statement Disclosures

The disclosures in the financial statements are objective, consistent and clear. Certain financial statement disclosures are particularly sensitive because of their significance to the financial statement users.

Audit Adjustments and Uncorrected Misstatements

The significant audit adjustments made to the original trial balance (trust report provided by Fidelity Management Trust Company) presented to us to begin our audit were made to reverse prior year receivables and to present the collective investment trust (Fidelity Managed Income Portfolio IV) at fair value.

We are not aware of any uncorrected misstatements other than misstatements that are clearly trivial.

Form 5500 Filing

GAAS require that we obtain and read a draft of the Plan's Form 5500 that is substantially complete prior to the dating of our auditor's report in order to identify material inconsistencies, if any, with the Plan's audited financial statements. We read the Plan's draft Form 5500 filing for consistency with information in the financial statements. We did not identify material inconsistencies with the audited financial statements, other than appropriate reconciling items with the draft Form 5500 as disclosed in the notes to the financial statements.

ERISA-Required Supplemental Schedule

We subjected the information included in the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or the financial statements themselves, and other additional procedures in accordance with GAAS. The objective of these audit procedures was to determine whether the ERISA-required supplemental schedule, other than the certified investment information, is fairly stated in all material respects in relation to the financial statements as a whole, whether the form and content of the ERISA-required supplemental schedule are presented in conformity with the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure Under ERISA, and whether the certified investment information in the supplemental schedules agrees to, or is derived from, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). We will include an other-matter paragraph in our auditor's report for the ERISA-required supplemental schedule. We did not identify inconsistencies with the audited financial statements or with the certified investment information.

Observations About the Audit Process

Disagreements with Management

We encountered no disagreements with management over the application of significant accounting principles, the basis for management's judgments on any significant matters, the scope of the audit, or significant disclosures to be included in the financial statements.

Consultations with Other Accountants

We are not aware of any consultations management had with other accountants about accounting or auditing matters.

Significant Issues Discussed with Management

No significant issues arising from the audit were discussed with or the subject of correspondence with management.

Significant Difficulties Encountered in Performing the Audit

We did not encounter any significant difficulties in dealing with management during the audit.

Significant Matters That Required Consultation

We did not encounter any significant and difficult or contentious matters that required consultation outside the engagement team and that are, in our professional judgment, significant and relevant to your responsibility to oversee the financial reporting process.

Reportable Findings

In planning and performing the audit, we considered plan provisions relevant to designing audit procedures for the purpose of expressing our opinion on the Plan's financial statements, but not for the purpose of expressing an opinion on the Plan's compliance with those provisions. Our audit was not designed to identify all instances that the Plan is not operating in accordance with the Plan's provisions or other specified criteria that might be considered reportable findings.

A reportable finding is one or more of the following:

- A matter that is identified as an instance of noncompliance or suspected noncompliance with laws or regulations
- A finding arising from the audit that is significant and relevant to those charged with governance regarding their responsibility to oversee the financial reporting process
- A deficiency in internal control identified during the audit that has not been communicated to management by other parties that is of sufficient importance to merit management's attention

We are required to communicate reportable findings from the audit procedures performed relating to the plan provisions to you, in writing.

Reportable Findings (Continued)

We have identified the following reportable finding in the previous year:

Required Minimum Distributions (previously reported, corrected in the current year)

During current and prior year audits, we noted that mandatory Required Minimum Distributions (RMDs) for several participants over 73 years of age were not distributed timely. Per review of the Fidelity website, these individuals were either listed as terminated with a bad address, incorrect social security number, were deceased, had a hold on their account or were a spousal beneficiary. This issue continued in 2024, but since Fidelity and the Plan Sponsor have been diligently seeking these lost participants for several years, the control deficiency is deemed corrected.

We recommend Plan management continue working with Fidelity to properly distribute the RMDs. Management has contracted with Fidelity to utilize the Fidelity Lost Participant service to find missing participants. Per Fidelity, these distributions will be processed when they can find the appropriate address/SSN and when the participant takes a hold off their account (hold was placed due to identity theft reasons).

Shared Responsibilities: AICPA Independence

The AICPA regularly emphasizes that auditor independence is a **joint responsibility** and is managed most effectively when management, audit committees, (or their equivalents), and audit firms work together in considering compliance with American Institute of Certified Public Accountants (AICPA) independence rules. For Boyer & Ritter LLC to fulfill its professional responsibility to maintain and monitor independence, management, the audit committee, and Boyer & Ritter LLC each play an important role.

Our Responsibilities

- AICPA rules require independence both of mind and in appearance when providing audit and other attestation services. Boyer & Ritter LLC is to ensure that the AICPA's General Requirements for performing non-attest services are adhered to and included in all letters of engagement.
- Maintain a system of quality management over compliance with independence rules and firm policies.

Your Responsibilities

- Timely inform Boyer & Ritter LLC before the effective date of transactions or other business changes, of the following:
 - New affiliates, directors, or officers.
 - New beneficial owners of the Plan Sponsor's stock which have significant influence.
 - Change in corporate structure impacting affiliates such as add-on acquisitions or exits.
- Provide necessary affiliate information such as new or updated investment structure charts, as well as financial information required to perform materiality calculations needed for making affiliate determinations.
- Understand and conclude on the permissibility, prior to the Plan and its affiliates, including the Plan Sponsor, and the officers, directors or persons in a decision-making capacity, engaging in business relationships with Boyer & Ritter LLC.
- Not entering into relationships resulting in close family members of Boyer & Ritter LLC covered persons, temporarily or permanently acting as an officer, director or person in an accounting or financial reporting oversight role at the Plan or Plan Sponsor.

Significant Written Communications between Management and Our Firm

Copies of significant written communications between our firm and the management of the Plan, including the management representation letter, have been provided to us by management.

This report is intended solely for the information and use of the Plan Administrator and management and is not intended to be, and should not be, used by anyone other than these specified parties. NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of Select Medical Corporation 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution employee benefit plan which was established by Select Medical Corporation on March 1, 1998. The Plan includes employees of Select Medical Corporation, wholly owned subsidiaries, affiliates and various joint ventures (the Corporation). The Plan was amended and restated effective September 1, 2021, to conform with current regulatory requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Eligible employees include all employees who have attained the age of 18 who have completed 1,000 hours of eligible service within one year. Participation in the Plan begins when the eligibility requirements are met. Full time employees may begin elective deferral contributions three months after their hire date in anticipation that they will reach 1,000 hours of service during a consecutive 12-month period.

Contributions: Each year, participants may elect to contribute on a pre-tax basis up to 30%, but not less than 1%, of eligible compensation, as defined in the Plan agreement (elective deferral contributions). Effective June 1, 2021, the Plan was amended to permit participants to designate a portion or all of their deferrals as Roth 401 (k) contributions includable in the participant's gross income at the time of deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. At its discretion, the Corporation may match employee elective deferral contributions equal to 25% of participant elective deferral contributions up to 6% of eligible compensation. An additional discretionary amount may be contributed at the option of the Corporation and is allocated to participants in the proportion of each participant's elective deferrals to the elective deferrals of all participants during the year. Contributions are subject to certain limitations.

Participant's Accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Corporation's contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options: Upon enrollment in the Plan, a participant may direct the investment of their account into any investment option offered by the Plan. The participants may change their investment options as often as they like. The self-directed account option (brokerage link) accounts are considered competing funds with respect to the Managed Income Portfolio II (MIP II), restricting transfers from MIP II to the brokerage link accounts by instituting a ninety (90) day equity wash requirement. This requires funds from the MIP II to be exchanged into a non-competing investment option for 90 days prior to a subsequent exchange into a brokerage link account. The Plan designated the Fidelity Retirement Money Market account as the default investment option to receive assets moving from the MIP II account to the brokerage link accounts.

Note 1. Plan Description (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Corporation's contribution portion of their accounts is based on years of continuous service. Generally, a participant is 20% vested after two years of credited service and 100% vested after three years of credited service, except as noted below pertaining to various acquisitions:

Participant Loans: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at local prevailing rates. Loan terms range from one to five years or longer for the purchase of a primary residence. Principal and interest are paid ratably through periodic payroll deductions.

Payment of Benefits: A participant shall be entitled to receive the balance held in his or her account upon retirement, reaching age 59½, upon death or disability or upon termination of employment. In addition, funds may be withdrawn in the event of a severe financial hardship as defined by the Plan. Participant benefits may be paid in a series of installments or in a lump-sum as agreed upon by the participant and the Trustee.

Forfeited Accounts: Forfeitures are available to reduce future employer contributions upon the earlier of the distribution of the terminated employee account or five years. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$158,312 and \$167,199, respectively. During 2024, forfeitures of \$1,664,333 were used to reduce employer contributions.

Note 2. Significant Accounting Policies

Basis of Accounting: The accounting records of the Plan are maintained on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances, plus any accrued interest. Delinquent loans are treated as distributions based upon the terms of the plan document surrounding defaulted loans.

Payment of Benefits: Benefit payments are recorded when paid.

Administrative Expenses: Expenses incurred for administration of the Plan are paid by the Plan through charges to participants' accounts and by the Corporation.

Subsequent Events: In preparing these financial statements, the Plan Administrator has evaluated events and transactions for potential recognition or disclosure through September 15, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Fidelity Management Trust Company (trustee of the Plan).

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification Fair Value Measurements, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy are as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2: Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments are held by Fidelity Management Trust Company. The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies: Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the plan are deemed to be actively traded.

Self-directed Brokerage Accounts: Self-directed brokerage accounts consist of investments in money market funds, registered investment companies, common stocks, preferred stocks, corporate bonds, options, etc. The fair values of these investments are generally based on closing market prices for the identical security as reported in active markets. Corporate bonds do not always trade on a daily basis so the fair values of each security is dependent upon various pricing models that incorporate benchmark yields, interest rates, credit risk, broker-dealer quotes and other valuation processes.

Collective Investment Trusts: The Plan invests in a variety of collective investment trusts offered separately by T. Rowe Price and Fidelity Trust Company.

The Plan invests in collective investment trusts through several trusts offered by T. Rowe Price Trust Company. The collective investment trusts are valued based upon the net asset value (NAV) of units of the Trusts as reported to the Plan by the trusts. Units of the trusts are published daily and used as the basis for current transactions. The units of the CIT are valued daily based on closing market prices of the underlying investments. The daily unit value is computed by dividing the total assets of the trusts, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trusts and included in the determination of unit values. While some of the collective investment trusts may have publicly quoted pricing inputs (level 1), the unit values of the accounts are not publicly quoted and are therefore classified as Level 2 investments.

The Plan invests in an investment contract through a collective investment trust (CIT), Fidelity Managed Income Portfolio II. The collective investment trust is valued based upon the net asset value (NAV) of units of the CIT as reported to the Plan by the trust. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value. The units of the CIT are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

Note 6. Related Party and Party-in-Interest Transactions

Certain Plan investments consist of shares of registered investment companies and units of a collective trust managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 7. Tax Status

The Company has adopted a Pre-Approved Profit-Sharing Plan sponsored by Fidelity Management & Research Company (FMR LLC). The Pre-Approved Profit-Sharing Plan received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Plan's qualified status. The Pre-Approved Profit-Sharing Plan opinion letter has been relied upon by this Plan. The IRS has ruled that the Pre-Approved Profit-Sharing Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
