Scope and Nature of the ERISA Section 103(a)(3)(C) Audits of the Financial Statements

We have performed audits of the financial statements of Horizon Global 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023, and for the period from January 1, 2024 to October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Horizon Global 401(k) Plan (the “Plan”) provides only general information regarding the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan and trust with a qualified cash or deferred 401(k) arrangement covering substantially all employees of Horizon Global Corporation and related employers (collectively, the “Company” or “Employer”). There is no age or service requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Effective October 31, 2024, the Plan was merged into the First Brands Group 401(k) Plan with Empower Trust Company as its trustee.

Contributions

The Plan allows participants to contribute up to the lesser of seventy-five percent of their pre-tax annual compensation, as defined in the Plan, or the maximum allowed by the Internal Revenue Code (“IRC”). In addition, the Plan contains a catch-up option for participants who have attained age 50 before the end of the year permitting them to make additional elective deferral contributions up to amounts limited by the IRS. New employees are automatically enrolled in the Plan, unless they elect otherwise, at an automatic enrollment rate of 6%. Participants enrolled in the Plan will be subject to an increased deferral rate of 1% automatically taking place every year up to a maximum deferral rate of 10%. Participants may also make rollover contributions from other qualified plans. The Company may make a discretionary matching contribution. The Plan suspended discretionary matching contributions effective October 23, 2022. The Company may also make discretionary profit-sharing contributions which are allocated pro rata amongst participants. No such contributions were made during 2024. Participants direct the allocation of their contributions, as well as the Company’s contributions, among the investment options available under the Plan. The Plan also allows participants to designate a portion or all of their deferral contributions as Roth or after-tax contributions made to the Plan on an after-tax basis.

Participant Accounts

Each participant’s account is increased or decreased, as appropriate, with (a) the participant’s contribution, (b) the Company’s contribution and (c) investment earnings and losses. In addition, each participant’s account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are fully vested immediately in their contributions and discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contribution is based on years of continuous service. A participant is 100% vested after three years of credited service for discretionary profit-sharing contributions. A participant is 100% vested upon reaching normal retirement age, early retirement age with five years of credited service, death, or disability while employed by the Company. During 2023, the Company had reductions in workforce that the Company has concluded result in a partial termination of the Plan. Accordingly, the terminated participants affected by the reductions in workforce became 100% vested in their account balance.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants can defer their distribution payment; however, a participant's distribution cannot be postponed if their vested account balance is \$5,000 or less as the Fidelity Management Trust Company ("Fidelity" or "Trustee") has been directed to distribute vested amounts ranging from \$5,000 to \$1,000 to an Individual Retirement Account and vested amounts less than \$1,000 be distributed as lump-sum distributions. Participants may also withdraw amounts from their accounts under certain hardship conditions as defined in the Plan Document.

Forfeited Accounts

Forfeited non-vested accounts totaled \$0 and \$51,017 at October 31, 2024 and December 31, 2023 respectively. These accounts will be used to reduce future Company contributions or pay Plan expenses. As of October 31, 2024, forfeitures used to pay plan expenses or fund employer contributions totaled \$22,702.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or fifty percent of their vested account balance under the Plan. The maximum number of notes available to any participant is one. Loan repayment periods are not to exceed five years, unless the loan is for the purchase of a participant's primary residence. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The participant repays the loan and all related interest through payroll deductions.

Notes are in arrears and delinquent when any payment is missed. If the note is not paid up to date by the end of the calendar quarter, after the calendar quarter in which a payment is first delinquent, the note will be in default. In that event, the entire outstanding note balance, consisting of the missed payments, remaining principal, and all accrued but unpaid interest, will be reported to the Internal Revenue Service ("IRS") as taxable income. If a note has not been fully repaid by the end of its term, the outstanding balance will be treated as a deemed distribution and will be reported to the IRS as taxable income.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are participant-directed accounts that are held by the Trustee. The Plan's investments are stated at fair value at October 31, 2024 and December 31, 2023.

Investment income consists of dividends and interest income. The net appreciation of investments consists of realized gains or losses and unrealized appreciation on those investments. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported based on historical cost.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Income Taxes

The Income Taxes Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be

sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and December 31, 2023 and for the period ended October 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- *Common collective trust fund*: The fair value of participation units held in the common collective trust fund is based on the net asset value per unit as reported by the fund manager. Transactions (purchases and sales) may occur daily. There are no redemption restrictions or unfunded commitments on this investment.
- *Mutual funds*: Valued at the closing price reported on the active markets in which the individual securities are traded.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RISK AND UNCERTAINTIES

The Plan provides for various investment options. These investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 – TAX STATUS

The Plan is a Fidelity pre-approved defined contribution plan. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the Plan document satisfies the provisions of Section 401 of the IRC. Although the Plan has been amended since the opinion letter, plan management believes that the Plan is designed and is currently being operated in compliance, in all material respects, with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 8 – PARTY-IN-INTEREST AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee and the Plan incurs expenses for administrative services performed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions.
