Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Berkeley Bowl Produce, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 

The following description of the Berkeley Bowl Produce, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan consists of a Defined Contribution Profit Sharing Plan and a salary deferral plan [401(k)] covering employees of Berkeley Bowl Produce, Inc. (the Company).

Berkeley Bowl Produce, Inc. is the Plan Sponsor and Administrator of the Plan, with Gen Yasuda (Officer and Shareholder of the Company) as Trustee and Associated Pension Consultants as the Third-Party Administrator. Smart Investor is the current Investment Advisor for the Plan. Record-keeper of the Plan is The Retirement Plan Company and the Custodian is Matrix Trust Company.

The Plan allows participants to designate a portion or all of their salary deferral contributions as a Roth deferral contribution.

Plan eligibility is as follows:

Profit Sharing Plan – employees who have completed one year of service, worked at least one thousand hours during the year and are employed on the last day of the Plan year.

401(k) Plan – employees who have completed three months of service.

Non-resident aliens are not permitted to participate in either portion of the Plan.

The Plan also remains subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Profit Sharing Plan

Employees are eligible to participate after completing one year of employment and more than 1,000 hours of service. After an employee has satisfied the eligibility requirements, entry to the Plan occurs on either January 1st, April 1st, July 1st or October 1st of each year. The Company makes discretionary contributions to the Plan at the rate of 6.0% and 6.5% of Eligible Compensation based on the Years of Service. Eligible Compensation excludes overtime pay. All Company contributions are participant directed. Contributions totaled \$1,537,888 and \$1,426,017 for the years ended December 31, 2024 and 2023, respectively.

401(k) Plan

Employees may elect to participate in the Plan upon completion of three months of service. Contributions of up to \$23,000 annually, plus \$7,500 catchup contributions for participants over age 50, are made to the Plan by participants through payroll deductions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants contributed \$862,424 and \$784,575 for the years ended December 31, 2024 and 2023, respectively.

In addition, the Plan allows eligible employees to make qualified transfers from other plans (employee rollover contributions).

Participant Accounts

The Company's contribution is allocated to employee groups as provided by the Adoption Agreement. Such amounts are then allocated to individual accounts within the group based on the ratio each individual's compensation bears to the group's total participant compensation. Plan earnings and losses are allocated based on the mutual fund units owned by the participant.

Vesting

Participants in the Profit Sharing and 401(k) Plans are immediately vested in their accounts.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$20,000 or 50% of their vested account balance. A participant can only have one loan currently outstanding from the Plan. The loans are secured by the balance in the participants' accounts and bear interest at a rate of the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Benefits are paid to participants generally upon termination of employment or retirement. Such distributions are paid either in lump sums or installment payments made over a period of years selected by the participants. In-service distributions may be made from a participant's elective deferrals upon disability or after the age of 59-1/2, and from nonelective employer's contributions after the later of age 65 or five years after the first day of the Plan year in which the participant commenced participation. In-service distributions may not be made from a participant's Roth contributions.

A participant's account may be distributed to his or her beneficiary in lump sum or in installment payments upon the participant's death.

The plan automatically rolls over terminated employee investment account balances to an IRA if the account does not exceed \$5,000 (excluding rollover contribution account balance). The automatic rollover will only occur if the terminated participant does not elect to receive a distribution or rollover the distribution to another retirement account.

2. Summary of Significant Accounting Policies

Method of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. Employer contributions and interest and other investment income are recorded when earned. Benefits and administrative expenses are recognized when the obligation is incurred. Notes receivable from participants are measured at their unpaid principal balance.

2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation (Depreciation) in Fair Value of Investments

Realized and unrealized appreciation (depreciation) in the fair value of investments is based on the difference between the fair value of assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan's investment options include funds that invest in securities of foreign companies which involve special risks and considerations not typically associated with investing in U.S. Companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

Operating Expenses

The Plan Sponsor (employer) absorbs a certain amount of the Plan's administrative costs, including accounting fees.

3. Fair Value Measurements

The Plan has adopted the authoritative accounting standard which defines fair value, outlines a framework for measuring fair value, and details the required disclosures under GAAP regarding fair value measurements.

The standard establishes a three-level value hierarchy for disclosures of fair-value measurements. The valuation hierarchy is based on the transparency of the inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

Level 1 – Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market for the asset or liability is a market in which the transaction for the asset or liability occurs with sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 – Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities in markets that are active; quoted market prices in markets that are not active; or model-derived valuations or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

Level 3 – Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable (e.g. a reporting entity's own data).

The following is a description of the valuation methodology used for a fair value measurement of investments:

Mutual funds – Mutual funds are stated at fair value based upon the quoted net asset value of shares held by the Plan on the last business day of the year.

The method described above may generate a fair value calculation that may not be indicative of net realizable value of future fair values. While the Plan believes the valuation methodology used is appropriate, the use of different methodologies or assumptions in calculating fair value could result in different amounts.

4. Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, note 3, and the Supplemental Schedule H, line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024; and the related investment activity reflected in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

The Plan's investments appreciated by \$2,189,441 and \$3,263,009 in 2024 and 2023, respectively.

5. Party-In-Interest Transactions

Fees paid by the Plan to the record-keeper for administrative services amounted to \$147,467 and \$129,986 for the years ended December 31, 2024 and 2023, respectively.

6. Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Volume Submitter Profit Sharing Plan (the prototype plan upon which the Plan is based), was designed in accordance with the applicable requirements of the Internal Revenue Code (IRC); therefore, is not subject to tax under present income tax law. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. Income Tax Status (continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by Federal and state tax authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants continue to be fully vested in their account balances and the Trust shall continue until all assets have been completely distributed to the participants or their beneficiaries in accordance with Plan provisions.

8. Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.
