#### NOTE 1 - DESCRIPTION OF PLAN

The following description of the **Columbus Center for Human Services, Inc. Retirement Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - On July 1, 1988, Columbus Center for Human Services, Inc. (the "Organization") adopted a Section 401(k) profit sharing plan. The Plan allows participation for all employees of the Organization who have completed 1,000 hours of service within one year from their hire date and have attained age 21. Employees covered by a collective bargaining agreement or who are non-resident aliens are not eligible to participate in the Plan. In accordance with the SECURE Act, effective January 1, 2024, long-term part-term employees who worked at least 500 hours in each of the prior three years are eligible to participate in the Plan. Upon satisfaction of the eligibility requirements, employees are automatically enrolled in the Plan on the earlier of the first day of the Plan year or the first day of the seventh month of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - The Plan provides for employee salary deferrals within statutory limits, as defined in the Plan, each year as an elective deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, excluding after-tax contributions. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2010, the Plan was amended to allow Roth 401(k) contributions.

Employer matching contributions are discretionary and participants become eligible for these contributions at the same time the participation eligibility requirements are met. The Organization may make a matching contribution in an amount equal to either a percentage of compensation or a dollar amount as it directly relates to elective deferrals made by eligible participants during the Plan year. Such amounts are to be determined by the Organization within the time period prescribed by the law. Employer matching contributions are not provided to long-term part-time employees who worked less than 1,000 hours but were eligible to participate in the Plan under the SECURE Act.

The Organization may also make a discretionary non-elective contribution that would be allocated to each eligible participant's account in proportion to their compensation as a percentage of the compensation of all participants. Effective January 1, 2019, the Plan was amended to change the allocation so that the rate shall be specified by an appropriate written action of the Organization on or before the due date of the Organization's tax return for the year in which the contribution is allocated. Discretionary non-elective contributions are not provided to long-term part-time employees who worked less than 1,000 hours but were eligible to participate in the Plan under the SECURE Act.

For the years 2024 and 2023, the Organization did not make any discretionary employer matching or discretionary non-elective contributions to the Plan. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the Internal Revenue Service. The Organization contributed \$2,695 and \$65 as qualified non-elective contributions during 2024 and 2023.

**Participant Accounts** - Matrix Trust Company is Custodian of Plan investments. Each participant's account is credited with the participant's contributions, Organization contributions, net earnings or losses, forfeitures, distributions, and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs both separately, and distinctly, into which investment the participant contribution and discretionary employer contributions are to be invested.

### NOTE 1 - DESCRIPTION OF PLAN - CONTINUED

**Vesting** - Participants are immediately vested in their voluntary contributions, rollovers, qualified non-elective contributions, and corresponding earnings. The following schedule will be used to determine vesting in the discretionary employer matching and discretionary non-elective contributions and corresponding earnings:

**Notes Receivable from Participants** - Participants may borrow from the Plan in any amount between \$1,000 and \$50,000, but not more than 50% of their vested account balance. Loans bear interest at an agreed-upon percentage based on prevailing market rates, subject to applicable usury limits. Loan terms are for a period not exceeding five years. A longer term may be approved by the Plan if proceeds are to be used for the purchase of a primary residence. Loans are secured by the balance in the participants' accounts. Principal and interest are paid ratably through payroll deductions.

**Benefits Paid** - Upon termination of service by reason of retirement, death, permanent disability, or otherwise, participants, or designated beneficiaries, may elect to receive their vested balance either in a lump-sum amount, or payments over a period of time in cash installments, or in a form agreeable to the Plan Administrator. If the participant's account balance is \$1,000 or less, the Plan Administrator may elect to automatically distribute the balance to the participant in a single-sum payment. If the balance does not exceed \$5,000, and the participant does not elect to have the distribution paid directly to them or an eligible plan, the Plan Administrator may make a lump sum distribution to a direct rollover individual retirement account. In addition, participants may receive distributions of the employee deferral and vested employer contribution amounts for qualified financial hardships.

**Forfeitures** - Forfeited balances of terminated participants' non-vested accounts are first used to restore participants' forfeitures, with any remaining forfeitures being used to pay Plan expenses and reduce employer discretionary matching or discretionary non-elective contributions. There was \$591 in forfeitures used during 2024 to restore participant accounts and no forfeitures used during 2023. The Plan had no unallocated forfeitures at December 31, 2024. The Plan had unallocated forfeitures of \$591 in 2023.

**Investment Options** - Upon enrollment in the Plan, a participant may currently direct contributions in investment options in increments of one percent. Participants may change their investment options at any time via phone or the internet.

#### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Financial Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect the reported amounts of net assets, and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for loans receivable considered uncollectible has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced. A benefit payment is only recorded upon termination of service by reason of retirement, death, permanent disability, or otherwise.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Organization pays certain administrative expenses of the Plan, and the Plan participants will bear the responsibility of the remaining expenses, to the extent not paid through forfeitures. Investment related expenses are included in net appreciation in fair value of investments. Fees for specific transactions, such as loan withdrawals and distributions, are paid by the individual participants.

**Subsequent Events** - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued.

#### NOTE 3 - CERTIFIED INVESTMENTS

Certain information related to investments and cash disclosed in the accompanying financial statements and supplemental schedule, including investments and cash held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the years 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the Custodian of the Plan).

#### NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards provide a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the accounting standards are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs, and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Investments in registered investment companies:* Valued at the daily closing price reported by the fund as registered with the Securities and Exchange Commission. The funds held by the Plan are deemed to be actively traded and are required to publish their net asset value (NAV) and to transact at that price.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 5 - RELATED PARTY TRANSACTIONS

Certain Plan assets are held in trust with Matrix Trust Company. Thus, Matrix Trust Company, as Custodian defined by the Plan, qualifies as a party-in-interest. Fees paid by the Plan for Custodian services for the years 2024 and 2023 totaled \$2,607 and \$2,148.

Ironshore, Inc. provides certain investment advisory and administration services to the Plan and qualifies as a party-in-interest. Fees paid by the Plan for these services for the years 2024 and 2023 totaled \$5,000.

Sound Financial Solutions, Inc. provides certain investment advisory services to the Plan and qualifies as a party-in-interest. Fees paid by the Plan for these services for the year 2024 and 2023 totaled \$5,000.

TWG Benefits, Inc. provides certain recordkeeping services to the Plan and qualifies as a party-in-interest. Fees paid by the Plan for these services for the years 2024 and 2023 totaled \$10,690 and \$8,185.

Dynamic Pension Services, Inc. provides certain investment advisory and administration services to the Plan and qualifies as a party-in-interest. Fees paid by the Plan for these services for the years 2024 and 2023 totaled \$10,368 and \$3,687.

The Organization provides certain accounting, recordkeeping, and administrative services to the Plan for which it receives no compensation.

#### **NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participants will become 100% vested in the employer portion of contributions.

#### **NOTE 7 - TAX STATUS**

The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **NOTE 9 - BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS**

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

#### **NOTE 10 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

For the years 2024 and 2023, there were no differences between the financial statements and the Form 5500.

#### **NOTE 11 - NON-EXEMPT TRANSACTIONS**

During 2024, the Plan sponsor failed to timely remit participant contributions in the amount of \$67. As a result of this failure, a non-exempt transaction was reported. The Plan sponsor was liable for lost earnings and excise tax, which will be paid during 2025.

The Plan sponsor was timely on all remittances of participant contributions during 2023.

#### **NOTE 12 - SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan was restated. The Organization elected to make Safe Harbor matching contributions. The Organization elected to contribute 100% of the first 3% of elective deferrals, and 50% of the next 2% of elective deferrals that a participant contributes to the Plan.
