### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Medical Knowledge Group 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following brief description of the Medical Knowledge Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary Plan description for a complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering all employees of Medical Knowledge Group, LLC (the Company or Employer) and any participating affiliates who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), a member of the Principal Financial Group, is the recordkeeper and trustee of the Plan.

#### *Contributions*

Each year, participants may contribute up to 90% of eligible compensation, as defined by the Plan, through a salary reduction. Contributions may be made to the Plan on a pre-tax and/or after-tax Roth basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain annual limitations, as imposed by the Internal Revenue Code (IRC).

The Company matches 50% of the participant contributions, up to 6% of Plan compensation, as defined by the Plan document. The Company's matching contribution was \$1,697,819 for the year ended December 31, 2024. Each year, the Company may decide to make a discretionary qualified nonelective contribution. For the year ended December 31, 2024, the Company did not elect to make a nonelective contribution.

### ***Participant Accounts***

The Plan maintains individual accounts for each Plan participant. Each participant's account is credited with the participant's contributions; Company matching contributions; nonelective contributions, if any; an allocation of the Plan's investment earnings or losses; and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Investment Options***

Participants direct the investment of participant and Company contributions in any of the investment options offered by the Plan.

### ***Vesting***

Participants are immediately vested in their salary deferral, rollover, and qualified nonelective contributions, plus actual earnings thereon. Vesting in the Company's matching portion of their accounts, plus actual earnings thereon, is as follows:

1 but less than 2	25

### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, or 50%, of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with current rates charged for similar loans made by local commercial banks, as determined by the Plan administrator. Interest rates on outstanding loans ranged from 3.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

Participants are eligible to receive distributions from their accounts at the normal retirement age (age 65), disability, death, or termination of employment. Participants receive the value of their vested account balance in the form of a single-sum payment. Additionally, participants are entitled to apply for hardship withdrawals and, after attaining age 59½, receive in-service distributions.

### ***Forfeitures***

If a participant leaves employment before becoming fully vested, any non-vested Company matching contributions and related investment earnings thereon are forfeited. These forfeitures are used to reduce any Company matching contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$109,053 and \$111,366, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$172,993 were used to reduce the Company's matching contributions, and \$26,262 were used to pay Plan expenses.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of the Plan's financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by Principal. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Matching contributions and nonelective contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

### **4. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

*Common Collective Trusts (CCTs)* - The CCTs are stated at fair value using the NAV practical expedient. This practical expedient is not used when it is determined to be probable that the fund will sell for an amount different than the reported NAV. The NAV of the CCTs is determined using the market price of the underlying securities and the contract value of investment contracts held by the CCTs, as determined by the trustee of the CCTs. There are no restrictions on the redemption of these investments and no unfunded commitments. The CCTs are direct-filing entities.

*Pooled Separate Account* - The asset is valued at NAV as a practical expedient based on the market value of the underlying investments. This practical expedient is not used when it is determined to be probable that the fund will sell for an amount different than the reported NAV. The NAV is not a publicly quoted price in an active market. The pooled separate account invests in mutual funds. The investment may be redeemed daily. There are no unfunded commitments, and there are no other restrictions or penalties. The pooled separate account is a direct filing entity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal. Principal received an opinion letter from the Internal Revenue Service, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 6. Related Party and Party-in-Interest Transactions

Certain investments are managed by Principal Global Investors Trust Company and Principal Life Insurance Company, affiliates of Principal Trust Company, the trustee of the Plan. Notes receivable from participants also qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions which are exempt from the prohibited transaction rules under ERISA.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.
