### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Key Food Stores Co-Operative, Inc. Employees Savings Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTE 1 PLAN DESCRIPTION**

The Key Food Stores Co-Operative, Inc. Employees Savings Plan (Plan) is administered by Key Food Stores Co-Operative, Inc. (Company or Plan Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Plan Document.

**General**

The Plan is a voluntary, participant-directed, defined-contribution savings plan covering eligible employees of the Company. The Plan is subject to, and complies with, the requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees, excluding collective bargaining employees, residents of Puerto Rico, and interns, are eligible to receive employer-based contributions after completing six months of service. Employees are eligible to make salary deferrals in the Plan after completion of two months of service. An employee is automatically enrolled in the Plan after meeting the eligibility requirements unless the employee elects to opt out of the Plan. Participants are eligible for matching, nonelective and safe harbor non elective contributions after completion of six months of service.

**Contributions**

Participants can make voluntary, pretax contributions and Roth 401(k) contributions to the Plan up to 100% of eligible compensation, as defined by the Plan. The Plan accepts rollover contributions from other qualified retirement plans, except after-tax contributions in accordance with ERISA. Contributions are subject to certain limitations as stipulated by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with, and subject to, IRC statutory limits. The Plan will automatically increase a participant's elective deferral percentage by 1% per year up to a maximum of 6% of compensation on the first day of the Plan year.

The Plan allows the Company to make nonelective contributions to the Plan. Nonelective contributions will be allocated to participants pro rata, as a uniform percentage of participant compensation. For the 2024 and 2023 Plan years, the Company made nonelective contributions of 2% of a participant's compensation. The Plan also allows the Company to make safe harbor contributions and additional matching contributions. The safe harbor nonelective contribution equals 3% of a participant's compensation. The Company may make a discretionary, additional matching contribution. If the Company makes a discretionary matching contribution, the matching contribution will apply to all elective deferrals. For the 2024 and 2023 Plan years, the Company made additional matching contributions of 25% of elective deferrals.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's contributions; (b) Plan earnings, gains, or losses, and (c) charged with an allocation of administrative expenses. Allocations are based on a participant's compensation or account balances, as defined in the Plan Document.

**Vesting**

Participants are immediately vested in their salary deferrals, rollovers, and safe harbor contributions. Vesting in the employer's matching contributions and nonelective contributions is based on years of service. A participant is 0% vested until they complete three years of service. A participant is 100% vested in the employer's matching contributions and nonelective contributions after three years of service.

**Investment Options**

Upon enrollment in the Plan, participants may direct their employee and employer contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options at any time.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of their vested balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months). Participants may have one loan outstanding at any given time. Loans bear a rate of interest of prime plus 1%. The interest rate will remain fixed throughout the duration of the loan. Terms depend on the type of note; a general note must be repaid within five years, while notes used to acquire a primary residence shall be repaid over a 10-year period.

**Payment of Benefits**

On termination of service, a participant may elect to receive: a cash, lump-sum amount equal to the value of their vested account; a rollover directly to the participant's account of choice; installments; or a life annuity. If a participant's vested balance is greater than \$5,000, receipt of distribution can be postponed up until the mandatory distribution date, which is defined as the later of April 1<sup>st</sup> following the calendar year of attaining the age of 72 or age at retirement. If participants are still employed by the age of 72, the mandatory distribution date generally is April 1<sup>st</sup> following the termination date of employment. If the vested balance of a terminated participant is \$5,000 or less, the participant will receive a mandatory distribution without consent.

**In-Service Withdrawals**

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account.

**Retirement**

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

**Forfeitures**

On or before each anniversary date, any forfeitures may be made available to reinstate previously forfeited account balances of participants, if any, and any remaining forfeitures may be used to pay administrative expenses. The remaining forfeitures, if any, will be used to offset employer nonelective or matching contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was \$23,726 and \$69,877, respectively. The Plan used \$91,417 and \$70,197 in the years ended December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with the accounting principles generally accepted in the United States of America.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee of the Plan. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Mutual Fund Fees**

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and, thus, not separately identifiable as an expense.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses and Participant Transaction Fees**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Subsequent Events**

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024, through October 8, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company for the years ended December 31, 2024 and 2023.

**NOTE 4 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

***Mutual Funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

**Common Collective Trusts:** Valued at the net asset value (NAV) of units of a common collective trust. NAV is a readily determinable fair value and is the basis for current transactions. (Level 2 inputs)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held by the Custodian, Empower Trust Company. Any transactions involving Empower Trust Company, the Plan Sponsor, or the third-party administrator are considered party-in-interest transactions. Notes receivable from Plan participants qualify as party-in-interest transactions.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all employer contributions, as of the termination date. Any unallocated assets of the Plan shall be allocated to participants' accounts and distributed in such a manner as the Plan Document describes.

**NOTE 7 TAX STATUS**

The IRS has determined and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
