Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan for Employees of Achieva (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

1. Description of Plan

The following brief description of the 403(b) Thrift Plan for Employees of Achieva (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Achieva, or the Achieva Family of Organizations, is a group of non-profit corporations formed for the purpose of furthering individuals with intellectual and/or developmental disabilities in the western Pennsylvania region. The Plan was established for the purpose of providing retirement benefits to the employees of Achieva. The accompanying financial statements include only the activity and financial position of the Plan and are not intended to reflect Achieva as a whole.

General

The Plan is a defined-contribution, 403(b) plan covering all eligible employees of the Achieva Family of Organizations. The Plan was established July 1, 2006. A person becomes eligible to make salary reduction contributions to the Plan upon becoming employed by Achieva and to participate in the employer base contributions upon completing one year of service and having at least 975 hours of service in that year.

Contributions

Contributions to the Plan include employee salary reduction contributions and employer base contributions. Participants may contribute a pre-tax or after-tax, portion of their compensation up to a maximum allowable by the Plan document and in accordance with other limiting provisions of the Internal Revenue Code and other applicable legal limits. Employer base contributions range between 2% and 5% of each participant's compensation, based upon years of service. For participants who were in Achieva's prior 401(a) Plan, the employer base contributions range between 2% and 9% of each participant's compensation, based upon years of service. Rollover contributions are permitted by the Plan.

Investment Options

Mutual of America Life Insurance Company (MOA) pension and retirement savings products allow for contributions to be allocated among the insurance company's general account and a wide array of separate account investments funds (pooled separate account). The

investment funds purchase shares of underlying mutual funds or portfolios. These underlying funds or portfolios sell their shares to separate accounts of insurance companies and are not publicly available.

Participant Accounts

Each participant's account is credited with (a) the participant's contributions, (b) the Organization's contributions, and (c) any earnings or losses thereon and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant has the exclusive authority to direct the investment of contributions made to his or her account. Transfers between investment accounts are permitted on any normal business day of the custodian.

Vesting

Participants are vested immediately in their employee contributions plus actual earnings thereon. Participants who participated in Achieva's prior 401(a) Plan are 100% vested in their employer contribution accounts. Participants who entered the Plan on or after July 1, 2006 become fully vested in employer contributions according to the following vesting schedule:

Benefits Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump sum amount or in annual installments over a fixed period. For termination of service due to

other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Participants with accumulated balances of less than \$1,000 at their date of service termination shall receive a lump sum distribution of their vested balance.

Hardship withdrawals may be made for purposes outlined in the Plan document.

Forfeitures

Forfeitures arising in accordance with the provisions of the Plan are used by Achieva to reduce future employer contributions or to pay Plan expenses. As of December 31, 2024 and 2023, there were no unallocated forfeited principal amounts. Forfeitures used to reduce employer contributions were \$27,277 and \$37,500 for 2024 and 2023, respectively.

Plan Loans

Loans issued to participants of the Plan are collateralized loans. There are no withdrawals of loan amounts from a participant's account nor are principal and interest payments applied towards a participant's account. Rather, the participant is borrowing from MOA and using their account balance as collateral. For a loan to be issued, the loan amount, plus a 20% reserve, must be placed into the general account. This amount is then considered to be "in reserve" and cannot be withdrawn or transferred. As loan payments are applied, the "reserved" amount is reduced by the amount of the loan payment and can be withdrawn and/or transferred. These loans are not considered to be assets of the Plan. Loans are to be repaid over a period not to exceed five years, unless used to acquire a principal residence, and bore a variable rate of interest range of 4.60% to 5.85% and 4.60% as of December 31, 2024 and 2023, respectively. Additional conditions apply as specified in the Plan document. The amount of outstanding Plan loans at December 31, 2024 and 2023 was \$441,944 and \$450,772, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. For investments in pooled separate accounts, MOA calculates a daily unit value, based on the underlying market value of investments. The value of a participant's fund balance is equal to the daily unit value multiplied by the number of units accumulated. Management determines the Plan's valuation policies utilizing information provided by MOA. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid by the Plan. There were no benefits allocated to the accounts of persons who had withdrawn from the Plan but were not paid as of December 31, 2024 and 2023, respectively.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by Achieva and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Certain types of activities are charged to participant accounts, including electing to receive hard copy statements. These monthly charges are reported as administrative expenses for the years ended December 31, 2024 and 2023, respectively.

Subsequent Events

Subsequent events have been evaluated through the Independent Auditor's Report date, which is the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Fair values for Level 1 investments are determined by reference to unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access. Fair values for Level 2 investments are determined by reference to quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, inputs other than quoted prices that are observable for the asset, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 investments have significant unobservable inputs, as they trade infrequently or not at all.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of

unobservable inputs. The Plan held no assets measured under the fair value hierarchy for the years ended December 31, 2024 or 2023.

Investments Measured Using the Net Asset Value per Share Practical Expedient

Interest in the pooled separate account is valued at the net asset value of shares held by the Plan at year-end. Separate account funds invest in mutual funds, including funds managed by Mutual of America Capital Management Corporation, a wholly owned subsidiary of MOA, and other funds managed by outside investment advisors. Investments held in the separate account are stated at fair value and are not available to satisfy the liabilities of the general account. Interest in the pooled separate account is valued at net asset per share as determined by investment managers under the so-called “practical expedient.” The practical expedient allows net asset value per share to represent fair value for reporting purposes when the criteria for using this method are met. The pooled separate account consists of mutual funds actively traded that are easily redeemed at the request of participants. The investment strategies of the underlying investment funds of the separate account include seeking capital appreciation and current income.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of the future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has a deposit contract with MOA. Under the terms of the contract, the majority of the Plan assets are held in MOA's General Account, which is made up mainly of Fixed Maturity Securities. The General Account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by MOA. MOA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract, which is fully benefit-responsive, is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$7,412,680 and \$7,886,533, respectively.

The effective annual yield and the crediting interest rate for the years ended December 31, 2024 and 2023 was 3.00% for accounts activated before May 1, 2008. For contracts activated after May 1, 2008, the effective annual yield and the crediting interest rate was 2.85% and 1.60%, respectively, for the years ended December 31, 2024 and 2023. The crediting interest rate is reset by MOA on an annual basis in January. Changes in future

interest crediting rates will not affect the amount reported on the statements of net assets available for benefits.

MOA is responsible for maintaining the balances due to each of the eligible participants in the Plan. The net assets available for benefits include assets available to current eligible employees as well as terminated employees who have not yet been paid their benefit by the Plan. MOA also is responsible for the proper payouts of benefits to eligible terminated employees per the terms of the Plan documents.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such event which would limit the Plan's ability to transact at contract value with participants is probable.

5. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Code. The plan administrator believes that the terms of the Plan have been prepared to conform with the written plan requirements of Regulation 1.403(b)-3 of the Code and is currently being operated in conformity with the applicable sections of the Code, and therefore, believe the Plan is qualified. The Plan is required to operate in conformity with the Code to maintain tax-exempt status for plan participants under Section 403(b). The Plan annually files a Form 5500.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to

routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress for the Plan.

6. Plan Termination

Although it has not expressed any intent to do so, Achieva has reserved the right to terminate the Plan or reduce or cease contributions at the discretion of the Board of Directors, or to amend the Plan at any time and in any respect, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balance.

7. Information Certified by the Plan's Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) of fair value of investments and dividends and interest for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by MOA, the custodian of the Plan.

8. Related Party and Party-in-Interest Transactions

Certain Plan investments in the pooled separate account and investments in the investment contract are managed by MOA. MOA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan amounted to \$27,250 and \$5,770 for the years ended December 31, 2024 and 2023, respectively.

During 2023, there were several instances in which employee deferral amounts withheld by the Achieva were not remitted to the plan timely. The amount of delinquent employee contributions incurred for the plan year ended December 31, 2023 was \$26,904. The 2023 late remittances occurred due to staff turnover. All delinquent contributions were corrected

as of December 31, 2024. There were no delinquent contributions during the year ended December 31, 2024.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


