***Scope and Nature of the ERISA Section 103(a)(3)(c) Audit***

We have performed audits of the financial statements of Haworth 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Haworth 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

### **Note A – Description of Plan**

The following description of the Haworth 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit sharing and 401(k) plan covering substantially all employees of Haworth International, Ltd., the Plan's sponsor, and its eligible subsidiaries (Company). Eligible employees can participate in the Plan upon completing one hour of service. Participants that make elective contributions are eligible to receive discretionary matching contributions from the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Participants may elect to make contributions to the Plan through payroll deductions of 1% - 75% of each participant's compensation, as defined, subject to statutory limitations. All newly hired eligible employees are automatically enrolled in the Plan after 30 days of employment with an automatic deferral rate of 6% unless they elect otherwise (default enrollment). Effective January 1, 2017, the Company began increasing certain employee payroll deferrals by 1% each January 1 as follows: Eligible employees whose payroll deduction is zero are automatically enrolled at 1%, while payroll deductions for participants employed longer than six months whose payroll deduction rate is at least 1% but less than 6% will be automatically increased by 1%, unless the employee elects otherwise (auto increase). The Plan also allows participants to opt out of the default enrollment and the auto increase, and also transfer funds from other qualified plans into the Plan. Effective August 1, 2023, the Plan was amended to add a qualified Roth contribution program.

The Company makes a contribution of 2% of total compensation for services and a 50% employer match of the participant's contribution up to the first 4% of the participant's eligible wages for those employees who are eligible to participate in the Plan and are excluded from participation and benefit accruals in the Haworth Pension Plan after December 31, 2009.

In addition, the Company makes a discretionary matching contribution. This matching contribution amount is determined annually, and was 50% of the participant's contributions up to 6% of the participant's eligible wages for 2024 and 2023 for those employed on the last day of the plan year.

#### **Plan Operations**

The Company has appointed Bank of America, N.A. (Trustee) to serve as Trustee and a fiduciary committee of employees of the Company to act as plan administrator. The Trustee is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to participants. The plan administrator interprets and communicates the provisions of the Plan and ensures that all government and participant reporting requirements are fulfilled. The Plan's fiduciary committee is responsible for oversight, determines the appropriateness of the Plan's investment strategy, and monitors investment performance.

### **Note A – Description of Plan (Continued)**

#### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the amount contributed to the participant's account plus or minus any allocation of income, expenses, gains, or losses. Allocations to participant accounts are based on compensation or account balances, as specified by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Plan allows a participant to self-direct investment transactions associated with separate investment fund options made available by the employer for this purpose. In addition, participants may choose to invest their accounts in self-directed brokerage accounts, subject to certain restrictions.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution accounts is based on years of continuous service. Participants' vesting percentage increases 20% for each year of service. After five years, participants are fully vested.

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

#### **Loans to Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant's loan cannot exceed the lesser of \$50,000, reduced by the excess of the highest outstanding balance during the previous 12 months over the outstanding loan balance on the day before the new loan was issued, or one half of the participant's nonforfeitable interest in the Plan. The loan is secured by the participant's vested account balance and bears a reasonable rate of interest. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial non-periodic payments and installments for required minimum distributions. In-service withdrawals are permitted in cases of hardship, upon attaining age 59½, or from a participant's transfer, rollover, or matching account (subject to certain requirements).

#### **Costs and Expenses**

Certain transaction fees and other administrative expenses are paid by the Plan and are based on reasonable and customary rates. Certain other costs and expenses incurred in connection with the operation of the Plan are borne by the Company.

### ***Note A – Description of Plan (Continued)***

#### **Forfeited Accounts**

Forfeited balances of terminated participants' nonvested accounts are used to reduce employer matching contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was \$51,391 and \$40,674, respectively. Forfeitures of \$955,577 and \$756,742 were used to reduce employer matching contributions during the years ended December 31, 2024 and 2023, respectively.

### ***Note B – Summary of Accounting Policies***

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported in the Plan's financial statements at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in mutual funds, self-directed brokerage accounts, and common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participant's account and are included in administrative expense when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document, and therefore an allowance for credit losses is not deemed necessary as of December 31, 2024 and 2023.

### **Note B – Summary of Accounting Policies (Continued)**

#### **Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.

### **Note C – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets,
- quoted prices for identical or similar assets and liabilities in markets that are not active,
- other inputs that are observable or can be corroborated by observable market data,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### Note C – Fair Value Measurements (Continued)

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common/collective trust funds:* Valued at net asset value (NAV) based on the closing price for underlying securities, reported on the active market on which underlying securities are traded, and based on quoted prices of similar assets. The NAV of each of the trust accounts is reported by the fund managers as of the financial statement date based on recent transaction prices and represents the price at which the Plan would be able to initiate a transaction. The common/collective trust funds held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement and have no unfunded commitments.

*Mutual funds:* Valued based on quoted net asset values of the shares held by the Plan on the last business day of the plan year.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

### ***Note D – Risks and Uncertainties***

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

### ***Note E – Information Certified by Trustee***

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held, notes receivable from participants, accrued income, and amounts due to broker at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, fee rate income, and interest income from notes receivable from participants for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Trustee.

### ***Note F – Party-In-Interest Transactions***

Certain plan investments are shares of mutual funds and common/collective trust funds managed by Bank of America, N.A. and its affiliates. Bank of America, N.A. is the Trustee, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions.

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$265,224 and \$242,335 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. Those party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### ***Note G – Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their accounts.

### ***Note H – Tax Status***

The Plan obtained a favorable determination letter September 6, 2023, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.
