## REPORT OF INDEPENDENT PUBLIC ACCOUNTANTS

To Participants and Plan Administrator of  
The 403(b) Thrift Plan for Employees of Urban Teacher Center, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the 403(b) Thrift Plan for Employees of Urban Teacher Center, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Notes to the Financial Statements December 31, 2024 and 2023**

#### **1. DESCRIPTION OF PLAN**

The following brief description of the 403(b) Thrift Plan for Employees of Urban Teacher Center, Inc. (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan was established by Urban Teacher Inc., which had a name change to "City Teaching Alliance, Inc." effective July 13, 2023 (the Organization), effective January 1, 2009, to provide retirement benefits for employees of the Organization. The Plan covers substantially all employees and does not have a minimum age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Organization's Board of Directors (the Board). The Board has overall responsibility for the operation and administration of the Plan. The Board determines the appropriateness of the Plan's investment offerings and monitors the investment performance.

The Plan was most recently amended and restated on June 14, 2020.

##### **Recent Legislation**

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

##### **Contributions**

Eligible employees may elect to contribute through regular payroll deductions from 1% to 100% of their pre-tax annual compensation subject to the Internal Revenue Code (the Code) limitations. A participant may modify the amount of salary reduction at any time during the Plan year. Participants may also rollover distributions from other qualified plans.

#### **1. DESCRIPTION OF PLAN (continued)**

##### **Contributions (continued)**

Participants are eligible for employer discretionary matching contributions once they have reached a minimum service requirement of 6 months eligibility (not to exceed 24 months) consecutively. The Plan made employer discretionary contributions in the amount of \$65,778 to the Plan during the year ended December 31, 2024.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions and an allocation of the participant's share of the employer's discretionary matching contribution, as well as an allocation of investment earnings or losses.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon and 100% vested in Organization's contributions after one year of credited service.

##### **Payment of Benefits**

Upon retirement, termination, death, disability, age 59½ or later, or financial hardship, a participant may elect, subject to the provisions of the Plan, to receive benefits in the form of a lump sum, partial or installment cash payments in accordance with the applicable income tax regulations.

##### **Collateralized Assets with the Plan's Custodian (Plan Loans)**

Plan loans are issued as separate contracts by Mutual of America. Participants may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of his or her Mutual of America account balance, subject to annuity contract and Plan provisions. Loan terms range from one to five years in one-year increments (up to ten years for the purchase of the participant's primary residence). Principal and interest are paid ratably by the participant to Mutual of America, and each payment will reduce amounts collateralized by the borrowing participant's Mutual of America account balance.

If the borrower does not repay the loan and related interest due, in accordance with the schedule set forth in the loan agreement, his/her loan will be deemed to be in default.

#### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

As of December 31, 2024 and 2023, the loans outstanding amounted to \$46,375 and \$2,312, respectively. Additionally, there were no loans defaulted as of December 31, 2024 and 2023. As source assets to fund the loans were not Plan assets, these loans are not considered assets of the Plan and have not been included in the accompanying statements of net assets available for benefits.

#### **Forfeitures**

Forfeitures represent the non-vested portion of a terminated participant's discretionary matching and non-elective contributions. These amounts are used to reduce future matching contributions of the Organization. The balance of the non-vested forfeitures was \$0 and \$142, as of December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan allocated \$148 to reduce employer contributions.

#### **Plan Termination**

Although it is the intention of the Organization to maintain the Plan throughout its corporate existence, it has the right to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, and if no successor plan is established, all amounts credited to participant accounts will become fully vested.

#### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Organization's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

##### **Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income/(loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Contributions**

Employee and employer contributions are recorded in the period that the Organization makes payroll deductions from the participant's earnings. Employer discretionary contributions are recorded in the period they are approved by the Organization and may be funded after year end.

##### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

##### **Administrative Expenses**

Certain expenses of the Plan are paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participants' account balance and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### **Subsequent Events**

The Plan's management evaluated subsequent events and transactions through **September 25, 2025**, the date these financial statements were available for issue, and have determined that no material subsequent events have occurred that would affect the information presented in the accompanying financial statements or require additional disclosure.

#### **3. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024 was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company (Mutual of America), the custodian of the Plan.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Separate accounts.* Consists primarily of mutual funds, which are valued using pricing models maximizing the use of observable inputs for similar securities.

*General account.* Consists of cash equivalents valued at cost plus accrued interest at year end.

*Target date funds.* Valued at the daily closing price as reported by the fund using the net asset value as a practical expedient to estimate fair value.

#### **5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of money market funds managed by Mutual of America. Mutual of America serves as the custodian for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than direct payment.

#### **6. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

#### **7. INCOME TAX STATUS**

The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
