NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of Alvogen Group's Savings Incentive Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all employees of Norwich Pharmaceuticals, Inc., Alvogen, Inc., Alvogen Pinebrook Research & Development, Inc., Almatica Pharma, Inc. and Almaject Inc. (the Companies), except those employees that are a resident of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Investment Advisory Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Companies' board of directors.

Eligibility

All employees are eligible to participate in the Plan upon hire with the exception of temporary employees who must first attain the age of 21 and complete 1,000 hours of service.

Contributions

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund based on age until changed by the participant.

The Companies provide safe harbor matching contributions equaled to 100% of the first 6% of eligible compensation for all employees that contribute to the Plan.

Contributions – Continued

The Companies may also make discretionary matching contributions which will be computed by the employer based on eligible compensation contributed to the Plan each payroll period. The Companies will communicate the amount of any annual discretionary matching contributions. No amount of discretionary contributions was made during the years ended December 31, 2024 and 2023.

In addition, the Companies may make discretionary non-elective (“profit sharing”) contributions in an amount to be determined by the Board of Directors each year. Participants must complete at least 1,000 hours of service during the plan year to be eligible to receive any profit sharing contributions that may be made for that plan year. All contributions will be invested as designated by the participant. The Companies did not make profit sharing contributions to the Plan during the years ended December 31, 2024 and 2023.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the employer matching, safe harbor matching contributions, as well as allocations of (a) the Companies’ profit sharing contributions, if applicable and (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, rollovers from other plans, special contributions, and safe harbor matching employer contributions plus actual earnings thereon. Vesting in the employer discretionary profit sharing and matching amounts is based upon years of service as follows:

Notes Receivable from Participants

Plan participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence, in which case the term may be for a period of up to ten years. The notes receivable are secured by the balance in a participant's account and bear interest at the prevailing market rates at the time of issuance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, separation of employment, or retirement, participants may elect to receive a distribution of their vested account balance in the form of a single lump-sum payment or rollover contribution to another qualified plan. Account balances less than \$7,000 will automatically be distributed by the Plan upon a distributable event. Participants may elect to receive installment payments and terminated participants may elect to withdraw any portion of the vested balance.

In Service Withdrawals

A participant may, upon attainment of age 59 ½, elect to receive all or a portion of their vested account balance while still employed. Hardship withdrawals from the Plan are permitted and subject to certain limitations imposed by the Internal Revenue Service and specified in the Plan Document.

Forfeited Accounts

Upon termination, participants' non-vested account balances are forfeited. The outstanding balance of forfeited non-vested contributions totaled \$287,612 and \$159,679 at December 31, 2024 and 2023, respectively. These accounts will be used to pay Plan administrative expenses and to reduce future employer contributions. For the years ended December 31, 2024 and 2023, \$793 and \$217, respectively, were used to offset Plan expenses. Forfeitures used to reduce employer contributions for the years ended December 31, 2024 and 2023 amounted to \$13,262 and \$38,566, respectively.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). This basis differs from GAAP in that certain revenues are recognized when received rather than earned and certain expenses are recognized when paid rather than when the obligation is incurred. Specifically, the variances from GAAP include omission of certain contributions receivable and benefits payable. However, investments are reported at fair value.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is received. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES – Continued

Revenue Sharing Credits

The Plan has arrangements with certain investment managers and/or the recordkeeper under which a portion of investment-related fees are rebated to the Plan (commonly referred to as revenue sharing credits). These credits are used to pay or reduce certain administrative expenses of the Plan.

Revenue sharing credits are recognized as offsets to administrative expenses when applied. If revenue sharing credits exceed the administrative expenses incurred by the Plan during the year, the excess is recorded as other income in the accompanying statements of changes in net assets available for benefits – modified cash basis.

During the years ended December 31, 2024 and 2023, the Plan received revenue sharing credits of \$158,528 and \$131,477, respectively. Of this amount, \$46,134 and \$69,834, respectively, was applied against administrative expenses, and \$112,394 and \$61,643, respectively, was recorded as other income for the years ended December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Trustee fees are paid by the Plan.

Reclassifications

Certain 2023 amounts have been reclassified to conform with the 2024 presentation. These reclassifications had no impact on the total assets, liabilities, net assets available for benefits or changes in net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from Fidelity Management Trust Company, the trustee, that all of the information provided by them is complete and accurate.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at the net asset value, based on quoted market prices in active markets, of shares held by the Plan at year end.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Valued at the net asset value, based on fair values of underlying investments reported by the trustee of the funds. Fair values for the underlying assets were based on either quoted prices in active markets or observable inputs or quotations from inactive markets.

**NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST
TRANSACTIONS**

Fidelity Management Trust Company is the trustee of the Plan's assets. As such, transactions between Fidelity Management Trust Company and the Plan qualify as party-in-interest transactions. Transactions involving participant loans also qualify as party-in-interest transactions. As described in Note 2, the Companies or the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA and are exempt from prohibitive transaction rules.

NOTE 6 – PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 7 – TAX STATUS

The Plan relies on an advisory letter dated June 30, 2020 from the IRS for Volume Submitter Plans submitted under Revenue Procedures 2005-16, stating that the written form of the underlying volume submitter plan document is qualified under Section 401 of the Internal Revenue Code (“IRC”), and that under certain conditions, employers adopting this form of the Plan will be considered to have a plan qualified under the IRC. Although the Plan has been amended since receiving the advisory letter, the Plan administrator and legal counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits – modified cash basis.
