We have performed an audit of the financial statements of Colonial Group, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the Colonial Group, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Colonial Group, Inc. originally effective January 1, 1989, and most recently restated June 1, 2022. The Plan covers all employees of Colonial Group, Inc. and certain subsidiary companies: Colonial Oil Industries, Inc., Colonial Terminals, Inc., Colonial Energy, Inc., CTI of North Carolina, Inc., Georgia Kaolin Terminals, Inc., Colonial Fuel and Lubricant Services, Inc., Colonial Chemical Solutions, Inc., Savannah Yacht Center, Enmark Stations, Inc., Industrial Chemical, Crown Products and Services, Inc. and Kemlink USA, Inc. (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

The Plan covers all active employees of the Company, excluding bargaining employees, leased employees, reclassified employees and non-resident aliens. There are no age or service requirements and participants become eligible to participate immediately upon employment.

Contributions

Each year Participants may contribute up to the dollar limitation set forth in Section 402(g) of the Internal Revenue Code (IRC) in effect at the beginning of the Plan year. Participants who have attained age 50 before the close of the Plan year are allowed to make catch-up contributions up to the maximum allowed by the IRC. Contributions to the Plan are made voluntarily by participating employees who elect salary reduction, which is remitted to the Plan by the Company on behalf of the participants. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to operate the Plan under a safe harbor provision whereby participants in the Plan receive a non-elective matching contribution ("employer safe harbor match") of 100% of the first 3% and 50% of the next 2% of Participant contributions.

The Company may also elect to contribute to the Plan in the form of Employer profit-sharing contributions. The Company declared a profit-sharing contribution of \$7,325,899 for the year ended December 31, 2024.

Participant Accounts

Earnings from investment funds are allocated on a daily basis to participants' accounts based on the percentage that each Participant's account balance bears to the total of all account balances. Company profit-sharing contributions, net of forfeitures, are allocated to a Participant's account based on the percentage the Participant's qualified compensation bears to the total qualified compensation of eligible participants.

Each Participant's account is credited with the Participant's deferral contributions, the Participant's rollover contributions (if any), employer safe harbor matching contributions, Company profit-sharing contributions (if any), and an allocation of earnings and expenses thereon.

1. Description of the Plan (cont.)

Vesting

Participants are vested immediately in their elective deferrals, catch-up contributions and Company safe harbor contributions plus actual earnings thereon. Participants become fully vested in Company profit-sharing contributions and related earnings after three years of service. A year of service is one in which the Participant worked at least 1,000 hours.

As a result of the reduction in workforce during 2024, a partial plan termination of the Plan occurred. All affected Plan Participants became fully vested in their accounts.

Payment of Benefits

Upon termination of service, Participants are entitled to receive the vested value of their accounts in accordance with the specific provisions of the Plan. The Plan provides for withdrawals by Plan participants in the event of death, retirement, permanent disability, termination of employment, and other specified circumstances. If a terminated Participant's vested account balance is less than or equal to \$5,000 the amount may be automatically distributed in the form of a rollover to an individual retirement account designated by the Company. In addition, the Plan permits a Participant to request a withdrawal for certain conditions of financial hardship.

Notes Receivable from Participants

The Plan permits the Plan administrator to approve loans to participants in an amount not to exceed 50% of the Participant's vested balance or \$50,000. A Participant may not take more than 5 loans in a rolling 12-month period. Note receivable transactions are treated as transfer between the investment fund(s) and the Participant note receivable fund. The notes receivable from the participants are secured by the balance in the Participant's account and bear a reasonable rate of interest as defined by the Plan. The interest rate for loans is the prime rate plus 1% as of the date of the loan (4.25% to 9.50% at December 31, 2024). Principal and interest payments occur ratably through regular payroll deductions over a period not to exceed five years, unless the notes receivable were used to purchase a primary residence, which may have a term not to exceed ten years.

Forfeitures

The Plan allows for forfeited non-vested accounts to be used to reduce future Company contributions, added to other Company contributions, or reallocated, as elected by the Company. Forfeited non-vested accounts may also be used to pay allowable Plan administrative expenses. During the year ended December 31, 2024, the Company utilized total forfeitures of \$813,863 to reduce Company contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$940,907 and \$784,656, respectively.

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP require the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a Participant ceases to make loan repayments and the Plan administrator deems the Participant loan to be in default, the Participant loan balance is reduced, and a benefit payment is recorded.

Payments of Benefits

Benefits are recorded when paid.

Plan Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Company. Investment fees are paid by the Plan in the form of reductions of net investment income earned by Plan participants.

3. Certified Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (collectively Principal), the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from Participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from Participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Fair Value Measurement

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are as follows:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the quoted market prices of shares held by the Plan at year-end. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV) as of December 31, 2024 and 2023. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

Pooled Separate Account - The fair value of the pooled separate account is based on the NAV of each account calculated by New York Life Insurance Company, and is based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value. The pooled separate account is a direct filing entity (DFE).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market Participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Principal Life Insurance Company. The Internal Revenue Service (IRS) has opined and informed Principal Life Insurance Company a letter dated June 30, 2020, stating that the form of the document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Parties and Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. The custody and recordkeeping functions of the underlying investments held by the Plan are performed by Principal; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Company.

No such officer or employee receives compensation from the Plan. Various administrative expenses of the Plan are paid directly by the Company. Note receivable from Participants are also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transactions rules.

7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their Company contributions.

Notes to Financial Statements

8. Risks, Uncertainties, and Concentrations

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

9. ESOP Plan Merger

Effective March 1, 2024, the Plan was formally amended for the merger of the Colonial Group, Inc. Employee Stock Ownership Plan (ESOP) into existing plan assets. The total value of \$40,105,624 was transferred effective March 1, 2024.

10. Delinquent Participant Contributions

During 2024 employee withholdings of \$16,667 were not remitted within the appropriate time period by the Company. These transactions constituted prohibited transactions as defined by ERISA. The Plan sponsor remitted this contribution and lost earnings to the Plan in 2024. The Employer elected to correct the contributions and lost earnings but not to do so through the Voluntary Fiduciary Correction Program (VFCP) given the immateriality of the amounts.

11. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act of 2022 did not have a material effect on the Plan's financial statements.

12. Subsequent Events

Management has evaluated subsequent events through October 09, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan was formally amended to include a 3% auto-enrollment feature for employees hired subsequent to the amendment date.
