We have performed audits of the financial statements of Beghou Consulting, LLC Profit Sharing 401(k) Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Beghou Consulting, LLC (“the Company”) Profit Sharing 401(k) Plan and Trust (“the Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan covering all employees of the Company. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: The Plan covers all eligible employees of the Company who are age 21 and older. In November 2023, the Plan was amended to reduce the service requirement related to employee deferrals from six months to one month of service. Additionally, in January 2024, the Plan was amended to reduce the service requirement related to safe harbor employer matching contributions from six months to one month of service. Employees covered by a collective bargaining agreement, are leased employees, nonresident aliens or temporary employees, as defined, are excluded from eligibility to the Plan.

Contributions to the Plan: Eligible employees are automatically enrolled into the Plan contributing 3% of eligible compensation, unless participation is declined. Participants will have an automatic increase of 1% annually, not to exceed 10%. Participants excluded from this provision include those who already have an automatic deferral increase established, have declined automatic increase participation, or are in their first six months of participation in the Plan. Individual participants may contribute up to 100% of their eligible compensation not to exceed the Internal Revenue Service (IRS)’s maximum allowed into pre-tax and/or after-tax Roth investments. Participants may also rollover pre-tax amounts representing distributions from other qualified plans. Participants that have attained 50 years of age may also contribute “catch up” contributions.

The Company makes safe harbor matching employer contributions to the Plan for each eligible participant equal to 100% of the first 1% of an employee’s compensation contributed to the Plan and 50% of the next 5% of employee’s compensation contributed to the Plan.

The Company may also elect to make a discretionary profit-sharing contribution. There were no discretionary profit-sharing contributions related to the 2024 plan year. The Company made a discretionary profit-sharing contribution of \$118,501 related to the 2023 plan year to satisfy non-discrimination thresholds, which was deposited into the Plan in 2024. Plan participants direct the investment of their contributions, the safe harbor matching and profit-sharing contributions into the various investment options offered by the Plan.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s safe harbor matching contribution, and an allocation of the Company’s discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant contributions, plan compensation, or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their elective deferral and rollover contributions plus actual earnings thereon. A participant is 100% vested in the Company’s safe-harbor matching contribution portion of their account, plus actual earning thereon, after two years of credited service. A participant is 20% vested after two years of credited service and 20% per year thereafter, attaining 100% vesting after six years in discretionary contributions.

Payment of Benefits: Upon termination of service due to retirement, disability, or death, a participant may elect to receive a lump-sum payment or an annuity form of payment. Participants may receive distributions of their elective deferral contributions plus actual earnings thereon under certain financial hardship circumstances. Participants may obtain early retirement benefits at age 55 if they have reached 10 years of service with the Company. Additionally, the plan provides for withdrawals upon attainment of age 59½.

(Continued)

NOTE 1- PLAN DESCRIPTION (Continued)

Distributions: Upon a participant's death, disability, retirement, or separation from the Company, the participant is entitled to receive a distribution of the vested portion of his or her account balance.

Forfeitures: Forfeitures of participants' accounts for Company matching and discretionary profit sharing can be applied to pay for administrative expenses under the Plan and to the extent not used, to reduce Company contributions. Forfeitures pending application are invested as directed by the plan administrator. Forfeitures during 2024 and 2023 totaled \$37,857 and \$45,659, respectively. No forfeitures were used to pay for administrative expense or reduce Company contributions in 2024. Forfeitures available for future use were \$176,482 and \$129,970 as of December 31, 2024 and 2023, respectively.

Administrative Expenses: Administrative expenses are deducted directly from the Plan's assets as permitted by the Plan. Certain other professional fees are paid by the Company.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from those estimates.

Risks and Uncertainties: The Plan provides for various investment. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Because of the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Participants may borrow funds from their account balances up to a maximum of \$50,000 or 50% of the vested interest of the participant in his or her account. Loans must be repaid within five years unless used to purchase a primary residence and are charged interest at a rate determined by the plan administrator.

Subsequent Events: Plan management has evaluated all events or transactions that occurred from December 31, 2024 to October 8, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1).

Self-Directed Brokerage Accounts: Accounts primarily consist of mutual funds and common stocks, that are determined by obtaining quoted prices on nationally recognized securities exchange (Level 1).

Collective Trust: The fair values of participation units held in the collective trusts are based on the net asset values per unit as reported by the fund managers as of the financial statement dates and recent transaction prices. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Investments measured at fair value on a recurring basis are summarized below:

NOTE 4 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 5 – INCOME TAX STATUS

The Plan has adopted the provisions of a Fidelity Volume Submitter Basic Plan Document; therefore, the Plan is not required to file for an individual determination letter from the IRS. The volume submitter plan received a favorable opinion letter from the IRS dated June 30, 2020. Therefore, the plan administrator believes that the plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE 5 – INCOME TAX STATUS (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6 – RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan held certain party-in-interest investments, including investments managed by the trustee of the Plan and an affiliate of the trustee, Fidelity Investments, Inc. In addition, notes receivable from participants held by the Plan reflect party-in-interest transactions. During the year ended December 31, 2024, the Plan also paid administrative expenses to Fidelity Management Trust Company of \$9,144. Certain other professional fees for the administration and audit of the Plan were paid by the Company.
