INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 401(a) Profit-Sharing Plan for the Employees of Suncoast Community Health Centers, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the 401(a) Profit-Sharing Plan for the Employees of Suncoast Community Health Centers, Inc. (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Suncoast Community Health Centers, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

There is no age or service eligibility requirement to enter the Plan.

Effective January 1, 2023, the Plan was amended to exclude overtime wages and bonuses from the Plan's definition of compensation.

Contributions

The Company's contributions to the Plan are discretionary, as defined by the Plan. Participants shall be entitled to receive an allocation equal to their pro rata share of any employer contribution made for a plan year by the Company, provided those participants are employed on the last day of the plan year and have been credited with at least 1,000 hours of service within the plan year for which the contribution is being made. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. During the years ended December 31, 2024 and 2023, the Board of Directors authorized an employer contribution, net of forfeitures applied, of approximately \$1,402,000 and \$1,470,000 to the Plan, respectively. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Each participant's account is credited with the annual allocation of: (a) the Company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on the prorated earnings of the employee compared to the total earnings of all eligible employees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company's contribution is based on years of continuous service. A participant vests 10% after 1 year of service, 20% after 2 years of service plus an additional 20% after each additional year, and is 100% vested after 5 years of credited service. Participants also become fully vested, regardless of the number of years of service, when a participant reaches normal retirement age, passes away, or becomes totally and permanently disabled.

Notes Receivable from Participants

Participant loans are not allowed by the Plan.

Payment of Benefits

The Plan provides for the payment of benefits in the form of a monthly annuity. Participants may elect to receive the annuity benefits over various option periods provided by the Plan. Benefits are paid in a lump sum in certain circumstances. The Plan also allows for hardship withdrawals.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$192,600 and \$97,500, respectively. During 2024, employer contributions for 2023 were funded and reduced by approximately \$132,700 from forfeited nonvested accounts. Subsequent to year-end, employer contributions for 2024 were funded and reduced by approximately \$166,400 from forfeited nonvested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

The Plan's insurance company general account investment is valued at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5 for discussion of contract value measurements.

The Plan sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Group Annuity Contract

Amounts allocated to the fixed income account earn interest at the rate guaranteed under the contract established and declared in advance by the insurance company. The fixed income account is part of the insurance company's general account and is subject to the claims and the insurance company's general creditors. The insurance company guarantees a minimum rate of interest. Guarantees are subject to the insurance company's claims paying ability.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to plan administration are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. INFORMATION CERTIFIED BY TRUSTEE

All investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Mutual of America Life Insurance Company, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustee that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Pooled separate accounts: Valued based on net unit values of separate accounts for the contracts as reported by the insurance company that manages the separate pooled accounts.

In accordance with ASU 2015-12, *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965) – (Part I) Fully Benefit-Responsive Investment Contracts, (Part II) Plan Investment Disclosures, and (Part III) Measurement Date Practical Expedient*, if an investment is measured using the NAV per unit (or its equivalent) as the practical expedient in Accounting Standards Codification Topic 820 and that investment is in a fund that files a Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity, disclosure of that investment's strategy will no longer be required. As such, the Plan is not required to disclose the investment strategy of the Plan's investments in pooled separate accounts. There are no restrictions or redemption requirements on these investments.

Due to ASU 2015-17, *Fair Value Measurements (Topic 820): Disclosure for Investments in Certain Entities that Calculate Net Asset Value per Share (or its Equivalent)*, the Plan's investments in pooled separate accounts of \$14,802,916 and \$12,995,597 at December 31, 2024 and 2023, respectively, are valued based on the net asset value practical expedient and, therefore, do not require categorization within the fair value hierarchy.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Company has entered into a deposit administration group annuity contract with Mutual of America (MOA) to which contributions under the Plan are made. Participants can elect to invest amounts allocated to their accounts in a general account maintained by MOA.

The Plan's insurance company general account investment is valued at contract value, which represents contributions made under the contract, plus interest at the contract rate, less funds used to pay retirement benefits. Fair value of the general account approximates the contract value less any early withdrawal charges, maintenance fees, and market value adjustments if the contract was terminated at the reporting date.

The general account is considered a cash equivalent as it presents the following characteristics: (1) there are no front-end or back-end charges, so the investments in the general account are completely liquid; (2) the interest rate credited is a current rate and is not dependent on the length of time the assets are invested with MOA; (3) withdrawals can be made at any time and are processed on the

day the request is received; and (4) the published value is the redeemable value of the fund as there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of the withdrawal request. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. MOA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed periodically for resetting.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's expenses are paid either by the Plan or the Company, as provided in the plan document. Expenses that are paid directly by the Company, such as professional and recordkeeping fees, are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation in fair value of separate account investments presented in the accompanying statement of changes in net assets available for benefits.

Certain plan investments held during 2024 and 2023 were separate account funds managed by MOA. MOA also provided certain administrative services to the Plan. As such, MOA is considered to be a party-in-interest. Fees paid directly by the Plan for certain of these services for the year ended December 31, 2024 were \$5,125 and are considered to be party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

8. TAX STATUS

The Plan has adopted a prototype non-standardized profit sharing plan, which received an opinion letter from the IRS dated March 31, 2014 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10. VOLUNTARY CORRECTION PROGRAM

Effective January 1, 2022, the Plan was restated to comply with Cycle 3 requirements. Due to a drafting error, the Plan restatement inadvertently provided that bonuses are included in the definition of Compensation when historically bonuses have been excluded. To correct the inadvertent drafting error and to conform the Plan document to the operation of the Plan, the Plan applied to adopt a retroactive corrective amendment effective January 1, 2022 that reinstates the definition of Compensation to exclude bonuses through the Voluntary Correction Program (VCP) filing under the Employee Plans Compliance Resolution System (EPCRS). The Company requested that the operational failure be corrected with a retroactive amendment on October 27, 2023. The Company is currently waiting for approval from the Department of Labor on this correction for the 2022 employer contribution to exclude bonuses.

11. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 29, 2025, the date on which the financial statements were available to be issued.
