## **NOTES TO FINANCIAL STATEMENTS**

### **DESCRIPTION OF PLAN**

The following description of the N&S Construction, Inc. 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of N&S Construction, Inc, AAP Construction of VA LLC, and N&S Locating Services LLC (Companies). The Plan was established on October 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended and restated effective May 20, 2022. Significant Plan provisions remained the same under the new agreement.

#### ***Contributions***

Each year, participants may contribute up to 92% of pre-tax and post-tax annual compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional "catch-up" contributions up to the limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants may also elect to designate their salary deferrals as Roth deferrals. The Companies also make Safe Harbor matching contributions to the Plan for employees who meet certain service requirements. The Companies match 100% of the first 4% of a participant's deferred compensation. For any Plan year, the Companies may contribute additional discretionary amounts as determined by the Companies. The Companies did not contribute any additional discretionary amounts for the year ended December 31, 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options periodically. Contributions are subject to certain IRS limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, and an allocation of the Companies' matching contributions, as well as the Companies' discretionary contributions and Plan earnings, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their contributions and the Companies' Safe Harbor and discretionary contributions, plus actual earnings thereon.

## **NOTES TO FINANCIAL STATEMENTS**

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95% of 50% of their vested account balance, excluding the Roth elective deferral balance. The loans are secured by the balance in the participant's account. Interest rates, determined monthly, are the prime rate as published in the Wall Street Journal plus one percentage point. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the vested interest in his or her account in either a lump-sum amount or in annual installments over a specified period, or roll over the balance into an individual retirement account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### ***Forfeited Accounts***

Forfeitures may be used to reduce future employer contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

## **SUMMARY OF ACCOUNTING POLICIES**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the **FAIR VALUE MEASUREMENTS** note for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Contributions***

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### ***Notes Receivable from Participants***

Notes receivable from participants represent participant loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

### ***Payment of Benefits***

Benefit payments are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

## **INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified by Mid-Atlantic Trust Company, the Plan's Trustee, and was not subjected to any auditing procedures performed:

- a. Total investments, as shown in the accompanying statements of net assets available for benefits, of \$5,153,438 and \$3,610,397 as of December 31, 2024 and 2023, respectively.
- b. Net investment gain as shown in the accompanying statement of changes in net assets available for benefits of \$490,760 for the year ended December 31, 2024.
- c. All investment-related information except for participant loans in the accompanying supplemental schedule, Schedule of Assets (Held at End of Year) as of December 31, 2024.

### **FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds are stated at fair value as certified by the Plan's Trustee and are based on the fair value of the underlying securities. The fair value of the underlying securities is based on quotations from national exchanges.

**GROUP ANNUITY CONTRACT WITH STANDARD INSURANCE COMPANIES**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Companies (Standard) with a contract value of \$100,633 and \$101,884 at December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Crediting rates are not based directly on the actual performance of the underlying securities in the Guaranteed Fund, but rather are determined in the contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance Companies to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

## **NOTES TO FINANCIAL STATEMENTS**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would also limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

### **RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Companies contributions to the Plan or benefits accrued or paid by the Plan for participants are not considered party in interest transactions.

The Plan allows for transactions with certain parties who may perform services for or have fiduciary responsibilities to the Plan, including the Companies. Paychex, Inc. is a service provider for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for these services amounted to \$7,018 for the year ended December 31, 2024.

### **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Companies has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### **STATUS OF THE PLAN**

The Plan Sponsor adopted Paychex Inc.'s non-standardized pre-approved profit sharing plan document. The Internal Revenue Service has issued an opinion letter dated August 31, 2020, which states that the prototype Plan sponsored by Paychex, Inc. is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

## NOTES TO FINANCIAL STATEMENTS

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
