Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. We noted no particularly sensitive estimates.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. We noted no particularly sensitive disclosures.

The financial statement disclosures are neutral, consistent, and clear.

### **Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### **Difficulties Encountered in Performing the Audit**

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### **Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no misstatements identified during the audit. However, there were closing entry adjustments made to the certified report and management is in agreement with those adjustments.

We were engaged to perform an ERISA Section 103(a)(3)(c) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by the asset custodians that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

## **INTERNAL CONTROL**

---

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the Plan's internal control to be significant deficiencies:

### **INTERNAL CONTROL FINDINGS**

#### **2024-1 Missing Opt-Out Documentation for Automatically Enrolled Participants**

During our audit procedures, we noted that the Plan utilizes automatic enrollment; however, Plan management did not maintain documentation of participant opt-out elections. Opt-out forms, confirmations, or other evidence of participants' decisions to decline participation were not retained. Maintaining documentation of opt-out elections is necessary to demonstrate that participants were given the opportunity to decline automatic enrollment and that the Plan operated in accordance with its governing documents and ERISA requirements.

We recommend that the Company implement procedures to obtain and retain written or electronic opt-out confirmations for all participants who decline automatic enrollment.

#### **2024-2 Missed Employee Deferral Elections**

During our audit procedures, we identified participants who had elected to make employee deferral contributions; however, the elected deferrals were not withheld from their compensation as required. As a result, the Plan did not operate in accordance with participant elections or the Plan document, and affected participants did not receive the contributions they were entitled to. Failure to implement participant deferral elections may result in plan operational errors and could require corrective contributions, including lost earnings, in accordance with IRS and DOL correction programs.

We recommend that Plan management work with the payroll provider and third-party administrator to (1) identify all affected participants and correct the missed deferrals and related earnings, and (2) implement stronger controls to ensure that all employee deferral elections are timely and accurately processed going forward.
