To the Trustees of

Opinion

The Plan is a defined contribution plan, established as a 401(K) Profit Sharing Plan covering all full-time employees of the Company who have 60 consecutive days of employment with no age or hours requirement. Employer matching and non-elective contributions have no age requirement but do require minimum service of 12 months and minimum hours of 1,000. Roberts Oxygen Company, Inc. is the sponsor of the Plan.

The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA) and covers all full-time employees of the sponsoring company and adopting employers (collectively, the "Company"). The Trustee is responsible for oversight of the Plan. The Trustee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Employees may elect to defer up to 100% of their compensation to contribute to the Plan. The maximum amount of contribution is announced annually by the IRS and is limited to \$23,000 and \$22,500 for calendar years 2024 and 2023, respectively. An additional \$7,500 and \$7,500 catch-up provision amount, for participants age 50 or older, is permitted for calendar years 2024 and 2023, respectively.

The Company may also make matching contributions to the Plan in order to match all or a portion of a participant's elective deferrals. These contributions are not required. Participants can also cancel their Salary Deferral agreement at any time by giving written notice to the Administrator. If cancelled, the participants will not be permitted to make a new election until the first available date that you would otherwise be entitled to change an existing agreement.

Investment of Accounts

Plan participants may direct their entire account balances in partial percentage increments to any of the various investment options offered by the Plan and can switch between investments as often as is permitted under the investment options participants choose.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, if any. All earnings and losses on investments are credited directly to participants accounts. Investment results reflect any fees and investment expenses for the investments selected. Participant accounts are charged with allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings or account balances, as defined.

Forfeiture Account

A forfeiture account is held within the trust to accumulate monies forfeited by partially/non-vested terminated participants. Forfeitures can also arise from ineligible or erroneous deposits made to the plan. Amounts that can be allocated in this plan year are considered available forfeitures. Amounts not yet available are held in suspense for future years. As dictated by the provisions of the plan document, available forfeitures may be used to pay plan administration expenses or used as a credit towards future employer contributions. Forfeitures cannot fund employee contributions or loan repayments. Any remaining forfeitures must be reallocated proportionately to eligible plan participants. At December 31, 2024, and 2023, the Plan's forfeiture balance was \$0, respectively.

Vesting

A year of vesting service is a period of time used to determine the participants' vested interest in their accounts. Participants are credited with a year of vesting service for each vesting computation period during which they are credited with at least 1,000 hours of service. The vesting computation period is the Plan Year.

1. DESCRIPTION OF PLAN (CONTINUED)

Vesting (continued)

A Break in Eligibility Service will occur if participants are not credited with more than 500 hours of service during any 12 consecutive month eligibility computation period. However, in certain circumstances, such as taking time off to give birth to a child, to adopt a child, or taking time off to care for a child following the birth or adoption, participants will be credited with 501 Hours of Service in order to prevent them from incurring a break in eligibility service. This special credit will not be used to determine their years of vesting service or to determine participants' entitlement to a contribution for any Allocation Period).

Participants' vested interest in their elective deferral account is 100% at all times. Participants' vested interest in the Company's Matching Contribution Account is determined by the schedule following this paragraph, based on their years of vesting service. Any part of this account which is not vested will be forfeited when participants receive a distribution (or after participants incur 5 consecutive breaks in service, if earlier).

1-2 Years of Vesting Service	0% Vested

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their account balance. The loans are secured by the balance in the participant's account and bear interest at an annual interest rate to be fixed by the Plan Administrator. The Plan Administrator shall take into consideration interest rates currently being charged on similar commercial loans by persons in the business of lending money. Loans must be repaid within 5 years. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Benefits are recorded when paid. On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, roll the vested interest over to a separate account outside of the sponsor's plan, receive an annuity, or a combination of the three forms. For termination of service for other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution or roll the vested interest over to a separate account outside of the sponsor's plan.

SECURE 2.0 Act of 2022

On December 29, 2022, the SECURE 2.0 Act of 2022 (SECURE 2.0 Act) was enacted to help improve retirement savings. The SECURE 2.0 Act made wide-ranging changes, both mandatory and elective, to qualified plans and its provisions have various effective dates. Significant provisions include the following:

- increase the required minimum distribution (RMD) age from 72 to 73, effective January 1, 2023, and to age 75, effective January 1, 2033;
- reduce the excise tax for failure to take RMDs from 50 percent to 25 percent of the RMD amount that was not taken, beginning January 1, 2023; and
- require all catch-up contributions for participants with compensation of more than \$145,000 (indexed for inflation) to be designated as Roth 401(k) contributions beginning after December 31, 2023.

The Plan will incorporate changes in its Plan document and administration to the extent required by the SECURE 2.0 Act.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. Investment securities are valued at the last reported sales price at the end of the Plan year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Tax Status

The prototype plan (Volume Submitter Profit Sharing Plan With CODA) adopted by ROBERTS OXYGEN COMPANY 401(K) PLAN is qualified under section 401 of the Internal Revenue Code and is therefore not subject to tax under current income tax law for use by employers for the benefit of their employees. The Plan's reliance on this qualification has been based upon a most recently received opinion letter, dated July 18, 2020, from the Internal Revenue Service for the prototype plan.

The Company and Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan's management believes it is no longer subject to income tax examinations for years prior to 2021.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Reclassifications

Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on the results presented.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the identified assets or liabilities, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the assets or liabilities have a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement. The measurements typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

The asset of liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. GUARANTEED INVESTMENT CONTRACT WITH NATIONAL INSURANCE COMPANY

In November 2015 the Plan entered into a benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company (John Hancock). John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive, contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by John Hancock represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

4. GUARANTEED INVESTMENT CONTRACT WITH NATIONAL INSURANCE COMPANY (CONTINUED)

Presently, the fair value of the guaranteed investment contract equals the contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$6,821 and \$6,031 at December 31, 2024 and 2023, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one percent (1%). Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including completed or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibition transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in the Company contribution of their accounts.

6. PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS

Certain plan investments are shares of mutual funds managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is a trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Fees paid by the Plan for investment management services amount to \$31,830 and \$21,798 for the years ended December 31, 2024 and 2023, respectively. Another \$12,679 and \$8,729 for custodial fees, broker fees and record keeping fees were netted against investment results for the years ended December 31, 2024 and 2023, respectively.

6. PARTY IN INTEREST AND RELATED PARTY TRANSACTIONS (CONTINUED)

Participant loans receivable qualify as party-in-interest transactions but are exempt from prohibited transaction rules of ERISA. At December 31, 2024 and 2023, the participant loans receivable balance was \$126,767 and \$133,285, respectively.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administration expenses for the trustee's fees are paid directly by the Company.

7. PLAN RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.

8. SUBSEQUENT EVENTS

In accordance with FASB ASC 855, the Plan evaluated subsequent events through October 2, 2025, the date these financial statements were available to be issued. There are no material subsequent events that required recognition or additional disclosure in these financial statements.
