## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## PAVmed Inc. 401(k) Profit Sharing Plan Notes to the Financial Statements

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the PAVmed Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

#### ***General***

The Plan was established on January 1, 2016, restated effective January 1, 2023, and is a defined contribution plan covering employees of PAVMed, Inc. and Lucid Diagnostics, Inc. (the “Companies”, “Sponsors”, and “Employers”). The plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The plan’s trustees are responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Some administrative functions are performed by employees of the Companies. No compensation is remitted to the Companies for these services.

Plan assets are held and managed by Reliance Trust Company, Transamerica Trust Company, and Transamerica Life Insurance Company, Inc., who invest contributions and Plan earnings, make investment transactions as directed by Plan management. Transamerica Retirement Solutions, LLC provides certain recordkeeping services and annual ERISA compliance testing.

#### ***Eligibility***

Employees who have attained age twenty-one and who are not residents of Puerto Rico or non-resident aliens are eligible to participate in the Plan. An eligible employee may enter the plan on the first day of the month after all entry requirements have been met.

#### ***Contributions***

Each year, participants may contribute a percentage of pretax annual compensation as defined by the plan up to 90% of their compensation (subject to annual deferral limits). The Plan also allowed for participants to make Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The plan provision also provides for employer matching contributions. Employer matching is fixed at 100% of the first 3% of the participants’ contributions.

Contributions are subject to certain internal revenue service limitations.

## PAVmed Inc. 401(k) Profit Sharing Plan Notes to the Financial Statements

### NOTE 1: DESCRIPTION OF THE PLAN (Continued)

#### *Participant accounts*

Each participant's account is credited with the participant's contributions, employer contributions and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are fully vested in their contributions as well as employer matching contributions plus actual earnings thereon immediately upon entering the Plan.

#### *Notes receivable from participants*

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is based on local prevailing rates on similar commercial loans, as determined by the plan administrator. Principal and interest is paid ratably through recurring payroll deductions. Loan terms cannot be extended beyond five years unless for a primary residence in which case they may not extend beyond thirty years.

#### *Investment options*

Upon enrollment in the Plan, a participant may direct employee and Plan sponsor contributions in any of the investment options that are offered by the plan.

#### *Benefit payments*

Benefit payments may generally be made to a participant upon the participant's retirement, death, disability, termination of employment, attainment of age 59 1/2, or upon incurring a financial hardship. Normal retirement age is 65. Benefits shall be paid to participants in an amount equal to the value of the participant's vested interest in his or her account in a single lump sum. Distribution of a deceased participant's account will be made to the designated beneficiary.

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they or a beneficiary experience severe financial hardship. The participant must meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

## PAVmed Inc. 401(k) Profit Sharing Plan Notes to the Financial Statements

### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### Use of estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV) or contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements and NAV. The Plan administrator determines the Plan's valuation policies utilizing information provided by the Plan's custodian.

The plan holds an interest in a group annuity contract with Transamerica Life Insurance Company, Inc. Plan Management has determined its interest in the contract is fully benefit-responsive and it is reported at contract value. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There was no credit loss for loans in default during the 2024 plan year. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contribution liabilities as of December 31, 2024, or 2023.

### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### Payment of benefits

Distributions to participants are recorded when paid.

#### Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to participant directed transactions are charged directly to participants' accounts and are included in administrative expenses. During the year ended December 31, 2024, \$32,129 of administrative expenses related to plan advisory and administrative services were charged and allocated to participant accounts, respectively.

#### Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risks associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### Subsequent events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 9, 2025. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### NOTE 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by Reliance Trust Company, Transamerica Trust Company, and Transamerica Life Insurance Company, Inc., the qualified institutions, under such regulation:

- a) Investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- b) Investment, at contract value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- c) Notes receivable from participants included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- d) Investment income information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- e) Interest income on notes receivable from participants in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- f) All amounts included in Note 4, Fair Value Measurements.
- g) All amounts included in Note 5, Fully Benefit-Responsive Investment.
- h) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### NOTE 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of input that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, which are:
  - Observable; or
  - Can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT**

The plan has entered into a traditional fully benefit-responsive investment held through a rider on Transamerica Life Insurance Company's group annuity contract with investments totaling \$147,072 and \$118,147 at December 31, 2024 and 2023, respectively. Transamerica Life Insurance Company maintains the contributions in their general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a semi-annual basis for resetting. The interest crediting rate was 1.65% and 1.25% as of December 31, 2024 and 2023, respectively.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Participant transactions may be redeemed daily and there is no notice period for cancellation of the contract by the contract holder. Notwithstanding, in the event the issuer receives withdrawal request equal to a greater than 4% or 14% of Transamerica Life Insurance Company's general account within a one or six month period, they reserve the right to delay payment on contract cancellation by up to twelve months.

**NOTE 6: TAX STATUS**

The Plan sponsor has adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is “more likely than not” that the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. Plan management has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken to require the recognition of a liability or disclosures on the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are managed by Transamerica Trust Company and Transamerica Life Insurance Company who are affiliates of Transamerica Retirement Solutions, LLC, which is the recordkeeper of the Plan and, therefore, these transactions qualify as party in interest transactions.

Transamerica Retirement Solutions, LLC provides administrative and recordkeeping services to the Plan. Fees paid by the Plan for these administrative services totaled \$32,129 in 2024.

**NOTE 8: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Employer contributions.

**NOTE 9: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

Certain amounts reported on Form 5500 differ from the financial statements as the Form 5500 was reported on a cash basis prior to 2024. The Plan adjusted its basis of accounting on Form 5500 from a cash basis method of accounting in 2023 to the accrual basis method of accounting in 2024.
