Note 1 - Plan Description

The following description of Guidehouse Managed Services LLC 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on September 2, 2014 and is a defined contribution plan covering substantially all employees of Guidehouse Managed Services LLC (the "Company"), a subsidiary of Guidehouse Inc., who have completed 90 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Amounts totaling \$475,680 were transferred into the Plan from the Guidehouse Inc. Retirement Plan, and amounts totaling \$337,747 were transferred out of the Plan to the Guidehouse Inc. Retirement Plan, a plan sponsored by Guidehouse Inc. in 2024.

Contributions

The Plan provides for employee pretax and/or Roth 401(k) contributions up to a maximum of 85 percent of annual compensation, as defined in the plan document. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Contributions are made through payroll deductions and are subject to limitations set by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions. For 2024, the Company provided matching contributions of up to 50 percent on the first 6 percent of eligible deferred compensation per pay period, up to the Internal Revenue Service maximum eligible compensation amount of \$345,000 that a participant contributed to the Plan during the year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with benefit payments and an allocation of plan losses. Each participant's account is charged a record-keeping fee on a quarterly basis and credited with an allocation of revenue-sharing payments received by the recordkeeper of the Plan. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's matching contributions, plus actual earnings thereon, is based on years of service. Effective January 1, 2024, the Plan was amended where employer matching contributions, profit-sharing contributions, and employer nonelective contributions and any earnings thereon fully vest after one year of service. Participants terminated prior to January 1, 2024 vest in profit-sharing contributions made by the Company 25 percent per year after two years of service until they become fully vested after five years of service. Participants terminated prior to January 1, 2023 vest in discretionary matching contributions made by the Company 25 percent per year after two years of service until they become fully vested after five years of service.

Participants who transfer employment from Guidehouse Inc. and whose accounts transfer directly by way of a trust-to-trust transfer from the Guidehouse Inc. Retirement Plan to the Plan in connection with such transfer of employment are immediately 100 percent vested in discretionary matching contributions made by the Company.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, long-term disability, or termination of employment in the form of a lump-sum amount equal to the value of the participant's vested interest in his or her account or in various installment annuities. Hardship distributions are also permitted if certain criteria are met.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are retained in the Plan and are first used to pay administrative expenses. Any remaining amounts will be used to reduce future employer discretionary matching contributions payable to the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$40,681 and \$456,966, respectively.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

All administrative costs are paid by the Plan unless paid by the Company or the participant. All record-keeping expenses are paid by the participants through an allocation of such expenses to their respective accounts.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 24, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the IRS. The volume submitter plan has received a favorable notification letter from the IRS dated March 31, 2014. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Collective Trust Funds

The collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments.
