## INDEPENDENT AUDITORS' REPORT

To the Board of Directors  
Positive Impact Health Centers, Inc. 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Positive Impact Health Centers, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audits]. The financial statements comprise of the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **1. DESCRIPTION OF THE PLAN**

The following description of the Positive Impact Health Centers, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### **General**

The Plan, which was established effective April 1, 2008, is a contributory, defined contribution plan available to qualifying employees of Positive Impact Health Centers, Inc. (the Company or Plan Sponsor) with the exception of union employees and nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### **Administration**

Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal) and Principal Life Insurance Company (Principal Life) serve as custodian and recordkeeper of the Plan. The Plan administrator and investment advisors determine the appropriateness of the Plan's investment offerings and monitor investment performance.

### **Eligibility**

To become an active member of the Plan, an employee must complete 28 days of service with the Plan Sponsor. Nonresident aliens, who have no earned income from sources within the United States, union employees and part time employees are excluded. Participants can enter the Plan on the first day of the month after meeting eligibility requirements.

### **Contributions**

Each year, participants may contribute up to 100% of annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Code (IRC) limits. Participants may designate all or a portion of their salary deferral as Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

All new participants hired after June 1, 2023, who do not elect a contribution percentage or do not elect to opt out of the Plan, are automatically enrolled for pre-tax contributions at a rate of 3% of eligible earnings.

Each year, the Plan Sponsor will make a safe harbor nonelective contribution equal to 3% of participant's eligible compensation.

The Plan Sponsor may make a discretionary profit-sharing contribution equal to a uniform percentage of a participant's salary deferrals based on their position within the Company. Each year, the Plan Sponsor will determine the amount of the discretionary percentage. During the year ended December 31, 2024, the Plan Sponsor made a discretionary profit-sharing contribution of 2% for all participants, an additional 1% for senior staff and an additional 2% for certain executives.

**Participant Accounts**

Each participant account is credited or charged with the participant's contributions, Plan Sponsor safe harbor matching and discretionary profit-sharing contributions and an allocation of net Plan investment earnings. Participant accounts are charged with withdrawals, Plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of the borrowing is five years unless it is for the purchase of a principal residence in which case the Plan administrator may permit a longer repayment term. A participant's note shall immediately become due and payable if such participant terminates employment for any reason or fails to make a principal and/or interest payment as provided in the note agreement. The notes are secured by the balance in the participant's account and bear a reasonable rate of interest, as determined by the Plan administrator. Principal and interest are repaid ratably through payroll deductions.

**Vesting**

Participants are immediately vested in their contributions, the Plan Sponsor's safe harbor contributions and the earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement (age 65) or separation from service, a participant or their beneficiary, may receive their vested balance in either a single lump-sum distribution or a direct rollover into a qualified retirement plan or individual retirement account. Terminated participants with a vested balance less than \$5,000 that have not elected payment will be cashed out. Rollovers are excluded in determining the \$5,000 threshold. The Plan also allows for in-service withdrawals upon reaching age 59½, for financial hardships, as defined by the Plan, and from all vested sources.

**Forfeitures**

Forfeited accounts will be used to reduce future Plan Sponsor contributions, to pay Plan expenses or will be reallocated to participant accounts. When reallocated to participant accounts, the forfeiture allocation follows the same manner as the profit-sharing contribution. The forfeiture balance as of December 31, 2024 and 2023, was \$1,008 and \$942, respectively. For the year ended December 31, 2024, Plan expenses were reduced by \$28,177. This account is regarded as an asset of the Plan for financial statement and Form 5500 reporting.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, with the exception of the group annuity contracts, which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expense charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make repayments and the Plan administrator deems the note receivable to be in default, the participant loan balance is reclassified as a benefit payment based upon terms of the Plan document.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to distribution, loan origination, administration of notes receivable from participants and various recordkeeping fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Subsequent Events**

Plan management has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued and has determined that there are no subsequent events that require disclosure under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 855, *Subsequent Events*.

**3. INFORMATION CERTIFIED BY PLAN CUSTODIANS**

Certain information related to investments disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and Principal Life.

**4. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In May 2022, the Plan entered into a contract with Principal in which the Plan invests in a fully benefit-responsive fixed account option investment issued by Principal through Principal Life, an affiliate of the Custodian. Benefit payments are made at book value (i.e., no termination or surrender charge adjustments) for Plan benefit events and investment transfers initiated by Plan participants.

The contract is considered benefit responsive. Contract value represents contributions, plus credited interest, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The custodian is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The investment does not permit the custodian to terminate the agreement prior to the scheduled maturity date. There are no reserves against the contract value for credit risk.

Certain events, such as the premature termination of the contract by the Plan or the termination of the Plan, would limit the Plan's ability to transact at contract value with the custodian. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes the occurrence of such events that would also limit the Plan's ability to transact at contract value with Plan participants is not probable.

The Custodian is contractually obligated to pay the principal and specified interest rates guaranteed plus compounded interest over a defined term, three, five or ten years, provided all contributions remain in the account until the end of the guarantee period. There are no reserves against the contract value for credit risk of the contract issuer as of December 31, 2024 and 2023. Under the group annuity contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account at contract value within

reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The interest rate earned is established on the first day of each month and apply to all ongoing contributions made to the account in that month. At the of each reporting year, a composite rate of interest is determined.

The Plan's ability to receive amounts due in accordance with fully benefit-responsible contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory requirements.

Certain events could limit the ability of the Plan to transact at contract value, including but not limited to, premature termination of the contract by the Plan. This would cause a one-time adjustment to the aggregate contract value, resulting in a fair value different from the contract value; however, the Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value, are probable of occurring.

## **5. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Common collective trust (CCTs) funds:* Valued at NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

*Pooled separate accounts (PSAs):* The fair values of accumulated units held by the Plan in the pooled separate accounts are based on each account's daily NAV, which is considered by Plan management to be the best approximation of fair value. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different than the reported NAV.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of PSAs, CCTs and GICs managed by the custodians as of December 31, 2024 and 2023. Therefore, related transactions qualify as party-in-interest transactions. The Plan paid administrative fees of \$82,098 to the custodian and third-party administrator fees during 2024. The Plan Sponsor pays directly any other fees related to the Plan's operations. The Plan ERISA Spending account held by Principal earned income reflected as other income on the statement of changes in net assets available for benefits and paid investment advisor fees included as part of plan expenses.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**8. TAX STATUS**

The Plan Sponsor adopted a 401(k)/Profit Sharing Non-Standardized plan document sponsored by ERISA Services, Inc., which received an opinion letter from the Internal Revenue Service (IRS) dated June 1, 2021, indicating that the plan document -is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
