#### **Note 1 – Plan Description**

The following is a brief description of the KLM Retirement Savings Plan (the “Plan”). Effective January 1, 2024, the Company amended and restated their non-standardized Plan Agreement to a standardized Plan Agreement. The new Plan Agreement changes several Plan provisions, including eligible compensation and the employer match formula. Some of the Plan amendments are specifically related to employees hired on or after January 1, 2024. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution pension plan sponsored by KLM Royal Dutch Airlines (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, (“ERISA”), as amended. Administration of the Plan is provided by a committee of four people (two members of the Company and two Plan participants, all of which are appointed by the Company) called the KLM Retirement Savings Plan Committee. The Plan’s assets are held in a trust administered by T. Rowe Price Trust Company (the Trustee).

#### **Eligibility**

The Plan is available to all employees of the Company, except leased employees, residents of Puerto Rico, expatriates and interns. All eligible employees, as previously defined, are immediately qualified to participate in the Plan.

#### **Contributions**

Each year, participants may make voluntary, pre-tax contributions (elective contributions) of up to 75% of annual eligible compensation. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. Participants direct the investment of the contributions in various investment options offered by the plan. The investment options include various mutual funds, a pooled separate account, and a guaranteed interest account, which provide participants with the opportunity to select from various returns on investment alternatives. Matching contributions are not made until the first enrollment period after the participant completes one year of service. The maximum voluntary pre-tax contribution permitted by law was \$23,000 and \$22,500 for 2024 and 2023, respectively, per participant. Participants, who are at least age 50 by the end of the year, were allowed to contribute an additional \$7,500 for 2024 and 2023, for a total of \$30,500 and \$30,000 for 2024 and 2023, respectively, per participant. The Plan includes various tests required under ERISA, which has the effect of limiting contributions of highly paid employees.

Effective January 1, 2024, the Plan included an automatic deferral of 5% of eligible compensation, unless the participant makes a contrary election. The automatic deferral percentage increases annually by 1%, until reaching a maximum of 15%.

Prior to August 1, 2023, the Plan agreement called for a 5% mandatory minimum employee contribution unless the employee elected not to contribute to the Plan. Effective August 1, 2023, there was a Plan amendment that terminated the 5% mandatory minimum employee contribution. The majority of the employees elected to increase their voluntary employee contribution accordingly.

**Contributions – Cont'd**

Through December 31, 2023, the Company contributed amounts up to 6% of the participant's eligible compensation based on the length of time a participant has been an employee of the Company, as described in the Plan agreement. Effective January 1, 2024, the Company will provide a non-safe harbor matching contribution in an amount equal to a percentage of the elective deferrals of 100% of the first 7%, for a maximum of 7%. In addition, effective January 1, 2024, the Company provides a 2% nonelective contribution only to employees hired before January 1, 2024. The Plan also allows for qualified nonelective contributions to the Plan by the employer in order to correct errors in the administration of the Plan.

**Participants' Accounts**

Each participant's account is credited with the participant's contributions and rollover contributions, the allocation of the Company's contribution and Plan earnings, and charged with certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contribution and the Company's contributions, plus actual earnings, and shall not be subject to forfeiture for any reason.

**Notes Receivable from Participants**

Subject to terms and conditions imposed by applicable tax regulations and the loan agreement, participants may borrow from their account a minimum of \$1,000, and up to a maximum of \$50,000, or 50% of their account balance, whichever is less. Loan terms range from one to five years, or for a longer period if used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through bi-weekly payroll deductions. Participants may also make payments by other means specified in the loan agreement. A loan default resulting in a taxable distribution (and early withdrawal penalties if applicable) will occur if payment is not made within thirty days of the loan due date.

**Retirement**

Normal retirement is defined as age 65. The participant may elect to receive the retirement benefits in a lump sum, or alternate form of payment, as permitted in the Plan.

**Payment of Benefit**

Upon retirement, hardship or termination, or for termination of service for other reasons, vested interest in his or her account can be distributed in either a lump sum benefit or an alternative form of payment, as permitted under the Plan. If the participant's vested benefit does not exceed \$5,000, the Plan Administrator may direct the trustee to distribute, in a lump sum payment, the participant's vested benefits.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. The fair value of the Plan's Stable Value Fund is valued using pricing services of T.Rowe Price Trust Company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest income. Delinquent participant loans are reclassified as distributions.

**Other Income**

The Trustee may receive revenue sharing payments from shares of registered investment companies in which the Plan assets are invested. The administrative services agreement between the Plan and the Trustee provides that to the extent revenue sharing payments received by the Trustee exceed an established revenue threshold agreed to between the Trustee and the Plan, the excess will be credited to the Plan. For 2024 and 2023, \$28,870 and \$27,427, respectively, were credited to the Plan under this agreement. The balance in the administration budget account, which holds the revenue sharing payments was \$2,457 and \$16,102 on December 31, 2024 and 2023, respectively, and is available for payment of future Plan expenses. Plan expenses were paid from this account in the amount of \$42,263 and \$24,588 for the years ended December 31, 2024 and 2023, respectively. For additional amounts included in "Other Income" see Note 5 – Excess Contributions Payable.

**Payment of Benefits**

Benefit payments are recorded when paid. There were no withdrawals approved but not paid as of December 31, 2024 and 2023.

**Administrative Expenses**

Professional fees and certain administrative expenses incurred by the Plan are paid by the Company. Participant generated transaction fees, expenses for third-party investment advice and plan recordkeeping are paid by the plan.

**Subsequent Events**

Subsequent events were evaluated through October 9, 2005, which is the date the financial statements were available to be issued.

#### Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

#### *Shares of Registered Investment Companies*

Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The shares of registered investment companies held by the Plan are deemed to be actively traded.

#### *Common Trust Funds*

The common trust funds are valued at the NAV of units of the bank common trust. The NAV is used as a practical expedient, to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The Stable Value Fund seeks to preserve a participant's principal investment and offers competitive income consistent with the preservation of principal. It invests in investment contracts issued by high quality companies.

**Note 5 – Excess Contributions Payable**

Effective August 1, 2023, with the termination of the 5% mandatory minimum contribution, the employer matching contribution was incorrectly calculated by the payroll processing company because of a calculation error. The Company detected the calculation error after eleven incorrect pay periods, nine in 2023 and two in 2024. The Company worked with their ERISA Counsel to retroactively correct the error, which was corrected in early 2024. After all corrections were made to the participant accounts, the funds were transferred to a plan administrative holding account and will be used to offset future contributions or administrative expenses. Therefore, the "Excess Contribution Payable" of \$157,824 on December 31, 2023 has been recorded to "Other Income" in 2024.

**Note 5 – Related-Party Transactions and Party-in-Interest Transactions**

Certain plan investments are shares of registered investment companies or units of common trust funds managed by T. Rowe Price, an affiliate of the Plan's Trustee. Transactions involving these funds qualify as exempt party-in-interest transactions under ERISA. The Company pays certain administrative expenses of the Plan. In addition, the Company also provides to the Plan certain accounting and administrative services for which no fees are charged.

**Note 6 – Tax Status**

The Plan obtained its latest determination letter, dated August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. Plan management believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan, with the consent of two-thirds of the participants, to terminate the Plan subject to the terms of ERISA.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are subject to various risks, such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**Note 9 – Reconciliation of Financial Statements to IRS Form 5500**

There were no material differences between the accompanying statements of net assets available for benefits and changes in net assets available for benefits and IRS Form 5500, Annual Return/Report of Employee Benefit Plan, filed with the U.S. Department of Labor and the Internal Revenue Service.
