Opinion

We have audited the financial statements of National Nail Corp. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Such information is the responsibility of the Plan’s management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Plan Description

The following description of National Nail Corp. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Effective April 1, 1997, National Nail Corp. (the "Company") established National Nail Corp. Employee Stock Ownership Plan. The Plan is a noncontributory, leveraged, defined contribution plan covering all employees who have at least one year of service, work at least 800 hours during the plan year, and are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan purchased the Company's common shares from existing stockholders using funds borrowed from the Company and holds the stock in a trust established under the Plan (see Note 5). As the Plan makes each payment of principal, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the Internal Revenue Code.

The above loan is collateralized by the unallocated shares of stock and is guaranteed by the Company. Accordingly, the accompanying financial statements present separately the net assets and changes therein pertaining to the accounts of employees with vested and nonvested rights in allocated stock (allocated) and stock not yet allocated to employees (unallocated).

Contributions

The Company is required to make a safe harbor matching contribution of 100 percent of the elective contributions made for each eligible participant under National Nail Corp. 401(k) Retirement Savings Plan up to 5 percent of compensation for 2024 and 2023.

Contributions to the Plan are at the discretion of the Company's board of directors, provided that such contributions shall be sufficient to cover principal and interest on the securities acquisition loan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year for the amount of the Company's contribution. Additionally, each participant's account is credited as of the last day of each plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year and have completed 800 or more hours of service in the plan year will receive an allocation. Allocations are first based on the safe harbor matching provision based on a participant's contributions into the Company's 401(k) retirement plan, and any remaining shares to be allocated are then based on a participant's eligible compensation relative to total eligible compensation.

Vesting

A participant is immediately 100 percent vested in the safe harbor contributions and actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of credited service, with participants becoming 100 percent vested after five years of credited service.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of service, or diversification. A participant who is eligible to receive the distribution of his or her account balance will receive a lump-sum amount if his or her account balance is less than or equal to \$1,000,000. If the participant's balance is greater than \$1,000,000, the participant will receive up to four annual installments with a minimum of \$1,000,000 each until the balance is distributed in full in accordance with the provisions of the Plan's distribution policy. Distributions are made in cash or company stock. Diversification distributions are allowed for an amount up to 25 percent of the participant's total shares allocated if the participant has reached age 55 and has been a participant for a minimum of 10 years, up to 50 percent if the participant has reached aged 60 and has been a participant for a minimum of 15 years, and up to 100 percent if the participant has reached age 65, irrespective of how long the participant has been in the Plan.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan. During 2024 and 2023, the Plan distributed and the Company repurchased from participants 33,274 and 46,045 shares, respectively.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. In the event of plan termination, the trustees shall distribute all assets remaining in the Plan, after the payment of any liabilities and expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. The Company allocates forfeitures to participants based on participants' compensation, as defined. Allocations of forfeitures are considered additional company contributions and are subject to the vesting provisions of company contributions.

Voting Company Stock

The plan administrative committee has the authority to exercise, in certain matters, voting rights attributable to the shares allocated to the Plan and is notified by the trustee prior to the time that such rights are to be exercised.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value. The common shares of National Nail Corp. are valued at fair value, as determined by an annual independent appraisal. See Note 6 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

Various administrative costs are paid by the Company.

Benefit Payments

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in company common stock. This investment is exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. The most significant assumptions and estimates relate to the valuation of company common stock. Included in the accompanying statement of net assets available for benefits is an investment in the Company's common stock reported at fair value of \$234,625,041 and \$229,676,649 as of December 31, 2024 and 2023, respectively. This asset is valued based upon a third-party appraiser's estimation of the current market value of the common stock and is supported by the Company's financial statements. Due to estimates and assumptions made in developing such appraisals, it is at least reasonably possible that the market value of the investment may be different than reported.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Note 4 - Investments in Common Stock

The Plan's investments, which consist entirely of the Company's stock held by the plan administrator at December 31, 2024 and 2023, are presented in the following table:

Note 5 - Notes Payable - Employer

The Plan has borrowed many times from the Company to purchase outstanding shares of the Company.

Effective December 31, 2020, the Plan refinanced the 476,381 unallocated shares into a new note of \$7,309,826. The note requires annual principal payments of \$10,000 plus interest at a rate of 1.31 percent and matures on December 31, 2070 with a lump-sum payment of the outstanding balance.

As of December 31, 2024 and 2023, the outstanding balance was \$6,971,404 and \$7,022,134, respectively.

The loan is collateralized by the unallocated company stock.

Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. Significant Level 3 inputs for company stock are based on the fair value determined through third-party appraisal, which utilized a combination of both market and income approaches, including the discounted cash flow method and the guideline public company method. The unobservable inputs for the discounted cash flow method were the weighted-average cost of capital, revenue growth, and discount for limited marketability. The unobservable inputs for the guideline public company method were valuation multiples on sales and EBITDA.

Note 6 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
