Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Chartwell Operations LLC Multiple Employer 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

NOTE A – DESCRIPTION OF PLAN

The following description of the Chartwell Operations LLC Multiple Employer 401(k) Plan (the “Plan”) provides only general information. Chartwell Operations LLC is the Plan sponsor and a member of a controlled group. The other members of the controlled group are Delfasco Operations LLC and Starfire Operations LLC (collectively, “the Company”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan became effective January 1, 2018.

General

The Plan is a defined contribution plan covering substantially all employees of the Company who have completed three months of service and are age 21 or older, except for 1) employees whose retirement benefits have been collectively bargained, 2) any leased employees, and 3) non-resident alien employees. An employee may enter the Plan on the first day of each plan quarter coinciding with or following the date on which the employee meets the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”). The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan’s Board of Trustees.

Contributions

Each year, participants may contribute up to 100 percent of annual compensation, as defined in the Plan, as either tax-deferred contributions or as after-tax ROTH contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover). Participants direct the investment of their contributions, as well as Company contributions, into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may increase or decrease their contributions on a monthly basis. Participants may stop contributing at any time.

The Company may make an annual matching contribution in a discretionary amount equal to a uniform percentage of the amount contributed by each participant. There was no matching contribution for the years ended December 31, 2024 and 2023. Additional profit sharing amounts may be contributed at the option of the Company’s board of directors. There was no discretionary profit sharing contribution for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's salary reduction contributions and Company matching contributions (if any), as well as allocations of the Company's profit sharing contribution (if any) and Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The Company's profit sharing contributions to the Plan are allocated among all of the participants who have completed 1,000 hours of service, as defined within the Plan document, and are actively employed on the last day of the Plan year.

Vesting

Participants are vested immediately in their own salary reduction contributions, rollover contributions plus actual earnings thereon. Vesting in the Company's matching or profit-sharing contribution portion of their accounts is based on years of continuous service. A participant is vested over a six-year period, as defined in the Plan adoption agreement.

Notes Receivable From Participants

A participant may borrow from their fund accounts. Allowable loans start at \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The maximum number of outstanding loans at any time is one per participant. The loans are secured by the balance in the participant's account and bear interest at prime plus one percent. Loans must be repaid within five years of the date on which the loan's funds are disbursed. If the loan is for the purchase of a principal residence, the repayment term can be up to 30 years. Principal and interest is paid ratably through monthly payroll deductions. For the years ended December 31, 2024 and 2023, there were 13 loans and six loan outstanding, respectively, bearing interest at 4.25% – 9.50%.

Payment of Benefits

On termination of service including death, disability or retirement, a participant may receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. The normal retirement age under the Plan is 59 ½. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Prior to termination of service, participants who have attained age 59 ½ may withdraw all or any portion of the value of salary reduction contributions. Partially vested account balances are not eligible for in-service withdrawals.

Payment of Benefits – (continued)

Participants' benefits are included in deductions from net assets during the period when vested members reach the normal retirement date and are paid, unless the participants continue in service after reaching the normal retirement date and postpone payment of accrued benefits until the deferred retirement date or otherwise terminate employment. Benefit payments commence immediately when participants separate themselves from service.

Following severance of employment, the Company may distribute participant balances less than \$5,000 as soon as administratively feasible.

Hardship Withdrawals

Hardship withdrawals by Plan participants may be made upon written request to, and upon approval of, the Plan Trustees. If approved, the distribution can be made out of the elective deferral, Roth elective deferral and rollover contribution accounts of the participant and shall be limited to the amount of the contributions to such account. No amount of income on such contributions may be withdrawn. All requests must be made in writing. Salary deferral contributions of participants who obtain a hardship withdrawal will be suspended for six months after the hardship withdrawal.

Forfeited Accounts

The forfeiture account is comprised of amounts formerly allocated to individual accounts of participants upon the participant's separation of service. The forfeited amount is the nonvested portion of the employer contribution. These amounts are used to reduce contributions made by the Company or reduce plan or to offset any administrative expenses of the plan. There were no forfeited nonvested accounts for either of the years ended December 31, 2024 and 2023.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make significant estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies using information provided by the investment advisers, custodians, and insurance company. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on participant loans are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expense

Certain expenses of maintaining the Plan are paid by the Plan, including administrative, professional and advisory fees, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued, to determine if they must be reported. Management determined that there were no reportable subsequent events to be disclosed.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Certain Plan investments are managed by RPG Consultants. RPG Consultants is the recordkeeper of the plan and, therefore, these transactions qualify as party-in-interest transactions.

Mid Atlantic Trust Company is the custodian of the plan and plan assets and these transactions qualify as party-in-interest transactions.

Smith Brothers Financial, LLC provides investment advisory services to the Plan and these transactions qualify as party-in-interest transactions.

The Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

The Company performs certain administrative functions on behalf of the Plan, for which no fees are charged.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE F – INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, as of December 31, 2024 and 2023, and interest, dividends and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (the custodian of the Plan).

NOTE G – TAX STATUS

The Plan operates under a volume submitter plan document sponsored by CCH Incorporated DBA FTWilliam Company. The volume submitter plan provider received an advisory letter dated March 31, 2014 from the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by this Plan. The Plan has been amended since receiving the advisory letter, however, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

NOTE H – EXCESS PARTICIPANT CONTRIBUTIONS PAYABLE

The Plan failed its discrimination test for the years ended December 31, 2024 and 2023. Excess contributions amounting to \$20,503 and \$28,926 are recorded as a liability in the accompanying statements of net assets available for benefits for the years ended December 31, 2024 and 2023,

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
