Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of National Trust for Historic Preservation Defined Contribution Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to the Financial Statements

1. Description of the Plan

The following description of the National Trust for Historic Preservation Defined Contribution Pension Plan (the Plan) for the employees of the National Trust for Historic Preservation in the United States and, National Main Street Center, Inc., a nonprofit subsidiary (collectively, the Trust), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Effective November 1, 2024, the NT Green Fund, Inc, the Trust's newly established nonprofit subsidiary, was added to the Plan as a participating employer.

General

The Plan was established by the Trust in 1986 to provide retirement benefits to eligible employees, as described below, on a noncontributory basis. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

The Trust is the administrator of the Plan. State Street Bank and Trust Company (SSB&T) is the trustee and Transamerica Retirement Solutions Corporation (TRSC) is the recordkeeper of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Trust are eligible to enter the Plan upon their date of hire or as soon as administratively feasible except for employees covered by a collective bargaining agreement and leased employees.

Employees are eligible to receive employer contributions upon completion of 1,000 hours of service, or equivalent, during the Plan year and attainment of 21 years of age.

Contributions

Under the Plan, the Trust will contribute, on behalf of each eligible participant, an amount equal to 5% of the participant's compensation for each calendar year. Participant contributions to the Plan are not permitted. To qualify for a contribution, participants must be employed on the last day of the Plan year. Plan participants who are age 55 and older at the time of separation are not required to be employed on the last day of the plan year or meet the 1,000 hours of service requirement to receive a contribution.

Vesting

Participant vesting in account balances is based on years of service. A participant is 20% vested after two years, 50% vested after three years, 75% vested after four years, and 100% vested after five years of credited service. Eligible employees aged 55 and over are 100% vested regardless of years of service.

Participant Accounts

Each participant's account is credited with allocations of the Trust's contribution and Plan earnings and charged with an allocation of Plan administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. Earnings/losses (net of investment expenses) are directly credited to participant accounts based on the participant's actual investment choices or according to the Qualified Default Investment Alternative, an investment used when an employee contributes to the Plan without specifying how the money should be invested. The benefit to which participants are entitled is the vested portion of their accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, participants may choose to receive a 50% joint survivor annuity, a lump-sum distribution, or single life annuity, which are permitted with spousal consent, equal to the value of the participant's vested interest in his or her account. For terminations of service for other reasons, participants with vested balances between \$1,000 and \$7,000, who do not make a timely distribution or direct rollover election, will have their entire vested account balance, including any prior rollover contributions, automatically rolled over to a traditional Individual Retirement Account (IRA) serviced by TRSC. If the vested account balance is \$1,000 or less, and a timely distribution or direct rollover election is not made, the vested account balance will be paid directly to the participant by check as a mandatory distribution, subject to the required 20% Federal withholding and any applicable state tax withholding. Participants with vested balances over \$7,000 may remain in the Plan.

Forfeitures

Forfeitures may be used to offset the Plan's required annual contribution as permitted by the Plan. Forfeitures that were used to offset employer contributions amounted to \$39,000 for the year ended December 31, 2024. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$86,116 and \$44,561, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's direct investment in the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trust determines the Plan's valuation policies utilizing information provided by its investment advisor and custodian. See Note 6 for discussion of fair value measurements.

The Plan's fully benefit-responsive investment contract (see Note 5) is valued at contract value.

Purchases and sales of such investments are recorded on the trade date. Interest income is recorded on the accrual basis and dividend income is recorded as of the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Employer contributions are recorded in the period to which they relate. Contributions from the Trust are funded once per year with payments made to the trustee in the year following the Plan year. Contributions for the year ended December 31, 2024 were made in April 2025.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Trust. Expenses that are paid by the Trust are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Income Tax Status

The Plan uses a volume submitter plan provided by TRSC. The Plan was restated January 1, 2022. The volume submitter plan received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which states that the volume submitter plan, as then designed, satisfies the applicable provisions under Section 401(a) of the Internal Revenue Code (the IRC). The Plan itself has not received a determination letter from the IRS. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress.

4. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by SSB&T, a qualified institution.

5. Guaranteed Interest Contract

The New York Life Guaranteed Interest Account (NYL-GIA) is a fully benefit-responsive fixed annuity contract whose yield is determined by a rate formula detailed by the GIA group annuity contract. Rates are set for each six-month period beginning on January 1 and July 1. During 2024, the rate was 3.0% from January 1, 2024 through June 30, 2024 and 3.25% from July 1, 2024 through December 31, 2024.

Changes in future interest crediting rates will not affect the amount reported on the statements of net assets available for benefits. Contract value is the amount plan sponsors would receive if they were to withdraw or transfer the funds within the Plan prior to their maturity.

As of December 31, 2024 and 2023, credit ratings for New York Life Insurance Company are A++ per A.M. Best and AAA per Fitch Ratings Inc.

Certain events can limit the ability of the Plan to transact at contract value with the issuer. Such events include Plan termination, merger, and layoffs. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants have occurred or are probable of occurring.

Certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: an uncured violation of the Plan's investment guidelines; a breach of material obligation under the contract; a material misrepresentation; or a material amendment to the agreement without the consent of the issuer.

6. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3). The three levels of fair value hierarchy are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

The following methods and assumptions were used to estimate the fair value of each class of financial instruments:

Money market and mutual funds: Valued at the daily closing price as reported by the money market and mutual fund. They are open-end investments that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The money market and mutual funds held by the Plan are deemed to be actively traded (Level 1).

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. Plan Termination

Although it has not expressed any intent to do so, the Trust has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of full or partial termination of the Plan, the Trust will direct the distribution of the assets to participants in a manner that is consistent with the provisions of the Plan and ERISA. Distributions will be made in cash and, if permitted by the Plan, through the purchase of irrevocable nontransferable commitments from Transamerica Financial Life Insurance Company. Except as permitted by IRS regulations, the termination of the Plan shall not result in any reduction of protected benefits. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

8. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by TRSC. Because of this relationship, transactions related to these investments qualify as party-in-interest transactions. Participant loan and distribution processing fees are paid to TRSC by participants. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investments in general are exposed to various risks, such as market, interest rate, credit, and overall market volatility. Due to the level of uncertainty related to changes in interest rate, market volatility and credit risk, it is reasonably possible that changes in these risks could materially affect the fair values of these investments and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

10. Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued. There are no matters requiring disclosures or recognition in the financial statements.
