INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Stead Automotive Group #1 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and **2023**, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and **2023**, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audits.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule included in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The Stead Automotive Group #1 401(k) Plan (the Plan) was established by Walnut Creek Ford, Inc. (the Company), effective April 1, 2007, to provide retirement benefits and tax-deferred savings opportunities to eligible Company employees. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Company has appointed an employee as the Plan trustee. The Plan is administered by a 401(k) Committee, which is comprised of Company employees, and is responsible for selecting investment options offered under the Plan and monitoring investment performance. Through December 31, 2023, United of Omaha Life Insurance Company (Mutual of Omaha) served as the Plan's custodian and record keeper. Effective January 1, 2024, Matrix Trust Company (Matrix) became the Plan's custodian and Ascensus Retirement Services (Ascensus) became the Plan's record keeper. Mutual of Omaha held, invested and reinvested and Matrix holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries.

Eligible Participants:

Employees, as defined by the Plan agreement, who have attained age 20, are eligible to participate after completing three consecutive months of service. The entry date will be on the semi-annual date (the first day of the Plan year and the first day of the seventh month of the Plan year) on or after the day the employee satisfies the eligibility requirements.

Contributions:

Participants may contribute a percentage of their pre-tax or after-tax annual compensation, as defined under the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional catch-up contributions under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

Stead Automotive Group #1 401(k) Plan Notes to Financial Statements

1. Description of the Plan (continued)

Contributions: (continued)

The Company may make discretionary matching and non-elective profit-sharing contributions to the Plan, as determined by the Company's Board of Directors. In 2024, the Company made matching contributions of \$274,120, including a receivable of \$23,503, equal to 3% of each participant's base compensation that a participant contributes to the Plan, not to exceed \$100 per month.

Participant Accounts:

A participant's account comprises a salary deferral account, Company contribution account and, where applicable, a rollover account. Each participant's account is credited with the participant's contributions, Company matching and any non-elective contributions, and earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are fully 100% vested in their contributions plus actual earnings thereon. Vesting in the Company's matching portion of their accounts plus actual earnings thereon is based on years of service. Participants become 50% vested after two years of service and 100% vested after three years of service.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a longer term may be granted. Participant notes are evidenced by a written note, bear a rate of interest equal to the prime rate published by The Wall Street Journal plus 1%, and collateralized by the vested participant account balance. The interest rate on the notes outstanding as of December 31, 2024 range from 4.25% to 9.5%. Repayment of principal and interest is typically made through payroll deductions.

Stead Automotive Group #1 401(k) Plan Notes to Financial Statements

1. Description of the Plan (continued)

Payment of Benefits:

Benefits are recorded when paid. Upon termination, participants may elect to receive an amount equal to the value of their vested account balances. Benefits are paid in a lump sum payment or in installments, if elected by the participants. The Plan may elect to distribute a terminated participant's account without participant consent if the vested balance is \$7,000 or less. Any participant account balance between \$1,001 and \$7,000 distributed without participant consent and before the participant's normal retirement age, as defined by the Plan agreement, will be automatically rolled over to an individual retirement account on behalf of the participant. Benefits are recorded when paid.

Forfeitures:

The non-vested portion of a terminated participant's account balance is retained in the Plan and may first be used to pay Plan administrative expenses, then to reduce future employer contributions. Forfeitures of \$22,259 were used in 2024 to pay Plan administrative expenses and reduce Company contributions. Forfeitures of \$27,886 were available at December 31, 2024 (\$22,020 at December 31, 2023).

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Administrative Expenses:

Several of the investment fund options are subject to fees based on a percentage of invested assets, as disclosed in each fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain administrative costs, as determined by the Company, are charged to the Plan and paid from Plan assets. The Company pays all other expenses related to the Plan, which are not reflected in the Plan's financial statements.

1. Description of the Plan (continued)

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions will be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

Investments consist of common/collective trusts, mutual funds and a guaranteed investment contract at December 31, 2024, and pooled separate accounts and a guaranteed investment contract at December 31, 2023, and are accounted for as follows:

Common/Collective Trusts (CCTs): The Plan invests in fully benefit-responsive investment contracts through the Callan GlidePath Funds offered by Callan LLC (Callan), State Street Funds offered by State Street Bank and Trust Company (State Street), and the Retirement Right Stable Value Fund offered by Hand & Trust Company (collectively, the Funds). The Funds are valued using the NAV practical expedient as reported by Callan and State Street. The NAV practice expedient is based on the fair value of the underlying assets owned by the CCTs, minus their liabilities, and then divided by the number of units outstanding. The NAV practice expedient of the Funds is calculated based on a compilation of primarily observable market information.

Investments: (continued)

Mutual Funds: These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Guaranteed Investment Contract (GIC): The GIC is a benefit-responsive investment contract with Mutual of Omaha. Mutual of Omaha maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Mutual of Omaha is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. Because the GIC is fully benefit-responsive, it is valued using the NAV practical expedient, as valued by Mutual of Omaha. The NAV practical expedient is based on the fair value of the underlying assets of the GIC, minus its liabilities, and then divided by the number of units outstanding. The NAV of a is calculated based on the compilation of primarily observable market information. The GIC does not permit Mutual of Omaha to terminate the agreement prior to the discontinuance date.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the GIC, Mutual of Omaha reserves the right to temporarily delay withdrawal from the GIC in order to ensure the investments liquidated will be carried out in an orderly business manner.

Pooled Separate Accounts: These accounts are separate from Mutual of Omaha's general fund account and consist of shares in various mutual funds. The investment in each separate account is expressed in 'units'. The value of each separate account is recorded at the close of each business day at fair value based on unit value reported by Mutual of Omaha. The 'unit value' is calculated by dividing the value of the entire account by the total number of units in the account. The value of the Plan's investment in each separate account on any date is determined by multiplying the number of units held by the unit value.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds are recorded at fair value and are classified within Level I of the fair value hierarchy at December 31, 2024. The pooled separate accounts are recorded at fair value and classified as Level II within the fair value hierarchy as of December 31, 2024 and 2023. The Funds and the GIC are valued based on the NAV practical expedient and is excluded from the fair value hierarchy under GAAP.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

3. Information Prepared and Certified by the Qualified Institutions

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix and Mutual of Omaha, the qualified institutions of the Plan, have certified to the completeness and accuracy of the:

- investments and non-interest bearing cash reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 **and 2023**.
- net appreciation in fair value of investments and dividends and interest from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan is a prototype plan offered by Ascensus. The Internal Revenue Service (IRS) has determined and informed Ascensus by a letter, dated July 1, 2024, that the plan submitted for review was qualified under applicable provisions of the Code. The Plan and the Plan sponsor believe the Plan is being operated in compliance with the applicable requirements of the Code and related state statutes and is therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan, and has concluded, at December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Plan investments include investments managed by Matrix Trust. As Matrix Trust is the Plan's custodian, purchases and sales of these investments qualify as party-in-interest transactions. Notes receivable transactions with participants also qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

6. Subsequent Events

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
