The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Southwest Health Center, Inc. 403(b) TSA Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan established for a not-for-profit organization, commonly known as a Code Section 403(b) savings plan. Southwest Health Center, Inc. (the "Health Center" or "Employer") is the Plan sponsor and is a not-for-profit corporation as described in Section 501(c)(3) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Upon enrollment in the Plan, participants may direct contributions in any of the applicable investment options available to Plan participants.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date ranging from the date of enactment to 2028 and beyond, with the bulk of the provisions taking effect in 2023 and 2024. In accordance with SECURE 2.0, the Plan increased the age for required minimum distributions (RMD) from age 72 to 73 effective January 2023. Further changes set forth in the SECURE 2.0 Act include eliminating pre-death RMD rules for Roth accounts and several voluntary changes to distribution provisions, effective January 2024. The Plan is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Eligibility

Eligible employees to participate in the Plan include all employees of the Health Center immediately upon being hired, in which the universal availability rules an eligible employee must enter the Plan as soon as administratively feasible following their hire date (no more than 60 days following the date of hire). The Plan auto-enrolls eligible employees at 3% on the first day of the month following two months of service provided the eligible employee does not provide an alternative election. Eligible employees for Health Center matching contributions include all employees over the age of 18 that have also completed six months of service. Eligible employees begin receiving Health Center matching contributions in quarterly entry dates during applicable calendar year following the matching contribution eligibility requirement being met.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Pre-tax and/or Roth contributions are permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Health Center may make discretionary matching contributions. For 2024, the discretionary match amount was 5% of eligible compensation for participants contributing at least 3% of compensation, and meeting the minimum age requirement of 18 and minimum service requirement of 6 consecutive months worked. Participants direct the investment of the employer matching contributions into various investment options offered by the Plan. During the Plan's year end compliance testing, the Health Center may be required to make true-up employer matching contributions for that Plan year subsequent to year end. These amounts are recorded as employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, discretionary matching contribution and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings (losses) thereon. Vesting in the Health Center's discretionary matching contribution plus actual earnings (losses) thereon is based on years of service. Participants vest at a rate of 20% per year beginning with the first year of service. Participants become fully vested after five years of service. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service during the plan year. A participant will also become 100% vested upon death, disability, and attaining the early retirement age.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one loan outstanding at a time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Currently, the Plan administrator's policy to determine the interest rate is 1 percent above the prime rate published by the Wall Street Journal. Loans may not exceed five years in length unless the loan proceeds are to be used for the acquisition of a participant's principal residence, in which case the maximum length is ten years. The notes have maturity dates through August 2030. Principal and interest are paid ratably through payroll deductions. Loans will be considered in default and a deemed distribution in accordance with the Plan administrator's Loan Policy.

Payment of Benefits

On termination of service, if the total vested account balance does not exceed \$7,000, the Plan will initiate an involuntary cash-out. The Plan allows for in-service distributions of fully vested accounts if a participant reaches age 59 1/2 subject to Plan provisions. In addition, hardship distributions are permitted from the participant's elective deferral account.

Forfeitures

Participants who terminate their employment and are less than 100% vested in their Health Center's matching contribution forfeit the non-vested portion upon taking distribution of their account balance. Forfeitures occurring during a Plan year can be used to reduce employer matching contributions or pay plan expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. During the year ended December 31, 2024, the Health Center's matching contributions were reduced by \$29,060 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP, requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimated amounts.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value with the exception of the guaranteed investment contract, which is stated at contract value. See Notes 3 and 4 for discussion of fair value measurements and the guaranteed investment contract, respectively. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Guaranteed investment contracts are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Health Center. Expenses that are paid by the Health Center are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in investment income.

Plan Termination

Although it has not expressed any intent to terminate the Plan, the Health Center has the right under the Plan to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Health Center contributions.

Subsequent Events

The Plan has evaluated subsequent events through October 9, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts: Valued at the daily closing price as reported by the fund. Pooled separate accounts held by the Plan are open-end mutual funds or common stocks that track specific indexes and are registered with the Securities and Exchange Commission. The pooled separate accounts held by the Plan are valued at a unit value which approximates the fair value of the underlying mutual funds which are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Guaranteed Investment Contract

The Plan has a fully benefit-responsive investment contract with Standard Insurance Company (The Standard). Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The fully benefit responsive investment contract is recorded in investments, at contract value on the statements of net assets available for benefits at December 31, 2024 and 2023 totaling \$4,861,520 and \$4,136,542, respectively.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but will never be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Note 4: Guaranteed Investment Contract (Continued)

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments, at fair value and investments, at contract value at December 31, 2024 and 2023 and total investment income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the custodian. The pooled separate accounts are not included in these certifications. Notes receivable from participants at December 31, 2024 and 2023 and interest income on notes receivable from participants for the year ended December 31, 2024 are not included in these certifications.

Note 6: Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for Plan participants. The Plan's management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such persons.

Certain Plan investments were managed by Reliance Trust Company, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees for the investment management services during the Plan year ended December 31, 2024, were offset against earnings. Specific detail for management fees is not available from the custodian.

Other service providers (e.g., brokers) received compensation from the Plan. These providers receive all compensation indirectly from Plan investments and are offset against earnings. The Standard also provides third-party administration services to the Plan, and these expenses incurred to the Standard are recorded as administrative expenses on the statement of changes in net assets available for benefits.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 10: Prohibited Transactions

Under DOL Regulation 2510.3-102, the Plan is required to remit employee contributions to the Plan as soon as they can reasonably be segregated from the Plan's general assets. During the plan year ended December 31, 2024, certain participant contributions totaling \$1,005 were not remitted within this required timeframe and were determined to be late as reported on Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, this transaction constitutes a prohibited transaction under ERISA. Additionally, during the plan year ended December 31, 2023, certain participant contributions totaling \$233 were not remitted into the Plan and have yet to be remitted as of December 31, 2024. Subsequent to December 31, 2024, management is in the process of correcting these items.
