## INDEPENDENT AUDITOR'S REPORT

To the Trustees of  
BLP/ALT Profit Sharing Plan & Trust:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. DESCRIPTION OF PLAN**

The following description of the BLP/ALT Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering substantially all employees of Bonded Lightning Protection Systems, LTD and Advanced Lightning Technology, LTD (collectively the “Company”) who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established on December 31, 1983 and was last amended and restated effective October 21, 2024, to conform to all current ERISA rules and regulations.

**Contributions and Forfeitures** - Eligible employees are entitled to make voluntary pretax and Roth contributions up to the maximum percentage of eligible earnings defined by the Plan and allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct investment of their contributions into various investment options offered by the Plan. The Company may contribute discretionary matching and/or profit-sharing contributions. Only participants who have completed a year of service and are actively employed on the last day of the plan year are eligible to share in employer contributions. Employer contributions are allocated to eligible participant accounts based on the proportion a participant’s total compensation bears to total compensation of all participants for that year.

Employer profit sharing contributions for the year ended December 31, 2024, totaled \$326,605 of which \$326,605 is recorded as employer contributions receivable at the end of the Plan year. The non-vested portions of participant account balances are forfeitable if a participant leaves the Plan and are used to reduce the employer’s matching contributions or pay Plan expenses. Unallocated forfeited non-vested accounts totaled \$17,642 and \$16,901 at December 31, 2024 and 2023, respectively. Forfeitures of \$6,134 were used to pay Plan admin fees during the year ended December 31, 2024.

**Participant Accounts** - Each participant’s account is credited with the participant’s contribution and allocations of (a) the employer’s contribution, (b) plan earnings, and (c) charged with administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

Any participant who attains normal retirement age, becomes disabled, or dies becomes fully vested regardless of length of service and will receive all benefit payments in accordance with distribution provisions of the Plan. Employees' 401(k) and profit-sharing accounts are subject to the restrictions and penalties of the Internal Revenue Code.

**Notes Receivable from Participants** - Notes receivable represent loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. A participant may borrow a minimum of \$1,000 up to a maximum equal to one-half of their vested account balance, but not in excess of \$50,000. Loan terms range from 1-5 years or more if the loan is used to acquire a principle residence. The loans are secured by the balance in the participant's account and bear interest at 5.25 – 10.50 percent, which is commensurate with local prevailing rates. Total notes receivable from participants at December 31, 2024 and 2023 were \$434,969 and \$421,662, respectively. There were \$25,083 loans deemed distributions for the year ended December 31, 2024.

**Payment of Benefits** - Participants who separate from service and whose value of all vested accounts is \$5,000 or less will have the value of their vested accounts distributed to them in a lump sum. If the vested balance is greater than \$5,000, the participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, make a rollover distribution or elect to receive substantially equal installments over a specified period of time. If participants die before receiving a distribution of their accounts, the vested interest of their accounts will be paid to their designated beneficiaries.

**Investment Options** - Upon enrollment in the Plan, a participant may direct contributions among investment choices in increments of one percent. Participants may change their investment options on any normal business day.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The Plan's financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value with the exception of the guaranteed interest account which are stated at contract value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Cash Surrender Value of Life Insurance** - Life insurance contracts held by the Plan are stated at cash surrender value.

**Investment Risk** - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, credit and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

*Use of Estimates* - The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Administrative Expenses* - Plan administrative expenses of \$48,843 were partially offset by forfeitures totaling \$6,134 during the year ended December 31, 2024. Certain administrative expenses are absorbed by the Plan Sponsor at no cost to the Plan.

*Payment of Benefits* - Benefits are recorded when paid.

*Subsequent Events* - Management has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

### 3. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan recordkeeping and investment custodial duties are conducted by Empower Annuity and Insurance Company of America ("Empower"). AXA Equitable Life Insurance Company ("AXA") manages life insurance contracts within the Plan. Certain investment funds and notes receivable from participants are managed by Empower Retirement, and their related entities, and therefore qualify as party-in-interest transactions. As such, all transactions conducted through these entities qualify as party-in-interest transactions.

### 4. FAIR VALUE MEASUREMENTS

Accounting standards establish the framework for measuring fair value. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* – The unit value of the mutual funds account is based upon significant observable inputs, although it is not based upon quoted market prices in an active market. The observable inputs are unadjusted quoted prices for identical assets in an active market, which is defined as a market in which transactions take place with sufficient frequency and volume to provide pricing information on an ongoing basis.

In accordance with the Financial Accounting Standards Board ("FASB") Accounting Standards Codification Subtopic 820-10, the mutual fund accounts held by the Plan are not classified in the fair value hierarchy table because they are measured at net asset value ("NAV") per share. The NAV is used as a practical expedient to estimate fair value as determined by the Plan custodian and is generally based on the value of the underlying mutual funds and other securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024, and 2023. There are no participant redemption restrictions for mutual funds.

## 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time by delivery to the trustees a prior written notice of such termination and is subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

## 6. TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan’s administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The Plan is subject to routine audits by taxing jurisdictions. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

## 7. PLAN ADMINISTRATION

David M. Riley and S. Lynn Riley serve as trustees for the Plan. Empower Annuity and Insurance Company of America serves as plan custodian.

## 8. INFORMATION CERTIFIED BY CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity and Insurance Company of America (the custodian of the Plan) has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown on the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Guaranteed interest account, at contract value as of December 31, 2024, and 2023.
- Net change in fair value of investments, interest and dividend income, and interest income on notes receivable, as shown on the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – schedule of assets (held at end of year) as of December 31, 2024.

Life insurance contracts presented on the statements of net assets available for benefits, totaling \$71,538 and \$69,560 at December 31, 2024 and 2023, respectively, are held by AXA and are not

certified. Procedures performed by the Plan’s independent public accountants have not been limited with respect to these contracts.

**9. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan offers a guaranteed interest account (“GIA”) as an investment option to participants within the Plan. The GIA is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits. The GIA is a stable value investment with a guaranteed rate of return and a guarantee of principal that is backed by the Empower Retirement general investment account. The GIA is provided through a group annuity contract between the Plan and Empower Annuity and Insurance Company of America. Under the contract, a crediting rate is established for a six-month period of time and all assets invested in the GIA are credited with that rate. At the expiration of each rate period, a new crediting rate is declared. Empower Annuity and Insurance Company of America assumes market, credit, and interest rate risks for the assets supporting the GIA.

All bona fide participant-initiated withdrawals from the GIA, including benefit payments at termination or retirement, loans, and transfers to other non-competing investment options, are paid at contract value. Transfers to other fixed income investments are not allowed. Employer-initiated events such as layoffs, a sale of a business unit, a company merger, or a change in the stable value option offered under the Plan are considered market value events and are subject to certain liquidity provisions. The contract value of the GIA was \$127,085 and \$140,384 at December 31, 2024 and 2023, respectively.
