Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Guidehouse Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Note 1 - Plan Description

The following description of Guidehouse Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Substantially all employees of Guidehouse Inc. (the "Company") and certain of its domestic subsidiaries, including project employees and per diem employees who have completed one year of eligible service, are eligible to participate in the Plan provided that they are at least 18 years of age. Effective January 1, 2024, long-term part-time employees who are at least 18 years of age are also eligible to participate in the Plan.

In 2024, amounts totaling \$337,747 were transferred into the Plan from the Guidehouse Managed Services LLC 401(k) Savings Plan and amounts totaling \$475,680 were transferred out of the Plan to the Guidehouse Managed Services LLC 401(k) Savings Plan, a plan sponsored by a subsidiary of the Company. Amounts totaling \$170,761,453 were transferred into the Plan from the Guidehouse Digital LLC 401(k) Savings Plan in connection with the plan merger discussed in Note 7.

Contributions

The Plan provides for employee pretax, Roth 401(k), and/or after-tax contributions up to a combined maximum of 85 percent of each participant's annual eligible compensation, as defined in the plan document. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Contributions are made through payroll deductions and are subject to limitations set by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

For 2024, the Company provided matching contributions of up to 100 percent of the first 3 percent of eligible deferred compensation up to the IRS maximum eligible compensation amount of \$345,000 that a participant contributed to the Plan during the year. Effective January 1, 2024, the Plan was amended to allow discretionary profit-sharing contributions to participants' accounts. Profit-sharing contributions are determined in the sole and exclusive discretion of the board of directors of the Company, and participants must be employed by the Company or an affiliate on the last day of the plan year in order to be eligible to receive a profit-sharing contribution allocation unless such participant terminates during such plan year as a result of death, total and permanent disability, or following the attainment of normal retirement age. No such profit-sharing contributions were made during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, company matching contributions, company profit-sharing contributions, and an allocation of the plan earnings and charged with an allocation of plan losses. Each participant's account is charged a record-keeping fee on a quarterly basis and credited with an allocation of revenue-sharing payments received by the recordkeeper of the Plan. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may direct the investments of their account balances into various investment options offered by the Plan. In addition, the Plan offers participants a self-directed brokerage option, which gives participants access to individual stocks, bonds, and other mutual funds.

Vesting

Participants are immediately vested in their participant contributions, the Company's matching contributions, and company profit-sharing contributions plus actual earnings thereon.

Note 1 - Plan Description (Continued)

Benefit Payments

Distributions are payable upon retirement, death, long-term disability, or termination of employment in the form of a lump-sum amount or in various installment annuities. Hardship distributions are also permitted if certain criteria are met.

Participant Notes Receivable

Participants may borrow from their vested accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. No more than two loans may be outstanding under the Plan at any one time. Loans will be charged the prime interest rate plus 1 percent and must be repaid ratably through payroll deductions within five years unless used to purchase the participant's principal residence.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, the trustee would distribute to each participant the value of his or her account, as determined by the terms of the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

The fully benefit-responsive unallocated contract is valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are reported at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative Expenses

All administrative costs are paid by the Plan, unless paid by the Company or the participant. All record-keeping expenses are paid by the participants through an allocation of such expenses to their respective accounts.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 24, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Accordingly, no provision for income taxes has been made in the accompanying financial statements.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 5 - Fair Value Measurements (Continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value (NAV) per share (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Self-directed Brokerage Account Investments

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage account investments include various investments in publicly traded securities, which are valued at the quoted prices reported in active markets. The self-directed brokerage account investments also include certificates of deposit and interest-bearing cash, which are valued based on their outstanding balances and bonds, which are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models (these models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures).

Note 6 - Investment Contract

The Plan has a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). In conjunction with the plan merger discussed in Note 7, the benefit-responsive investment contract's servicing was transferred into the Plan as a closed investment option from the Guidehouse Digital LLC 401(k) Savings Plan whereby no further participant contributions or investment transfers are permitted to or from the contract subsequent to the merger. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.0 percent. When establishing interest crediting rates for this product, Voya considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Note 6 - Investment Contract (Continued)

Generally, there are limited circumstances that could limit the ability of the Plan to transact at contract value. The Company does not believe events that allow the issuer to terminate the contract and require the plan sponsor to settle an amount different than contract value are probable. Further, the plan merger had no impact on the benefit-responsiveness of the contract.

Note 7 - Plan Merger

Effective January 2, 2024, the Guidehouse Digital LLC 401(k) Savings Plan was merged with the Plan. Accordingly, assets of approximately \$171 million were transferred into the Plan in 2024.
