For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The following description of the Omni Glass & Paint, LLC 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined contribution plan covering substantially all nonunion employees of Omni Glass & Paint, LLC (Company) and is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended (ERISA). The Company's Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective March 1, 2023, all full-time employees who are age 18 or older who are not covered under collective bargaining agreements are eligible to participate in salary deferrals on the 1st of the month following three months of employment. Prior to this date, the age requirement was 21 years of age. Part-time employees must be credited with 1,000 hours of service in a 12-month period in order to participate in the Plan. Eligible employees are automatically enrolled in the Plan. Employees are eligible to receive discretionary company contributions provided they have completed 1,000 hours of service during the Plan year and are still employed by the Company at year-end. Matrix Trust Company is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to make annual contributions of up to 75% of eligible compensation and limited to the amount allowed by the Internal Revenue Code. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Company matching and nonelective contributions are discretionary as determined by the Company's Board of Directors. For 2024 and 2023, the matching contribution was 30% on the first 7.5% of compensation and the nonelective contribution was 3% of eligible compensation. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation upon entry date unless the participant made an affirmative election otherwise. There is an automatic 1% increase annually, which culminated at 6% of eligible compensation prior to a March 2023 Plan amendment. Effective March 1, 2023, the automatic 1% annual increase is capped at 8% of eligible compensation.

Participant Investment Account Options

Investment account options available include various funds. Upon enrollment in the Plan, a participant may direct company match, company nonelective and participant contributions to any combination of available investment options. Each participant has the option of directing his contributions into any of the separate investment accounts, or self-directed accounts, and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled are the benefits that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The nonvested balance is forfeited upon termination of service.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement or termination of employment, as defined in the Plan Document. The Plan provides for normal retirement at age 65. Upon termination of service, a participant may elect to receive or defer a lump-sum amount equal to the value of his account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump-sum payment or partial distribution if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the participant will receive an involuntary elected by the participant. Vested balances less than \$1,000 will be paid out as an involuntary cashout distribution only in a single lump-sum payment to the participant. Participants experiencing financial hardship may withdraw a portion of this account balance as defined in the Plan.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$18,200 and \$19,100, respectively. These accounts will be used to reduce future Company contributions. Also, in 2024 and 2023, Company contributions were reduced by approximately \$20,700 and \$22,400, respectively, from forfeited nonvested accounts.

Notes Receivable From Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Quoted market prices, if available, are used to value investments. The Plan's mutual fund investments and money market funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Tax Status

The Plan is a prototype nonstandardized plan document sponsored by OneAmerica Financial Partners, Inc. The prototype Plan has received an opinion letter from the Internal Revenue Service (IRS) as to the prototype plan's qualified status. The prototype opinion letter has been relied on by the Plan. The Plan has been amended since the prototype plan received the opinion letter; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue has been included in the Plan's financial statements. Therefore, no provision for income taxes has been included in the Plan's financial statement.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities held by the Plan include mutual funds and money market funds and all self-directed accounts. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. The common collective trust fund held by the plan was determined to be a Level 2 security. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 investments held in the Plan.

The common collective trust fund is valued at the NAV of units of a bank common trust. The NAV, as provided by the trustee, is used to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust, the investment advisor reserves the right to temporarily delay withdrawal from the trusts in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan paid approximately \$42,700 and \$36,600 in recordkeeping fees to OneAmerica Retirement Services during the years ended December 31, 2024 and 2023, respectively. Additionally, the Plan paid approximately \$36,100 and \$30,500 in investment advisory fees to Northstar Asset Management during the years ended December 31, 2024 and 2023, respectively.

The Company provides certain administrative services at no cost to the Plan.

Note 6. Nonexempt Transactions

Defined-contributions plans are required to remit employee contributions and loan repayments to the Plan as soon as they can be reasonably segregated from the employer's general assets. While the Company remitted all employee contributions and loan repayments to the Plan, contributions and loan repayments of \$18,964 were not remitted within the required time period for the year ended December 31, 2024. The lost earnings were deposited into the Plan in 2025.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Subsequent Events

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
