## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following brief description of the Stark Tech 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan with salary reduction features as permitted under Section 401(k) of the Internal Revenue Code (IRC), covering eligible employees of Stark Tech Operating Company, LLC (the Plan Sponsor). The Plan includes eligible employees of other employers (Buckpitt & Co., Inc.; Stark Intelligence, LLC; Stark Commodity Advisors, LLC; R.L. Kistler, Inc.; U&S Services, Inc.; MC2, Inc.; PRES Services, LLC; Shaw Mechanical Services, Inc.; TP Woodside, Inc.; Quality Plus, Inc.; Technical Building Services, Inc.; and Antares Group Incorporated – collectively, with Stark Tech Operating Company, LLC, referred to as "the Company") that are affiliated through common ownership that have elected to participate in the Plan. The adoption agreement was amended to consider service with the predecessor employers for purposes of determining eligibility, vesting and allocation conditions under the Plan. The Plan is funded by employee and employer contributions. A portion of administrative expenses may be paid by the Plan. Administrative expenses not paid by the Plan are paid by the Plan Sponsor. At December 31, 2024 and 2023, the assets of the Plan were maintained in investment funds held by Capital Bank and Trust Company, the trustee of the Plan. The Plan is intended to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable.

During the year ended December 31, 2023, the Antares Group Incorporated adopted the Plan and all assets from their previously sponsored retirement plans were transferred into the Plan.

#### **Eligibility**

Employees of the Company are eligible to participate in the Plan upon attaining age 21.

#### **Contributions**

Participants may authorize an elective deferral contribution up to the maximum annual limitations as provided by the IRC. Participants who are age 50 or older before the end of the plan year are allowed to make an additional "catch-up" contribution. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may also designate all or a portion of their salary deferral as Roth deferrals, subject to immediate taxation and maintained by the Plan in a separate Roth deferral account. The Company provides a matching employer contribution, where the employer will determine how much, if any, it will make as a matching contribution as defined by the Plan document. An employee must complete 3 months of service to be eligible for the employer match. The Company may also make discretionary contributions to the Plan as defined by the Plan document. To be eligible to receive an allocation of the employer discretionary contribution, an employee must have completed 1 year of service and be employed on the last day of the plan year or have completed 500 hours during the plan year.

## 1. DESCRIPTION OF PLAN (Continued)

### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of plan investment earnings (losses), and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. If the participant elects to keep his or her interest in the Plan after termination of employment, the participant's account will continue to receive its share of earnings or losses.

### **Investments**

Participants direct the investment of employee and employer contributions into various investment options offered by the Plan. Participants may change their investment allocation on a daily basis.

### **Vesting**

All Participants who are employed with the Company as of or after January 1, 2021 are 100% vested in all contributions at all times.

For those Participants who terminated employment prior to January 1, 2021, employer and matching contributions vest under a 6-year graded vesting schedule. The schedule is summarized as follows:

*After 2 Years of Service – 20% vesting*

*After 3 Years of Service – 40% vesting*

*After 4 Years of Service – 60% vesting*

*After 5 Years of Service – 80% vesting*

*After 6 Years of Service – 100% vesting*

In the event of death, disability, or attainment of early retirement age, the employee's vesting percentage increases to 100%.

Forfeitures of unvested Company contributions are retained by the Plan, rather than returned to the Company, and will be used as a credit to reduce future Company contributions or used to pay fees. At December 31, 2024 and 2023, there were \$46,660 and \$53,281 of forfeited funds on hand, respectively. In 2024 and 2023, no forfeitures were used to pay Company contributions.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at the prime interest rate plus two percentage points. Principal and interest are paid ratably through payroll deductions. Participants may have two loans outstanding at any time.

### **Withdrawals and Distributions**

Participants may receive their accumulated vested benefits held by the Plan's trustee upon termination of employment or elect to keep their vested balance in the Plan until the earlier of normal retirement age, death, or disability if their account balance is in excess of \$5,000. Upon termination of service due to retirement, death, or disability, a participant will receive an involuntary lump-sum cash-out distribution equal to the value of their account if the total vested account balance does not exceed \$5,000. If the total vested account balance exceeds \$5,000, a participant may elect installment distributions or a lump sum payment.

Hardship distributions may be taken from a participant's contribution, subject to certain limitations. In-service distributions of employee vested account balances are allowed upon attainment of age 59-1/2.

## 1. DESCRIPTION OF PLAN (Continued)

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting and presents the net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. It is at least reasonably possible that the significant estimates used will change within the next year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Risks and Uncertainties**

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan Document.

### **Administrative Expenses**

Investment fees are paid by the Plan. Other administrative expenses not paid by the Plan are paid by the Plan Sponsor.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Income Taxes**

The Plan uses a prototype plan document sponsored by Actuarial Consulting Service, Inc. Actuarial Consulting Services, Inc. received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

**3. FINANCIAL CERTIFICATION**

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Capital Bank and Trust Company, the trustee of the Plan, and has been certified by them as complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

The Plan uses various valuation techniques in determining fair value. FASB ASC Topic 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in valuation methodologies in 2024 or 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Values are determined based on quoted market prices in active markets.

*Stable value funds:* Valued at Net Asset Value ("NAV") as a practical expedient based on the underlying assets of the fund. The fund is designed to be a Stable Value fund seeking a reasonable level of income with stability of principal. The fund seeks to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The Fund invests entirely in the MetLife Group Annuity Contract 25053 which consists of separately managed investment portfolios directed by Reliance Trust Company. NAV is obtained from information provided by the investment advisor using the audited financial statements of the common collective trust funds at year end. There are no unfunded commitments or redemption restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

**5. PARTY-IN-INTEREST TRANSACTIONS**

Empower Institutional is the recordkeeper of the Plan and Capital Bank and Trust Company is the trustee of the Plan. The Plan has investment options managed by American Funds which is affiliated with Capital Bank and Trust Company. Therefore, any transactions with these parties qualify as party-in-interest which are exempt from the prohibited transaction rules.

Notes receivable from participants of \$708,025 and \$584,051 as of December 31, 2024 and 2023, respectively, with interest rates ranging from 4.25% - 10.50% and various maturity dates through 2032, also qualify as party-in-interest which are exempt from the prohibited transaction rules.

**6. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
