**Note 1: Description of Plan**

The following description of the Karpinski Engineering, Inc. Employees' Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement and its amendments for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all full-time and part-time employees of Karpinski Engineering, Inc. (the "Company"). Full-time employees are eligible to participate in the plan on the first day of each plan quarter coincident upon reaching the age of twenty-one and completing two months of eligibility service. Part-time employees are eligible to participate in the plan on the first day of each plan year and the first day of the fourth, seventh and tenth months of each plan year immediately following his or her twelve month anniversary date and upon reaching the age of twenty-one and completing 1,000 hours of service. The Plan is a single employer plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator and Board of Trustees oversee the governance of the Plan.

In accordance with the Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019 those long-term part-time employees who have worked 500 or more hours consecutively, for the years 2021 to 2023, became eligible to participate in the Plan beginning January 1, 2024.

Effective for plan years beginning January 1, 2025, the SECURE 2.0 Act reduced the service requirement for those long-term part-time employees who have worked 500 or more hours from three years to two years.

*Contributions*

Each year, participants may elect to defer a percentage of their compensation up to the maximum amount allowable under Code Section 402(g) and 415 of the Internal Revenue Code, as defined in the Plan. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). Rollovers totaled \$-0- and \$282,154 for the years ended December 31, 2024 and 2023, respectively. Participants direct the investment of all contributions into various investment options offered by the Plan. The Company may make discretionary matching employer contributions on behalf of each participant. The Company elected to make matching employer contributions of \$171,877 and \$167,317 for the years ending December 31, 2024 and 2023, respectively. The Company also has the option of making an additional discretionary profit sharing contribution. The Company elected to make a profit sharing contribution of \$200,000 and \$300,000 for the Plan years ending December 31, 2024 and 2023, respectively, and is included in receivables - profit sharing on the accompanying statements of net assets available for benefits.

*Participant Accounts*

Each participant's account is credited with the participant's contributions as well as allocations of the Plan sponsor's matching and discretionary profit sharing contributions along with Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after 5 years of service. In addition, participants are 100% vested upon normal retirement age, death, or the date they become disabled, as defined in the Plan.

The graduated vesting schedule with respect to the Company's matching and profit sharing contributions are as follows:

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest of their account balance. Loan repayment terms may not exceed 5 years. However, loans used for the purchase of a primary residence may not exceed 10 years. A participant may only have one loan outstanding at a time with repayments made on a monthly basis through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.75% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator. As of December 31, 2024 and 2023, the interest rate charged on outstanding loans was the prime rate plus 1.0%.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive a partial or lump-sum distribution equal to the value of the participant's vested interest of his or her account. Benefits will be automatically distributed if his or her account balance is \$1,000 or less. Distributions greater than \$1,000 and less than \$7,000 are automatically converted to an IRA. All distributions in excess of \$7,000 require participant consent. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account in a lump-sum distribution.

The Plan allows for hardship withdrawals from a participant's elective deferral account and his or her vested interest in the matching and discretionary profit sharing contribution accounts. The Plan also allows for in service withdrawals from a participant's elective deferral account as well as his or her vested interest in the matching and discretionary contribution accounts upon attaining the age of 59 1/2 and after 60 months of participation in the Plan.

Benefits are recorded when paid.

**Plan Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Audit and legal fees of the Plan are paid by the Company.

**Forfeitures**

Forfeited balances of non-vested accounts are first used to reduce Company contributions and second to pay reasonable Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,371 and \$2,118, respectively. These accounts will be used to reduce future employer discretionary and profit sharing contributions. Also, in 2024 and 2023, employer profit sharing contributions were reduced by \$4,688 and \$1,500, respectively, from forfeited non-vested accounts.

**Note 2: Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a settlement date basis. Interest and dividends are recorded on a cash basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account. Delinquent participant loans are reclassified as distributions based on the terms outlined in the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Notes receivable as of December 31, 2024 and 2023, were \$72,870 and \$67,699, respectively.

**Date of Management's Review of Subsequent Events**

Subsequent events have been evaluated by management through October 3, 2025, which is the date the financial statements were available to be issued.

**Note 3: Fair Value Measurements**

As previously mentioned, the Plan's investments are reported at fair value on the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

**Level 1 Fair Value Measurements:**

The Plan's Level 1 investment assets consist of mutual funds. Mutual funds are valued at the daily closing price as reported by the funds. The mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the plan are deemed to be actively traded.

**Level 2 Fair Value Measurements:**

There were no Level 2 assets held by the Plan at December 31, 2024 and 2023.

**Level 3 Fair Value Measurements:**

There were no Level 3 assets held by the Plan at December 31, 2024 and 2023.

The Morley Stable Value Fund is a collective investment trust that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value (NAV) of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell for an amount different from the reported NAV. Participant transactions may occur daily. If the Plan initiates full redemption of the collective trust, the issuer reserves the right to require twelve months notification in order to ensure that security liquidations will be carried out in an orderly manner.

**Note 4: Information Certified by the Custodian**

In accordance with 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected to restrict the scope of the auditor's examination. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments, dividends, and interest income for the years ended December 31, 2024 and 2023, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Charles Schwab Trust Bank, the custodian. Auditing procedures have not been performed on this information except to compare such information to the information included in the accompanying financial statements.

**Note 5: Party-In-Interest Transactions**

At December 31, 2024 and 2023, there were no Party-In-Interest transactions with respect to the investments held by the Plan. Investment management and advisory, and recordkeeping services are paid by the Plan and totaled \$79,945 and \$68,429 for the years ended December 31, 2024 and 2023, respectively. Participant loans are disclosed in Note 2.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7: Tax Status**

The Internal Revenue Service has determined by a letter dated September 21, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the determination date, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, with the related trust being tax-exempt.

**Note 7: Tax Status - Continued**

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

The Plan Administrator believes the Plan is no longer subject to income tax examinations for the years prior to 2021.

**Note 8: Plan Amendments**

The Plan was amended during 2024 to provide automatic enrollment into the Plan effective January 1, 2025 for new participants or terminated employees who are rehired. The Plan will automatically withhold 3% ("default percentage") of eligible compensation unless otherwise elected by the participant. The default percentage will increase by 1% each January 1<sup>st</sup> until it reaches 7% of eligible compensation.

There were no plan amendments during 2023.

**Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

FASB ASC 275, *Risks and Uncertainties*, requires disclosures that focus primarily on risks and uncertainties that could significantly affect the amounts reported in the financial statements in the near term or the near-term functioning of the reporting entity. The risks and uncertainties addressed can stem from the nature of an entity's operations, the use of significant estimates, and current vulnerabilities due to certain concentrations.
