Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Ghafari Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Ghafari Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiple-employer defined contribution plan covering substantially all employees of Ghafari Associates, L.L.C. (the "Plan Sponsor" or Ghafari), except nonresident aliens with no income from a U.S. source. The Plan covered substantially all employees of GT Legacy Holdings, Inc. (f/k/a G-TECH Services, Inc. dba G-TECH Professional Staffing, Inc.) (G-TECH), except nonresident aliens with no income from a U.S. source through July 22, 2024. Ghafari and G-TECH are collectively referred to herein as the "Companies." The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended to exclude employees of non-U.S. subsidiaries or branches of the Plan Sponsor from participating in the Plan.

Participants are permitted to invest in one or more of the investment options offered pursuant to the provisions of the Plan, including an option to invest in the Fidelity Management Trust Company BrokerageLink brokerage account, a self-directed brokerage account. Fidelity Management Trust Company's BrokerageLink brokerage account allows participants to invest their balances in a wide range of publicly traded investments beyond those available in the core investments of the Plan.

Contributions

Participants may make contributions to the Plan in the form of a rollover of funds from another qualified plan. Participants may contribute pre- and post-tax dollars up to a maximum of 50 percent of eligible compensation subject to maximum limitations established by the Internal Revenue Code (IRC). A participant who is eligible to make catch-up contributions under the IRC may contribute pre- and post-tax dollars up to 100 percent of eligible compensation subject to maximum limitations established by the IRC. The Plan auto-enrolls certain new participants at a 5 percent deferral rate that escalates by 1 percent each year on June 1 until the participant's deferral rate reaches 10 percent.

The Companies may make discretionary matching contributions equal to a specified percentage of each participant's deferred compensation. The exact percentage, if any, is determined each year by the Companies. Participants must be employed on the last day of the plan year in order to receive a matching contribution. The Companies awarded discretionary matching contributions of \$1,328,517 and \$1,375,933 to eligible participants related to the plan years ended December 31, 2024 and 2023, respectively. The discretionary matching contributions are funded to the Plan the following calendar year.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Companies' contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Companies 20 percent after two years of service and an additional 20 percent per year thereafter until they become fully vested after six years of service.

Note 1 - Plan Description (Continued)

Effective July 22, 2024, G-TECH, a participating employer of the Plan, was sold to an unrelated third party. The sale caused a partial termination of the Plan. As a result, the unvested funds in the affected participants' accounts became 100 percent vested and are not subject to forfeiture. Participants employed by Ghafari at December 31, 2024 remain subject to the Plan's vesting requirements.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document, or upon reaching the age of 59½. The plan administrator must approve any such hardship withdrawals.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances available to reduce future company contributions totaled approximately \$33,400 and \$18,800, respectively.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

Termination

While they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the trustee shall distribute all assets remaining in the Plan, after payment of any expenses properly chargeable against the Plan, to the participants in accordance with the value of the units credited to such participants as of the date of such termination. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded mutual funds and common stock. Interest-bearing cash is valued at fair value based on its outstanding balance. The common/collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying assets. All other investments are valued based on quoted market prices. See Note 4 for additional information.

Note 2 - Summary of Significant Accounting Policies (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain administrative costs are paid by the Companies.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 7, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 4 - Fair Value Measurements (Continued)

Level 1

The fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
