### Report on the Audit of the Financial Statements

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Pension Plan of Danville Metal Stamping Co., Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Pension Plan of Danville Metal Stamping Co., Inc., and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. As discussed in Notes 1, 2, and 6 to the financial statements, the Board of Directors authorized the termination of the plan, and plan management determined liquidation is imminent during 2023. In accordance with accounting principles generally accepted in the United States of America, the plan is presenting the 2024 and 2023 financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Pension Plan of Danville Metal Stamping Co., Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a noncontributory defined benefit pension plan established September 1, 1969. The Plan was amended and restated throughout the years to comply with tax legislation and was most recently amended effective March 31, 2023.

Effective September 30, 2017, the Plan was amended to be closed to new participants, to remove Plan disability benefits in the case of disabilities occurring after that date, and to freeze the Plan benefits at the accumulated benefits amount as of that date.

The Plan is administered by the Danville Metal Stamping Co., Inc. (the Company) Benefits Committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

The Plan covered substantially all employees of the Company who had reached the age of 20½. The Plan excluded leased employees and employees covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Termination**

In 2022, the Board of Directors approved to amend and terminate the Plan effective March 31, 2023 (see Note 6). As part of the plan for liquidation, the Plan was amended to allow for a lump sum distribution or purchase of an annuity. The Plan administrator notified eligible participants of their options, subject to amended provisions. Management deemed liquidation to be imminent as of December 31, 2023 as distributions commenced under the plan of liquidation.

In December 2023, \$12,699,378 in lump sum payments were paid out to participants who elected this option.

The Plan signed an agreement dated February 13, 2024 with Principal Life Insurance Company (Principal) to annuitize the remaining accumulated plan benefits and transfer liability to Principal effective February 16, 2024, with a benefit commencement date of May 1, 2024. Net premiums paid to Principal for the annuity contract totaled \$23,825,914 during the year ended December 31, 2024.

**Plan Termination (Continued)**

On December 12, 2024, the Plan transferred funds in the amount of \$950,000 to the Danville Metal Stamping Company, Inc. Employees Savings Plan, which is an affiliated defined contribution plan sponsored by the Company. As part of the plan of liquidation, the Danville Metal Stamping Company, Inc. Employees Savings Plan was designated as a qualified replacement plan as defined under IRS Code Section 4980(d)(2). The funds received by the Danville Metal Stamping Company, Inc. Employees Savings Plan will be allocated ratably to participants in that plan for a period not to exceed seven years beginning in 2025 as determined by management.

On December 19, 2024, the Plan transferred \$2,883,010 to the Company, which represented the assets remaining in the Plan as of that date. The reversion of remaining Plan assets was subject to applicable excise taxes to be paid by the Company. As of December 31, 2024, the Plan had completed its plan of liquidation and was fully terminated.

**Pension Benefits**

Employees with five or more years of service are entitled to annual pension benefits beginning at normal retirement age (65) equal to 7/8% of their average annual compensation for each year of service, subject to limits as defined in the Plan. Average annual compensation is based on the highest annual compensation for any five consecutive Plan years out of the last 10 completed Plan years of employment prior to September 30, 2017.

The Plan permits early retirement at ages 55-64 after completing 10 years of service. If employees terminate before rendering five years of service, they forfeit the right to receive their accumulated plan benefits. Employees entitled to a retirement benefit may elect the normal form of pension payment which is a life annuity with 120 months guaranteed or, in lieu of the normal form, an employee may elect a life annuity with only 60 months guaranteed, or a 100%, 75%, 66-2/3%, or 50% Joint and Survivor Annuity. If the nonforfeited accrued benefit is less than \$5,000, the Plan administrator may pay the benefit in a lump sum distribution.

At the discretion of the Committee, the Plan can allow participants to take a lump sum distribution if the nonforfeited accrued benefit is less than \$50,000 for a certain period of time. There were \$5,565 and \$12,699,378 of lump sum distribution offerings made during the years ended December 31, 2024 and 2023, respectively.

**Death and Disability Benefits**

Active employees completing 10 years of service who become totally disabled prior to September 30, 2017 receive annual disability benefits that are equal to the accrued normal benefit. Disability payments are made until the disabled employee reaches age 65 at which time retirement benefits become available to that employee under the terms of the Plan.

**Death and Disability Benefits (Continued)**

If an active employee dies at age 55 or older, a death benefit, equal to the beneficiary's portion of the 50% Joint and Survivor Annuity the employee would have been eligible to receive had he retired, is paid to the employee's spouse provided they have been married for at least one year. If an active employee age 60 or older dies with 20 years of vesting service, a surviving spouse would receive an amount equal to the 100% Joint and Survivor annuity. These payments are made for the life of the surviving spouse with 120 months guaranteed.

**Funding Policy**

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During the years ended December 31, 2024 and 2023, the Company made no contributions. The Company's contributions for 2024 and 2023 met the minimum funding requirements of ERISA.

The Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to provisions set forth in ERISA (see Note 6).

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

As a result of the Plan termination effective March 31, 2023, Plan management determined liquidation of the Plan is imminent during 2023 when distributions under the plan of liquidation commenced. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting to the liquidation basis used in presenting the 2024 and 2023 financial statements.

Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. As of December 31, 2023, the Plan accrued costs of \$113,314 expected to be incurred, and accrued investment losses of \$661,591 expected to be recognized, through the end of its liquidation as there is a reasonable basis for estimation.

**Use of Estimates in Preparing Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, and the actuarial present value of accumulated plan benefits at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

The Plan's expenses are paid either by the Plan or the Company as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

**NOTE 3 ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to:

- a. retired or terminated employees or their beneficiaries,
- b. beneficiaries of employees who have died, and
- c. present employees or their beneficiaries.

Benefits under the Plan are accumulated based on the employees' highest five consecutive complete credited years of compensation out of the last 10 latest years prior to the sooner of September 30, 2017, or their normal retirement date. The accumulated plan benefits for active employees are based on their highest five consecutive complete credited years of compensation ending on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances – retirement, death, and termination of employment - are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided through annuity contracts are excluded from plan assets and are also excluded from accumulated plan benefits.

The actuarial present value of accumulated plan benefits is determined by an independent actuary and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of December 31, 2023 were:

- a. Life expectancy of Participants (amount-weighted aggregate rates from the PRI-2012 mortality study projected generationally from 2012 with scale MP-2021, with contingent survivor rates for survivors)
- b. Retirement Age Assumptions (Normal retirement age of 65 years; other active participants will elect early retirement from ages 55 to 64)
- c. Investment Return: 4.77 – 4.81%

In 2022, the Board of Directors approved to amend and terminate the Plan effective March 31, 2023. The foregoing actuarial assumptions were calculated on the termination basis.

Subsequent to the benefit information date, the Plan satisfied all obligations by distribution of benefits to participants or transfer to an insurance carrier.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuations been performed as of December 31, 2023 there would be no material differences.

**NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION**

Old National Wealth Management, the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information, including pending trades, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 5 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at a dollar per share.

**NOTE 6 PLAN TERMINATION**

**Election to Terminate Plan**

The Company signed a formal resolution dated November 23, 2022 to terminate the Plan effective March 31, 2023. As of the effective date of termination, all participants became fully vested and the net assets of the Plan were allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. governmental agency) up to the applicable limitations.
3. All other vested benefits (that is, vested benefits not insured by the PBGC).
4. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC as of the effective date of Plan termination. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. That ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or Plan termination (whichever comes later). For younger annuitants, or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward.

Benefit improvements attributable to Plan amendments may not be fully guaranteed if the effective date of Plan termination is within five years of the Plan amendment. After the first year, the PBGC would guarantee 20% of any benefit improvements that resulted in benefits below the ceiling, with an additional 20% guaranteed each year the Plan continued beyond the Plan amendment date. If the amount of the benefit increase below the ceiling is also less than \$100, \$20 of the increase (rather than 20%) becomes guaranteed by the PBGC each year following the effective date of the amendment. As a result, only the primary ceiling would be applicable after five years.

The Plan was fully funded therefore participants received 100% of their beneficial interest or was transferred to an insurance carrier to commence payments upon retirement.

**NOTE 7 PLAN TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 21, 2015, that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 9 PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Old National Bank dba: Old National Wealth Management (ONB). ONB is the trustee as defined by the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. The Plan paid or accrued administrative expenses to ONB totaling \$12,432 and \$48,754 for the years ended December 31, 2024 and 2023, respectively.
