Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Nickles Bakery Employees' 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of the Nickles Bakery Employees' 401(k) Plan ("Plan"), formerly known as Nickles Bakeries Employees' 401(k) Plan, provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all qualifying employees of Alfred Nickles Bakery, Inc. (Company and plan administrator). All employees are deemed to be participants in the Plan on the earlier of the first day of the Plan year, or the first day of the seventh month of the Plan year, after completing one year of service and reaching age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions:

Participant contributions are voluntary. Contributions of earned compensation may be tax deferred up to a maximum dollar amount as established by the Internal Revenue Service. The Company may make discretionary matching contributions. The Company may also make a discretionary "safe harbor" contribution and a discretionary profit-sharing contribution. Such contributions are determined by the Company's Board of Directors. For the year ended December 31, 2024, the Company matched 50% of the first 6% of participant contributions as well as making a 3% "safe harbor" contribution and a 1% profit-sharing contribution. The 1% profit-sharing contribution totaled \$68,597. For the year ended December 31, 2023, the Company matched 50% of the first 6% of participant contributions as well as making a 3% "safe harbor" contribution and a 1% profit-sharing contribution. The 1% profit-sharing contribution totaled \$64,348. The Company's "safe harbor" contribution and profit-sharing contribution are allocated to each participant's account based on compensation.

Participant Accounts:

An account is maintained in the name of each participant. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account for which the participant is vested.

Vesting:

Each participant is fully vested with respect to his or her contributions and Company "safe harbor" contributions and related income allocated to his or her account. Other employer contributions vest with the participant as of the earlier of the date the participant completes six years of service (20% per year after the first year) or reaches age 65. Participants may not withdraw their balances prior to reaching age 59½ except for reasons of financial hardship, retirement, disability, death or termination of employment.

Forfeitures:

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The amount of forfeited, nonvested accounts was not material during the years ended December 31, 2024 and 2023.

Investment Options:

Upon enrollment in the Plan, a participant may direct employer and employee contributions in any percentage increments in any of the available investment options.

Participants may change their investment options at any time.

Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable are treated as a transfer from (to) the investment fund to (from) the loan fund. Notes receivable terms range from 1-5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. Notes receivable are valued at their outstanding balance.

Payment of Benefits:

On termination of service, death, disability or retirement, a participant may receive a lump-sum amount equal to the vested amount of his or her account or elect to receive annual installments over a period of time specified in the Plan Agreement.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Note 2. Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefit Payments:

Benefit payments are recorded when paid.

Administrative Expenses:

Administrative expenses of the Plan are paid by the Plan or the Company, at the option of the Company.

Subsequent Events:

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Note 3. Unaudited Information

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, management received a certification from Empower Annuity Insurance Company of America, the Custodian of the Plan, acknowledging the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the related investment activity reflected in the statements of changes in net assets available for benefits for the years then ended, the supplemental schedule as of December 31, 2024 and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in Company contributions and will receive a distribution of the balance in their account in accordance with the terms of the Plan.

Note 5. Income Tax Status

The Plan utilizes a Volume Submitter Plan Document offered by the third party administrator. The Internal Revenue Service has informed the third party administrator by a letter dated June 30, 2020, that the form of the Plan is acceptable under applicable sections of the Internal Revenue Code ("IRC"). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Company is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

Note 6. Risks and Uncertainties

The Plan holds various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Party-in-Interest

The investments held by the Plan are offered by Empower Annuity Insurance Company of America, the Custodian of the Plan. As such, these investments and the related transactions qualify as party-in-interest transactions.

Note 8. Fair Value Measurements

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. Fair value is defined as the price that would be received to sell an asset or would be paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs used to measure fair value are classified into three levels:

- Level 1 – Quoted market prices in active markets for identical assets and liabilities

- Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data
- Level 3 – Unobservable inputs in which little or no market data exists

The following is a description of the valuation methodologies used for assets of the Plan measured at fair value at December 31, 2024 and 2023.

Guaranteed investment contracts, which are not fully benefit responsive, are stated at fair value as estimated by Empower Annuity Insurance Company of America, based upon the fair value of the underlying assets. The values are reported daily based on the valuation method disclosed in the contract, as calculated by the Custodian. Based on the terms of the contract, fair value equals contract value, and these contracts are considered to be Level 2 assets.

Common collective trusts are valued based on their reported net asset value (NAV). The NAV is based primarily on observable inputs and the market value of the underlying investments and is classified as Level 2.

Mutual funds are valued at the fair value based on quoted prices in active markets as reported by the Custodian and are considered to be Level 1 assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
