Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of the Plan**

***General***

The following description of Merchants Bonding Co. Mutual Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Merchants Bonding Company (the Company) for the benefit of its employees. Employees are allowed to make elective deferrals after they reach the age of 18 or older and are scheduled to work at least 1,000 hours during the plan year. One year of entry service is defined as 1,000 or more hours of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Principal Life Insurance Company, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company (collectively, Principal) are the custodians and trustees of the Plan.

***Contributions***

Each year, participants may contribute up to 100% (subject to IRS limitations) of pretax annual compensation or after-tax annual compensation, as defined in the Plan. Participants are automatically enrolled to defer 5% of eligible compensation. The Plan also includes an auto-escalation provision for auto-enrolled employees whereby the deferral percentage will automatically increase each first day of the Plan year by 1% up to a maximum percentage of 10%. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The employer may contribute a discretionary match. In addition to the discretionary match, the employer may contribute an additional match at the end of the year along with a discretionary profit-sharing contribution. Participants may elect their deferrals to a traditional (pretax) account or to a Roth (after tax) account.

***Participant Investment Account Options***

Each participant has the option of directing their contributions and employer contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contribution and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account. All expenses of maintaining the Plan are paid by the Company, with the exception of loan processing fees and withdrawal fees, which are paid by the Plan participants.

***Vesting***

Participants are immediately vested in their voluntary contributions and the Company's qualified nonelective contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100% vested after four years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate based on rates available for similar loans from commercial lending institutions. Principal and interest is paid ratably through bi-weekly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, the participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, fixed period or fixed payment installment options, or various life annuities offered by the Plan. Upon termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. A participant may withdraw all or part of their benefits derived from their contributions on account of hardship as defined by the Plan and applicable IRS regulations. Under these rules the participant must exhaust the possibilities of all other distributions and loans available under the Plan and meet certain other requirements. Upon receiving a hardship withdrawal, the participants elective contributions are suspended for six months.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts were \$0. Forfeitures of non-vested employer contributions may be used to pay administrative expenses or to reduce employer contributions. During 2024 and 2023, \$52,543 and \$18,433 of forfeitures were used to reduce employer contributions, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and pooled separate accounts (PSAs) are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in a collective investment trust (CIT) is valued at the NAV of shares held by the Plan at year end based on share value using the audited financial statements of the collective trust at year end.

The fair value of guaranteed investment contracts are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, and Principal Life Insurance Company on behalf of Principal Global Investors Trust Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain plan investments and an investment contract with Principal Life Insurance Company are managed by Principal and qualify as party-in-interest transactions. The Plan also has a service agreement with Principal, who also receives revenue from mutual funds for services they provide to the funds. Principal is the Plan custodian, and therefore, these transactions qualify as party-in-interest. These transactions are exempt from the prohibited transaction rules of ERISA.

The Plan paid \$60,779 and \$47,646 of recordkeeping fees to Principal during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 5. Plan Amendments**

Effective July 1, 2023, the Plan was amended to redefine eligible wages for the employer match as base earnings and annual bonus earnings.

Effective August 15, 2024, the Plan was amended to change the age of eligibility to the Plan from 21 to 18. Additionally, all employees entering the Plan after August 15, 2024 will have automatic deferral increases of 1% each year up to a maximum of 10%.

**Note 6. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

***Investment Contract with Insurance Company***

The Plan entered into a contract with Principal Life Insurance Company, which guarantees interest on money as it is deposited. The rate credited is the rate declared at the beginning of each calendar quarter and is guaranteed on all deposits made during that quarter until the end of the 12-month period following the beginning of that calendar quarter. The contract is not benefit responsive and is reported at fair value. The guaranteed investment contract is not fully benefit responsive; therefore, fair value is the relevant measurement.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Principal Life Insurance Company. This prototype plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements were available to be issued.
