Note 1: Description of Plan

The following description of the BPG Real Estate Services LLC's 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of the BPG Real Estate Services, LLC (the Company) and employees of related employer Principal Realty, who have completed thirty days of service. Seasonal and intern employees are eligible to participate after completing 1,000 hours of service in a year and reaching age 21. Employees may enroll after meeting their eligibility requirements and reaching their Entry Date. The Entry Date is the first day of the month coinciding with or following the date the employee satisfies the eligibility requirements. Eligibility for qualified elective deferral and Roth deferral is one month of service. Employees are automatically enrolled at a deferral rate of 3% unless an employee makes a contrary election. The Plan provides for qualified employer matching contributions and profit-sharing contributions for employees meeting certain criteria such as one year of service, 1,000 hours of service during the year and are employed by the Plan sponsor on the last day of the Plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established July 1, 2007 and restated September 6, 2024. The Plan was created for the purpose of providing retirement benefits for those employees who qualify for the participation under the terms of the Plan.

Contributions.

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan up to the maximum dollar amount allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan offers a Regular 401(k) and a Roth 401(k) deferral. Participants may also contribute amounts representing distributions from qualified plans (roll-over).

The Company may elect to make a matching contribution and/or a discretionary profit sharing contribution. Matching contributions are equal to a discretionary percentage, determined by the employer, of participants' elective deferrals. The Company made contributions totaling \$0 and \$0 during 2024 and 2023, respectively.

Participants direct investment of their contributions and their allocation of employer contributions, into various investment options offered by the Plan. The Plan offers various mutual funds and a stable value fund.

The Plan evaluates receivables for collectability in accordance with ASC 326, *Financial Instruments -- Credit Losses*. Given the short-term nature of these receivables, their settlement history, and the enforcement mechanisms under ERISA, management has determined that the risk of credit losses is not material to the financial statements. Accordingly, no allowance for credit losses has been recorded.

Participant Accounts.

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the discretionary matching contribution portion of their accounts plus actual earnings thereon is based on the participant's years of continuous service. A year of vesting for the Company contributions is based on 1,000 hours of service worked in a year. The vesting percentage will not increase for any plan year in which a participant does not work 1,000 hours. A participant is 100% vested after six (6) years of credited service on a straight line graded basis beginning after two years of service or upon reaching retirement age and having been a participant for at least five (5) years, whichever occurs first.

Notes Receivable from Participants.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is for five years, but the term may be extended if the loan is for the purchase or construction of a principal residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits.

Upon termination of service due to death, disability or retirement (age 65), a participant may receive a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. In service distributions are permitted upon attaining age fifty-nine and one half (59 1/2), disability, qualified reservist or financial hardship. The normal retirement age under the Plan is age sixty-five (65) upon which the participant becomes fully vested in his or her account balance. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts.

The portion of a participant's account to which he or she is not entitled to upon separation of service is reverted to the employer's Forfeiture Account. In accordance with ERISA, this amount must be held in suspense until the participant has incurred a five-year break-in-service, or if earlier, has been paid his or her entire vested balance. Amounts that can be allocated in this plan year are considered available forfeitures. Those amounts not yet available for allocation are held in suspense for future years.

Per the Plan Document, available forfeitures are used to reduce future employer contribution obligations or to pay Plan expenses. At December 31, 2024 and 2023, the employer's Forfeiture Account balance was \$484 and \$18,535, respectively. Plan expenses totaling \$29,658 and \$0 were paid from the forfeiture account during the years ended December 31, 2024 and 2023, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See *Note 3* for a discussion of fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan’s realized gains and losses on investments both bought and sold during the year, as well as unrealized gains and losses on investments held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are defaulted after 90 days of non-payment. Delinquent loans may be subject to offset against participants’ vested account balance. However, the loan stays on the books until a distributable event has occurred or a loan offset is requested.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan absorbs the cost of administering the Plan, including record keeping and auditing fees. Investment related expenses are charged against investment income. Fees related to the administration of notes receivable from participants are charged directly the participant’s account and are included in administrative expenses.

Note 3: Information Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by *Fidelity Management Trust Company*, the trustee of the Plan.

The following is a summary of the plan's investment information as of December 31, 2024 and 2023, and for the years then ended, included in the plan's financial statements and supplemental schedule, that was prepared by, or derived from, information prepared by *Fidelity Management Trust Company*, the trustee of the Plan, and furnished to the plan management. Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 2 - Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets with insufficient volume or infrequent transactions (less active markets); or model-derived valuations in which all significant inputs are observable or can be derived principally from or corroborated by observable market data for substantially the full term of the assets or liabilities.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - held at net asset values of the shares held by the Plan at year-end.

Common Collective Trust - Valued at the NAV of units of the bank collective trust, which is used as practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities and represents the probable amount at which daily transactions would be recorded. Participant benefit payments and transfers to noncompeting options require a 30-day written notice. Other withdrawals require a twelve- month advanced written notice. Redemptions are processed daily.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

A party-in-interest is defined under Department of Labor regulations to include any fiduciary of the Plan, any party rendering service to the Plan, the employer sponsoring the Plan and certain others. *Fidelity Management Trust Company* acted as a trustee for investments as defined by the Plan. *Fidelity Investments*, a party-in-interest to the Trustee, manages various mutual funds within the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rule under ERISA. In addition, participant loans held in the Plan qualify as party-in interest transactions which are exempt from the prohibited transaction rule under ERISA. Other parties in interest include the plan sponsor, administrator, financial advisor and the auditor.

Note 6: Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7: Tax Status

The Employer restated the Plan and adopted a volume submitter plan document sponsored by *Fidelity Management & Research Co* (Fidelity) effective November 1, 2017. Fidelity received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2014, which states that the volume submitter document satisfies the applicable provisions of the Code. The Plan itself, as restated, has not received a determination letter from the IRS.

The Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 7: Tax Status (Continued)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions for three years after filing.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. At various times during the year, the Plan may have cash deposit in excess of federally insured limits.

Note 10: Prohibited Transactions

For plan years 2024, the employer sponsor failed to remit certain participant contributions in a timely manner, based on when the participant contributions were withheld from participant paychecks, as required under Department of Labor Regulation §2510.3-102. The Plan sponsor corrected the error for the late remittances in the plan year the failure occurred.

Note 11: Excess Contributions Payable

The Plan failed to pass the Average Deferral Percentage (ADP) test for the 2024 plan year. For both plan years 2024 and 2023, participants exceeded the limits of IRC Section 415. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The accompanying statements of net assets available for benefits include approximately \$32,764 and \$34,927 as of December 31, 2024 and 2023, respectively, in excess participant contributions payable to participants related to these issues.

In order to correct the failure of the ADP test for the 2024 plan year, federal law generally required that corrective distributions be made no later than December 31, 2025. The company has partially settled the 2024 corrective distribution obligation during 2025.

Note 12: Subsequent Events

In accordance with generally accepted accounting principles, the Plan Administrator evaluates events or transactions that occur subsequent to year end for potential recognition or disclosure in the financial statements through October 14, 2025 the date on which the financial statements are available to be issued.
