Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Manpower Temporary Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Manpower Temporary Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1. DESCRIPTION OF PLAN

The following description of Manpower Temporary Services 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan to provide retirement benefits to the non-wagemaster employees of Manpower Temporary Services and related entities, Manpower of San Diego, Manpower of New Mexico, Manpower of Temecula, and Manpower of Spokane (collectively, the "Company").

Eligibility

Employees are eligible to participate in the Plan once they have one hour of service with the Company. Highly compensated and wagemaster employees are not eligible to participate. Participants may enter the Plan on January 1 or July 1 after meeting these requirements.

Contributions

Participants may contribute a portion of their annual compensation (elective deferrals) to the Plan subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make discretionary matching contributions for permanent participants. The Company provides a matching contribution of 12.29% of each dollar contributed by an eligible participant. The matching contribution, which was transferred to the participants' accounts from the forfeiture account, for the year ended December 31, 2024 was \$16,367.

The Company may also make a discretionary non-elective contribution to the Plan. No discretionary non-elective contributions were made for the year ended December 31, 2024. For a participant to receive an allocation of Company discretionary contributions, the participant must be employed on the last day of the year and complete one year of service.

Rollover contributions

The Plan provides for rollover contributions, which represents contributions by participants from other tax qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participant contributions.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and charged with an allocation of administrative expense. The contributions are allocated within each participant account based upon the participant's investment elections. All amounts in participant accounts are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their elective deferral contributions plus actual earnings thereon. Vesting in the Company's matching and non-elective contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant vests in Company contributions at the rate of 20% per year beginning in year two and is 100% vested after six years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant account and bear interest 1% above the prime rate as determined by the Plan administrator at the time the loan is made. Loan transactions are treated as transfers to (from) the investment funds from (to) a participant's loan receivable. Principal and interest are amortized and repaid through payroll deductions over the repayment term up to five years unless the proceeds are used for the purchase of a principal residence in which case the maximum repayment period may be longer.

Payment of benefits

Benefits are payable to participants or designated beneficiaries upon retirement, termination, death, disability, or in-service if the participant has attained age 59 ½. Distributions may be paid in a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments over a fixed period for purposes of the required minimum distribution rules, or they may be rolled over into another plan or an Individual Retirement Account.

The Plan has a mandatory cash out provision for account balances up to \$5,000. Benefits are recorded when paid.

Hardship withdrawals

Participants may withdraw their elective deferral contributions in the event of hardship as defined by the plan agreement.

Administrative expenses

Substantially all administrative expenses of the Plan are paid by the Company.

Forfeitures

Upon termination of employment, the unvested portion of a participant's Company contribution account is forfeited. Forfeitures of employer matching contributions are available to reduce future Company contributions or Plan administrative fees. At December 31, 2024 and 2023, forfeited accounts available were \$0 and \$8,696, respectively. During the year ended 2024, forfeitures of \$16,367 were used to reduce the employer matching contribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation includes realized gains and losses on investments bought and sold during the year as well as unrealized appreciation of investments held at year end.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Plan management has evaluated the collectability of notes receivable from participants and because they are secured by the participant's account, an allowance has not been recorded.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of events that affect the financial statements. The Plan has no subsequent events that required recognition or disclosure in the financial statements for the year ended December 31, 2024. Subsequent events were evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets held at December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts ("PSA"): PSAs with underlying mutual fund investments are valued based on the observable net asset value ("NAV") which is based on the fair value of the underlying investments of the PSA, less any liabilities. The underlying investments of the PSA consist of registered investment securities. The Plan had no unfunded commitments related to PSA. The redemption of PSA is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

Stable value fund: Valued at the NAV of the units of the stable value fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. At December 31, 2024 and 2023, Plan investments for which fair value is measured using the NAV per share practical expedient were \$3,274,228 and \$2,929,273, respectively.

NOTE 5. INCOME TAX STATUS

The Plan document is the Ascensus LLC Non-Standardized Pre-Approved Profit Sharing Plan with an Internal Revenue Service (IRS) opinion letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax exempt.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. The Plan's annual return/report of employee benefit plan filings for the past three years are subject to examination by tax authorities and may change upon examination.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contribution accounts.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments were managed by John Hancock Life Insurance (U.S.A), the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9. PROHIBITED TRANSACTIONS

Participant contributions of \$6,334 were withheld from participants pay during February 2020, but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings will be calculated based on interest rates determined by the Internal Revenue Code and will be remitted to the Plan's trust in 2025.

Participant contributions of \$8,832 were withheld from participants' pay during various pay dates in 2022, but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings of \$634 were calculated based on interest rates determined by the Internal Revenue Code and were remitted to the Plan's trust in 2024.

Participant contributions of \$4,000 were withheld from participants' pay during various pay dates in 2022, but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings will be calculated based on interest rates determined by the Internal Revenue Code and will be remitted to the Plan's trust in 2025.

Participant contributions of \$10,019 were withheld from participants' pay during various pay dates in 2023, but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings will be calculated based on interest rates determined by the Internal Revenue Code and will be remitted to the Plan's trust in 2025.

Participant contributions of \$237 were withheld from participants' pay during various pay dates in 2024, but were not remitted to the Plan's trust within the time required by the Department of Labor. The lost earnings will be calculated based on interest rates determined by the Internal Revenue Code and will be remitted to the Plan's trust in 2025.
