NOTE 1—DESCRIPTION OF PLAN

The following description of Identity, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all but part-time, temporary and seasonal employees of Identity, Inc. (the Organization). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for oversight of the Plan. The Executive Team determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Organization's Board of Directors.

Contributions. Each year, participants may contribute up to the maximum percentage of compensation, as defined by the Plan, under Internal Revenue Code (IRC) section 402(g). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization makes an employer safe harbor contributions in the amount of 100% of participant's elective deferrals not to exceed 6% of the participant's compensation. An additional discretionary non-elective employer contribution amount may be contributed by the Organization at the option of the Organization's management. Participants must have one year of service as defined by 1,000 hours and be 21 years of age or older to receive employer contributions. The non-elective employer contribution amount for the year ended December 31, 2024 was \$96,613. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts. Each participant's account is credited with the participant's contributions and Organization's safe harbor matching contributions, as well as allocations of the Organization's discretionary non-elective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of no greater than their vested balance. Participants are limited to one outstanding loan at any given time. The loans are secured by the balance in the participant's account and bear interest at rates that range from 7.25% to 9.50%. Interest is calculated at 1% over prime using the first date of the month in which the loan is originated. Principal and interest are paid ratably through payroll deductions.

Vesting. Participants are 100% vested immediately in all contributions.

Payment of Benefits. A participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal, for all distributions other than death. After termination of employment with the Organization, if the vested amount of the account does not exceed \$5,000, the vested account balance will be distributed from the Plan. Participants may also elect in-service distributions from the Plan on account of hardship or attainment of age 59 ½.

Forfeited Accounts. At December 31, 2024 **and 2023** forfeited nonvested accounts totaled \$35 and \$34, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. During the year ended December 31, 2024, forfeited nonvested accounts totaling \$1 were used to reduce employer contributions.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contribution Receivable

The Plan uses the ERISA definition of plan assets to determine whether an accrual should be made for employee or the related employer contributions receivable based on when amounts have been withheld from employee compensation. A defined contribution plan can elect to recognize the employee and the related employer matching contribution either (1) in the period related to the participant's service or compensation (even if not yet withheld), or (2) in the period the employee contribution is withheld if the policy is applied on a consistent basis.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024 **and 2023**, delinquent participant notes receivable are recorded as benefit payments based on the terms of the Plan document.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Executive Team determines the Plan's valuation policies utilizing information provided by the custodian and investment manager. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. There were no distributions requested that were not paid out by December 31, 2024.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments. Fees related to the administration of benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Asset-based fees are also included in administrative expenses.

Date of Management's Review

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

NOTE 3—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market fund: Valued at the daily closing price as reported by the fund.

NOTE 4—PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 5—TAX STATUS

The Organization has adopted a pre-approved plan document that has received an opinion letter from the IRS dated November 30, 2020, stating that the form of the preapproved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7—CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Capital Bank and Trust Company (the custodian of the Plan).

NOTE 8—RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan include investment management expenses, general administrative service expenses, and recordkeeping fees. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations

NOTE 9—SUBSEQUENT EVENT

The Plan has implemented some mandatory and optional provisions of the SECURE 2.0 Act in 2025. Optional provisions included: increased catch-up limit for participants of ages 60 through 63.
