Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Darling's et al 401(k) Retirement Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users based on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Darling's et al 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Darling's et al 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan:

The following brief description of the Darling's et al 401(k) Retirement Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for more complete information.

General – The Plan is a defined contribution plan covering all employees of Darling's, Darling's Agency, LLC, Darlco, Inc., Green Point, Brunswick Ford, and Newport (collectively, the "Companies") who have completed 60 days of service and attained the age of 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may elect to defer up to the maximum annual limits as established by the Internal Revenue Service (IRS), \$23,000 and \$22,500 during the years ended December 31, 2024 and 2023, respectively, of pre-tax eligible compensation as defined by the plan document. Eligible participants meeting certain age requirements may elect to defer an additional \$7,500 in 2024 and 2023, of pre-tax eligible compensation as defined by the plan document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Companies contribute a matching contribution equal to 50% of a participant's contribution to the Plan, subject to a maximum of \$1,500. The Companies may also make a discretionary profit-sharing contribution to eligible participants. During the year ended December 31, 2024 the Companies made matching contributions totaling \$442,360. During the year ended December 31, 2024, the Companies did not make profit sharing contributions.

Contributions from Plan participants and the Companies matching contributions are recorded in the year in which the employee contributions are withheld from compensation. The Companies profit-sharing contribution is recorded in the year generating the profit share.

Participant Accounts – Each participant's account is credited with the participant's contributions, the Companies' corresponding matching and profit-sharing contributions and an allocation of Plan earnings and/or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' matching and profit-sharing portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service in all matching contributions. A participant is 100% vested after three years of credited service in all discretionary contributions.

Investment Options – Participants may direct their contributions to numerous funds. These funds include a variety of investment options including money market funds, fixed-income funds, balanced funds, growth and income funds, growth funds, aggressive growth funds and international funds. In addition, they also have the option of investing in a benefit responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya).

Payment of Benefits – On termination of service due to death, disability, retirement, hardship, or attainment of age 59½, a participant may elect to receive the value of his or her account in one lump sum or a single or qualified joint annuity equal to the vested account balance. Benefits are recorded when paid.

### 1. Description of Plan (continued):

Participant Notes Receivable – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 (not to exceed 50% of the participant's vested account balance). Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. Loan terms range from 3 to 5 years and up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1% as determined by the Plan administrator. Interest rates range from 4.25% - 9.50%. Principal and interest is paid ratably through payroll deductions.

Forfeitures – At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$12,234 and \$41,826, respectively. Discretionary forfeitures are allocated amongst the remaining participants. Matching forfeitures are used to pay expenses of the Plan. During the year ended December 31, 2024 forfeitures totaling \$59,290 were used to reduce the Companies' matching contributions.

Other income – The Plan includes a recordkeeping expense account, as required by the trustee, Voya, under which certain pooled separate account expenses that are charged by the funds to the individual participants are recaptured by the Plan and held in the Voya Fixed Account. These funds are then used to pay for expenses of the Plan that benefit Plan participants as approved by the IRS, Department of Labor and ERISA. Amounts unused for expenses may be allocated to eligible participant accounts based upon each participant's pro rata percentage of total plan investments. During the year ended December 31, 2024, these recaptured funds totaled \$28,977 and are included in other income on the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the balance in the recordkeeping expense account totaled \$29,439 and \$28,897, respectively.

### 2. Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

Basis of Accounting – The accounting records of the Plan are maintained on the accrual basis, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as quoted in an active market, except for its insurance contract which is valued at contract value.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. The accompanying Statements of Net Assets Available for Plan Benefits present the fully benefit responsive investment contracts at contract value. The Statement of Changes in Net Assets Available for Plan Benefits is prepared on a contract value basis.

**2. Significant Accounting Policies (continued):**

Investment Valuation and Income Recognition (continued) - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Companies. Expenses that are paid by the Companies are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of investments.

Subsequent Event – In preparing these financial statements, management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**3. Tax Status:**

The Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**4. Information Prepared and Certified by Trustee:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Reporting and Disclosure under ERISA. Voya served as the Plan's trustee. Accordingly, the trustee has provided the Plan administrator with certifications as to the completeness and accuracy of investment balances, investment transactions, supplemental schedule, interest and dividend income, realized gains and losses on the sale of investments and unrealized appreciation and depreciation of investments in accordance with Department of Labor Regulations. Employer contributions receivable totaling \$22,312 and \$2,211 as of December 31, 2024 and 2023, respectively and the participant notes receivable totaling \$627,778 and \$579,630 as of December 31, 2024 and 2023, respectively, have not been certified by the trustee.

### 5. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participant's accounts and the amounts reported in the accompanying statements of net assets available for benefits.

### 6. Plan Termination:

Although they have not expressed intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will either remain or become immediately 100% vested in their accounts.

### 7. Investments at Contract Value:

During 2024 and 2023, the participant's investment options include a fully benefit-responsive investment contract with Voya. Voya maintains the contributions in a group annuity contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Voya. As described in Note 2, because the group annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$3,046,072 and \$2,352,735, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than one and a half percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition of competing investment options or deleting of equity wash provisions, (3) bankruptcy of the Plan sponsor or other cause for significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 8. Fair Value Measurements:

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: <ul style="list-style-type: none"><li>• quoted prices for similar assets or liabilities in active markets;</li><li>• quoted prices for identical or similar assets or liabilities in inactive markets;</li><li>• inputs other than quoted prices that are observable from the asset or liability;</li><li>• inputs that are derived principally from or corroborated by observable market data by correlation or other means.</li></ul> <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Pooled separate accounts are stated at their NAV as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The funds have no unfunded commitments and there is no redemption notice period. Pursuant to ASC Topic 820, investments which use NAV as a practical expedient to measure fair value are not included in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of the different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 9. Transactions With Parties-in-Interest:

The Companies provide to the Plan certain accounting and administrative services for which no fees are charged. The employees that provide these services are also contributing participants in the Plan. These transactions qualify as party-in-interest transactions.

Notes receivable from participants are also considered party-in-interest transactions. However, under the provisions of ERISA, these transactions meet the criteria for exemption, are not considered prohibited transactions and do not need to be reported in the supplementary schedules of Form 5500.

Plan investments are managed by Voya, the trustee for the Plan, and therefore, transactions with Voya qualify as party-in-interest transactions.
