Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements



NOTE 1 PLAN DESCRIPTION

The Omni Ophthalmic Management Consultants 401(k) Profit Sharing Plan (Plan) is administered by Omni Ophthalmic Management Consultants LLC (Company or Plan Sponsor). The following description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant-directed, defined contribution savings plan that became effective January 1, 1999. The following employers have adopted the Plan: Omni Eye Surgery of New York; Essex Specialized Surgical Institute; Delaware Valley Vision Associates Group Practice, LLC; TLC Management (Delaware Valley), LLC; Ludwick Eye Center; and Erie Retinal Surgery, Inc. Thus, when reference is made to the Company, it will include all employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees are eligible to participate in the Plan, except for nonresident aliens, leased, part-time, seasonal, temporary, or employees covered by a collective bargaining agreement. The minimum age requirement is 21 years old, and a service requirement of three months is required for employee contributions and employer discretionary matching contributions. The minimum age requirement is 21 years old, and a service requirement of six months is required for employer discretionary profit-sharing contributions. The Plan has an automatic enrollment feature. Under the automatic enrollment feature, an employee will be automatically enrolled as a participant with an election to contribute 3% of their compensation to the Plan unless they elect to opt out. Employees may enter the plan on the first day of the month coinciding with or next following the date that the eligibility requirements are met.

Employee Contributions

Participants may make voluntary pretax contributions and Roth 401(k) contributions to the Plan up to 100% of eligible compensation, up to the annual Internal Revenue Service (IRS) dollar limit. The Plan accepts rollover contributions from other qualified retirement plans in accordance with ERISA. Participants who have attained age 50 before the end of the Plan Year are eligible to make catch-up contributions in accordance with, and subject to, IRS limitations.

Employer Contributions

The Plan allows the Company to make discretionary matching and profit-sharing contributions. For the years ended December 31, 2024 and 2023, employer discretionary matching contributions were \$703,258 and \$944,603, respectively. For the years ended December 31, 2024, and 2023, there were no employer discretionary profit-sharing contributions made.

Investment Options

Upon enrollment in the Plan, participants may direct their employee and Company contributions by percentages into any of the investment options available. A separate account is maintained for each participant, and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of: (a) the Company's discretionary matching and profit-sharing contributions; (b) Plan earnings, gains, or losses; and (c) charged with an allocation of administrative expenses. Allocations are based on participant's compensation or account balances, as defined in the Plan Document.

The Plan permits participants to self-direct the investments of their accounts in a variety of investment options. All participants have elected to self-direct their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary employee contributions and rollover contributions, plus earnings thereon. Vesting of the Company's discretionary matching and profit-sharing contributions are based on years of vesting service. Vesting increases 20% per year from year two through year six, with no vesting in the first year. Participants also become 100% vested upon the attainment of age 65, or upon death or disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of one-half of their vested account balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months). Loans are repaid within a period not to exceed five years, except for the purchase of a primary residence, which may be repaid over a 15-year period. The loans are secured by one-half of the participant's vested balance and bear interest at a rate of prime plus 2%, as determined on the origination date of the loan. Principal and interest are paid ratably through payroll deductions. Only one loan per participant can be outstanding at a time. If a participant is terminated prior to repayment of the loan balance, the remaining balance on the loan is a deemed distribution to the participant.

Payment of Benefits

After retirement, death, or disability, participants are entitled to receive a lump-sum distribution. Partial withdrawals or installments are only permitted for participants or beneficiaries who receive required minimum distributions. Participants have the option to leave amounts in the Plan up to the mandatory distribution date, which is defined as the later of April 1 following the calendar year of attaining the age of 72 or age at retirement. Upon termination, vested benefits can be rolled over to another qualified plan or an individual retirement account (IRA) or distributed in a lump-sum payment or partial withdrawals. If the vested balance is \$5,000 or less, the participant will receive a lump-sum distribution without their consent.

Hardship withdrawals are subject to approval by the Plan administrator and are subject to income tax withholding and penalties.

In-service Withdrawals

Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their account. Withdrawals may be made from a participant's nonelective contribution account at any age if the amount to be distributed has accumulated for at least two years or the participant has completed five years of participation in the Plan.

Retirement

The Plan's normal retirement age is 65. There is no early retirement provision under the Plan.

Forfeitures

Forfeitures are used to pay for administrative expenses or reduce employer discretionary matching and discretionary profit-sharing contributions. The balance in the forfeiture account at December 31, 2024 and 2023 was \$2,912 and \$21,705, respectively. For the years ended December 31, 2024 and 2023, \$116,477 and \$-0-, respectively, was used to reduce employer contributions. For the years ended December 31, 2024 and 2023, \$38,899 and \$173,419, respectively, were used to pay administrative expenses.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and management determine the Plan's valuation policies utilizing information provided by the investment advisor and Custodian. See Note 4 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses and Participant Transaction Fees

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, investment fees, and certain Plan administration fees not covered by the Company are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024, through October 8, 2025, the date that the financial statements were available to be issued.

NOTE 3 INVESTMENTS CERTIFIED BY THE QUALIFIED INSTITUTION

John Hancock Trust Company LLC, the qualified institution of the Plan, has supplied the Plan administrator with certifications as to the completeness and accuracy of investments and notes receivable from participants as of December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, in the accompanying financial statements and ERISA-required supplemental schedules.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds and Money Market Fund – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Common Collective Trusts – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner (Other inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments are held by John Hancock Trust Company LLC, the Custodian as defined by the Plan, and therefore those transactions qualify as party-in-interest transactions.

Notes receivable from Plan participants qualify as party-in-interest transactions.

NOTE 6 PLAN TERMINATION

Although the Company has not expressed intent to terminate the Plan, it may do so at any time under the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions, as of the termination date.

NOTE 7 TAX STATUS

The Plan Sponsor obtained an opinion letter from the Internal Revenue Service on June 30, 2020, in which the IRS stated that the prototype Plan Document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended; however, the Plan administrator believes the Plan is being designed and operated in compliance with the Plan Document and applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events that could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During the Plan years ended December 31, 2019 through 2022, there were occurrences in which the Company did not remit various employee salary deferral contributions and loan repayments within the time period prescribed by the Department of Labor. The late remittances were considered nonexempt transactions. Those late remittances totaled \$194,318. The Company remitted the lost earnings on these amounts in 2024, thereby fully correcting them.

In 2023, there was \$104 in delinquent employee contributions and loan repayments. As of December 31, 2024, \$83 of this amount had not yet been remitted. This amount and the related lost earnings were remitted in 2025.

In 2024, there was \$17,278 in delinquent employee contributions and loan repayments. As of December 31, 2024, none of this amount had been remitted. This amount and the related lost earnings were remitted in 2025.
