Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We performed an audit of the accompanying financial statements of SRL Reedmark Pooled Employer Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

Note 1 – Description of Plan

The following description of the SRL Reedmark Pooled Employer Plan (the Plan or the PEP) provides only general information. Participants should refer to the PEP basic plan document, and the applicable adoption agreement for the participant's employer which has chosen to participate in the PEP (Participating Employer), for a more complete description of the PEP's provisions.

General

The PEP is a pooled employer plan established and administered by Reedmark Advisors, LLC, the Pooled Plan Provider (PPP). The PEP was established under the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) on January 1, 2024. The PEP is a defined contribution plan covering eligible employees of the Participating Employers and is not intended to qualify under the Internal Revenue Code (IRC), sections 410(a) and 501(a). The PEP is intended to constitute a multiple employer plan, as described under IRC Section 410(a), 411 and 415. Each Participating Employer elects its own provisions related to eligibility, contributions, notes receivables from participants, and payment of benefits. There was one Participating Employer in the PEP as of and for the year ended December 31, 2024. The PEP is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The PEP's PPP is responsible for oversight of the Plan, determining the appropriateness of investment offerings, and monitoring investment performance.

Transamerica Financial Life Insurance Company (Transamerica or the Custodian), the Agent for Reliance Trust Company (RTC) from January 1, 2024 through June 30, 2024 and Transamerica Trust Company (TTC) from July 1, 2024 through December 31, 2024, hold the PEP's investment assets, and Transamerica's affiliate, Transamerica Retirement Solutions, LLC (TRS) provides recordkeeping services.

Eligibility

Only those employees of the Participating Employers who are designated by the Participating Employer in its adoption agreement as eligible employees shall be eligible to participate in the PEP. Participating Employers may define eligibility requirements based on factors such as age, service or employee type. Eligible employees shall be eligible to make participant contributions and receive allocations of employer contributions if and to the extent specified in the applicable adoption agreement or otherwise provided by the PEP.

Contributions

Each year, participants may contribute an amount of annual compensation, as elected by their Adopting Employer, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the PEP year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the PEP. Roth deferrals are allowed under the PEP, in accordance with PEP provisions.

The PEP includes an auto enrollment provision whereby all newly eligible employees who enter the PEP are automatically enrolled in the PEP unless they affirmatively elect not to participate in the PEP. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, as defined, and their contributions invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 10%. Participants direct the investment of their contributions into various investment options offered by the PEP.

An Adopting Employer may make discretionary matching and/or profit-sharing contributions at an amount determined in accordance with the formula specified in the adoption agreement, if so elected. Adopting Employer contributions, if any, are recorded in the year for which the contributions apply. Aggregate Adopting Employer contributions for the year ended December 31, 2024, amounted to \$100,000. Adopting Employer contributions are invested in funds in accordance with the participant's direction and the PEP's provisions.

Contributions, continued

Contributions are subject to certain IRS limitations.

Participant accounts

Participant accounts are credited with the participant's contributions, the Participating Employer's contributions, if any, and investment earnings and losses and charged with the participant's withdrawals, applicable transaction charges, and an allocation of administrative expenses. Participants may direct their account balance into various investment options offered by the PEP which include mutual funds and a guaranteed investment contract with an insurance company. Allocations are based on earnings and losses of the participant's investments or participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account

Vesting

Participants are immediately vested in their individual contributions, plus actual earnings or losses thereon. Vesting in their Participating Employer's matching, discretionary and other contributions, if any, plus actual earnings thereon, is based on years of service. Vesting schedules are based on annual vesting periods not to exceed six years and vary by Participating Employer based on each employer's election in their adoption agreement. Participant accounts become fully vested upon reaching normal retirement age of sixty-five (65), death, disability, or upon termination of the PEP.

Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future Participating Employer's contributions. For the year ended December 31, 2024, no forfeitures were utilized. At December 31, 2024, there were no available forfeited nonvested accounts.

Notes receivable from participants

PEP participants are permitted to borrow from their account a minimum \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms range from one to five years unless the loan is used to acquire the principal residence of the participant which must be repaid in a reasonable period of time not to exceed thirty years. Loans are secured by the balance in the participant's account, and bear interest at the prime rate plus 1%. A participant may only have two loans outstanding at any time. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the PEP document. Principal and interest are repaid through regular payroll deductions. These loans are subject to certain restrictions as defined by the PEP Document and applicable restrictions under the Internal Revenue Code (the IRC).

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$7,000 or elect a lump-sum distribution. Participants with vested accounts greater than \$1,000 but not greater than \$7,000 will have their vested interest paid in a direct rollover to an IRA chosen by the PPP. A participant's vested interest of \$1,000 or less will be automatically distributed in a lump-sum payment. Participants may elect to take an in-service distribution of their vested accounts if they meet certain defined requirements, including becoming disabled, early retirement (age 59½), or due to heavy financial hardship, as defined.

Plan expenses reimbursement account

The Plan utilizes an expense budget account (EBA) to pay Plan related expenses. The EBA is funded by a monthly charge to participant accounts of 0.02%. EBA funds can be used to pay Plan-related expenses approved by the Plan Administrator or can be allocated to Plan participants at the end of the year.

At December 31, 2024, the EBA totaled \$400. During the year ended December 31, 2024, no EBA funds were used. The EBA is recorded as an investment on the Statement of Net Assets as interest-bearing cash.

Plan administration

The PPP is the Plan Administrator, and as such, controls and manages the operations of the Plan. The Plan's investment assets were maintained by Transamerica. Transamerica invests cash received, interest and dividend income and make distributions to participants (subject to the direction of participants).

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the PEP are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract which is recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The PPP determines the PEPs valuation policies utilizing information provided by the Custodians.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the PEP's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the PEP management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates, and those differences may be material.

Risks and uncertainties

The PEP provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, liquidity risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible changes in such risks in the near-term would materially affect participants' account balances and the amounts reported in the financial statements.

For the year ended December 31, 2024, there was only one Participating Employer in the PEP.

Note 2 – Summary of Significant Accounting Policies, Continued

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. Delinquent notes are reclassified as distributions based on the terms of the PEP basic plan document and participant loan program. As of December 31, 2024, no allowance for credit losses has been recorded.

Payment of benefits

The PEP records benefits when paid.

Contributions

Contributions from PEP participants and the matching contributions from the Participating Employer are recorded in the year in which the employee contributions are withheld from compensation. Participating Employer non-elective/profit-sharing contributions are recorded in the relevant period in accordance with the terms of the PEP document.

Administrative expenses

The PEP has classified certain Plan expenses as administrative expenses rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the PEP are paid by the PPP or the Participating Employers and are not reflected in these financial statements. Certain expenses paid by the PEP consist of recordkeeping, trustee, and third-party administrator fees. Certain participant directed transactions such as loan processing and withdrawal fees are charged directly to the participant's account.

Uncertain tax positions

U.S. GAAP requires PEP management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, Plan management has determined it does not have any positions at December 31, 2024, that it would be unable to substantiate.

Note 3 – Certified Investment Information

The PPP has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company, the Agent for Reliance Trust Company from January 1, 2024 through June 30, 2024 and Transamerica Trust Company from July 1, 2024 through December 31, 2024, qualified institutions, have certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental information is complete and accurate:

- Investments and notes receivable from participants as shown on the statement of net assets available for benefits as of December 31, 2024;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investment information included in the Schedule H – Line 4i Schedule of Assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the PPP, the PEP’s independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4 – Fair Value Measurements

Accounting guidance provides a framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024. During the year ended December 31, 2024, there were no transfers of financial investments into or out of Level 3.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual funds – are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are deemed to be actively traded on national exchanges and transact at their published daily net asset value (NAV).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Guaranteed Investment Contract with Insurance Company

The PEP invests in a fully benefit-responsive guaranteed investment contract issued by Transamerica (the issuer) with a contract value of \$74,421, as of December 31, 2024. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the PEP. The effective rate of interest is set semi-annually and is effective as of the first day of the semi-annual period. The average crediting rate for the year ended December 31, 2024, was 2.50%. Per the contract's terms, Transamerica may not terminate the agreement prior to the scheduled maturity date.

The effective rate of interest is established every January 1 and July 1 and is based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. The guaranteed investment contract does not permit Transamerica to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the PEP. Contract value, as reported to the PEP by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The PEP's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the PEP to transact at contract value with Transamerica. Such events include amendments to the PEP documents (including complete or partial plan termination or merger with another plan), changes to the PEP's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the PEP Sponsor or other PEP Sponsor events that cause a significant withdrawal from the PEP, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. The PPP does not believe any events are probable of occurring that might limit the ability of the PEP to transact at contract value with the contract issuer and that also would limit the ability of the PEP to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the PEP and settle at an amount different from contract value. Such events include an uncured violation of the PEP's investment guidelines, a breach of material obligation under the contract, a material misrepresentation or a material amendment to the agreement without the consent of the issuer.

Based on ongoing credit evaluations of its guaranteed investment contract investments, the PPP does not expect payment defaults or delinquencies and has not recorded an allowance for credit losses for these investments as of December 31, 2024.

Note 6 – Refunds Payable for Excess Contributions

During 2024, the PEP received contributions from participants in excess of PEP and IRS limitations. Such excess contributions were refunded to participants in the subsequent year with a liability and corresponding reduction to excess contributions recorded at December 31, 2024.

Note 7 – Related Party and Party-In-Interest Transactions

Parties in interest are defined under DOL regulations as any fiduciary of the PEP any party rendering service to the PEP, the Pooled Plan Provider, Participating Employers, and certain others. The PEP's investments include shares of mutual funds, and a guaranteed investment contract issued, managed, and administered by Transamerica. Transamerica is the agent for the Plan's Trustee, TTC, and Transamerica's affiliate, TRS, is the Plan's recordkeeper, and therefore, these transactions qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the PEP or Participating Employers. No officer or employee receives compensation from the PEP for these services.

Note 8 – PEP Termination

Although it has not expressed any intent to do so, the PPP reserves the right to terminate the PEP subject to the provisions of ERISA. In the event of PEP termination, participants will become 100% vested in the Participating Employer's contribution portion of their accounts.

Note 9 – Tax Status

On June 30, 2020, the IRS stated that the Non-Standardized Pre-Approved profit-sharing plan with CODA adopted by the PEP, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the PEP and its related trust are tax-exempt. The PEP has not received a determination letter specific to the PEP itself. The PEP has been amended since adoption; however, the PPE and the PEP's tax counsel believe that the PEP is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the PEP's financial statements.

The PEP is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10 – Plan Transfers

Qualified plans sponsored by certain Participating Employers may be merged into the PEP in conjunction with such Participating Employer's adoption of the PEP. New participant accounts are then created for such participants in the PEP. In addition, the account balances of participants employed by certain Participating Employers who terminate their employment during the year may be transferred out of the PEP through mergers with, or creation of, other qualified plans. During the year ended December 31, 2024, transfers into the PEP from other qualified plans totaled \$2,646,925.

Note 11 – Subsequent Events

The PEP evaluated events occurring subsequent to December 31, 2024 through October 7, 2025, the date on which the financial statements were available to be issued, for matters that should be recorded in the financial statements or disclosed in the footnotes thereto.
