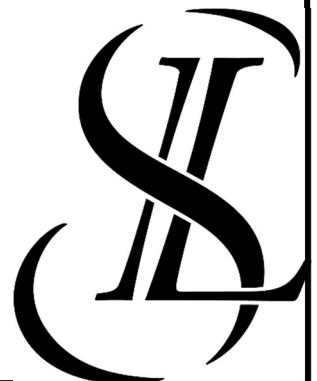

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the J. Davis Architects, PC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency ("qualified institution"), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the J. Davis Architects, PC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan available to eligible employees of J. Davis Architects, PC (the "Company"). To be eligible to participate in the Plan, an employee must have attained age 21 and completed 30 days of service. Employees may begin participation immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions

Eligible employees are automatically enrolled to make pre-tax contributions equal to 3% of compensation, unless they choose an alternative percentage or decline participation. Participants may otherwise elect to contribute up to 100% of their pre-tax and/or after-tax ("Roth") annual compensation, as defined by the Plan, not to exceed the limits set by the Internal Revenue Service ("IRS"). Participants who have attained the age of 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). The Company makes safe harbor matching contributions of 100% of the first 3% plus 50% of the next 2% of eligible compensation contributed by participants. The Company may also make a discretionary matching contribution to be determined annually by the Board of Directors. However, no discretionary matching contributions were made for 2024.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

Participant Accounts

Each participant's account is credited with the participant's and the Company's contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based upon participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and any Company safe harbor matching contributions, plus any income or loss thereon. Company discretionary matching contributions vest according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum, partial or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

1. Description of Plan (Concluded)

Notes Receivable from Participants

A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms are generally up to five years, with the exception of borrowings for primary residences which can be up to fifteen years. The notes are secured by the vested account balance in the participant's account and bear interest at the prime rate plus 1% at the date of application. Participants may only have two outstanding notes at a time. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeitures from non-vested participant accounts may be used to offset future Company contributions. During 2024, forfeitures of approximately \$10,100 were used to reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$15,600 and \$26,100.

Administrative Expenses

The Company absorbs substantially all expenses incidental to the administration of the Plan including internal administrative costs. Other fees, including custodian and recordkeeping expenses, may be paid by the Company or the Plan. Note and distribution fees are paid out of affected participant accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated events occurring subsequent to the date of the financial statements through October 8, 2025, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (“Capital Bank”).

4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

5. Income Tax Status

The Plan has adopted a prototype non-standardized plan document sponsored by Trinity Pension Group, LLC (“Trinity”). The IRS has determined and informed Trinity by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

6. Plan Termination

Effective May 16, 2025, the Plan terminated and participants became fully vested in their account balances. A description of the priority order of the participants’ claims to the Plan’s assets upon Plan termination are included in the summary plan description. Liquidation of the Plan is expected to be completed in 2026.

7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds and a money market fund managed by American Funds. American Funds is a related party of Capital Bank, the Plan’s trustee and, therefore, these transactions qualify as party-in-interest. Fees paid by the Plan to Capital Bank for administrative services were approximately \$1,100 in 2024.

Fees paid by the Plan to Trinity for administrative services were approximately \$2,900 in 2024.

Fees paid by the Plan to Capital Advisers Inc for investment advisory services were approximately \$300 (net of participant revenue credits of approximately \$35,500) in 2024.

8. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, “Fair Value Measurements and Disclosures” (“ASC 820”), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and money market funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

Self-directed brokerage accounts: Comprised of common stocks, mutual funds, unit investment trusts, and cash. Common stocks are valued at the closing price reported on the active market on which the securities are traded. Mutual funds are valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market. These investments are classified as Level 1 of the valuation hierarchy. Unit investment trusts are valued at the closing value of the fund utilizing NAV. The NAV for these investments are generally quoted, based on the fair market value of the underlying investments. As the value of these investments is readily available, these funds are classified within Level 2 of the valuation hierarchy. Cash is measured on a recurring basis and is determined using quoted prices in an active market. These investments are classified as Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
