INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Humane Society Silicon Valley 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Humane Society Silicon Valley 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Humane Society Silicon Valley 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Humane Society Silicon Valley 403(b) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Humane Society Silicon Valley 403(b) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Humane Society Silicon Valley 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution plan sponsored by Humane Society Silicon Valley (the "Organization" or "Employer"), is designed to qualify under Section 403(b) and related provisions of the Internal Revenue Code (IRC). The Plan was established January 1, 2005, and is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan was restated effective February 1, 2020, using an Internal Revenue Service pre-approved volume submitter document. The Plan is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent laws.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Plan sponsor has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Organization has designated the Retirement Plan Committee (the "Committee") as the administrator of the Plan, and as such, the Committee carries out the duties imposed by ERISA. The Organization has contracted with American United Life Insurance Company (AUL or the "Custodian"), a OneAmerica Company, and an affiliate of AUL to provide custodial and record-keeping services, respectively, and the Committee collectively serves as the trustee of the Plan.

Eligibility

All employees of the organization who have attained age 18 are eligible to immediately participate in the Plan. Employees who are classified as either reclassified employees (defined in the plan documents as either employees paid outside of the payroll system or out-sourced workers) or temporary employees with less than one year of credited service, as defined in the plan documents, are not eligible to participate in either the Organization's discretionary matching contributions or discretionary nonelective contributions made to the Plan.

1. DESCRIPTION OF THE PLAN (continued)

Participant contributions

Participants are allowed to contribute their eligible pre-tax or after-tax (as Roth contributions) compensation, as defined in the plan documents, up to the maximum annual amount allowed by the IRC. Unless affirmatively elected otherwise, eligible employees are automatically enrolled into the Plan with an annual pre-tax deferral rate of 5% which automatically increases 1% annually beginning on January 1st of the second calendar year up to a maximum of 10%. Participants are also allowed to make pre-tax and after-tax (as Roth) rollover contributions to the Plan from other qualified retirement plans, or certain individual retirement accounts.

The Organization amended the Plan effective May 1, 2024 to automatically increase the employee pre-tax deferral rate by 1% annually beginning on January 1st of the first calendar year up to a maximum of 10% for the eligible employees who automatically enrolled into the Plan.

Plan participants who have attained age 50 before the end of a calendar year are allowed to make additional contributions called "catch-up contributions" to the Plan, up to the annual contribution limit as defined in the IRC. Participants credited with 15 years or more of eligible service with the Organization or other qualified organization, as defined in the plan documents, may elect to also make additional catch-up contributions to the Plan.

Employer contributions

The Organization is allowed to make discretionary matching contributions and discretionary non-elective contributions to the Plan. During the year ended December 31, 2024, the Organization made matching contributions to the Plan of up to 1.75% of eligible compensation contributed by eligible participants each pay period. Discretionary non-elective contributions are made either equally to all eligible participants or as a uniform percentage of either eligible participants' contributions or compensation. No discretionary non-elective contributions were made to the Plan for the year ended December 31, 2024.

Participant accounts

Each participant's account is credited with the participant's contributions, allocations of the Organization's discretionary matching contributions and discretionary non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings or account balances, as defined in the plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Participants direct the investments of all their contributions into the various investment options offered by the Plan.

1. DESCRIPTION OF THE PLAN (continued)

Vesting

Participants are immediately 100% vested in their voluntary contributions and the Organization's discretionary matching and discretionary non-elective contributions, plus actual earnings thereon.

Administrative expenses

Fees and expenses charged under participant accounts impact retirement savings and fall into three basic categories. Investment fees are generally assessed as a percentage of assets invested and are deducted directly from investment fund balances. They can be in the form of sales charges, loads, commissions, or management fees. Plan administration and record-keeping fees cover the routine expenses for the services of lawyers, accountants, third party administrators, and other advisors. The Plan requires that certain expenses related to the Plan be paid directly by the Organization, but permits certain expenses incurred to administer the Plan to be paid from Plan assets. Transaction-based fees are associated with optional services offered under the Plan, and are charged directly to participant accounts for particular Plan features that may be available, such as the maintenance of a terminated participant's account.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, financial hardship, disability, or death. Upon termination, if a participant's account balance is equal to or less than \$1,000, the balance is immediately distributed as a lump-sum payment. Upon termination, if a participant's account balance is greater than \$1,000 and less than or equal to \$5,000, their balance shall be automatically rolled over into an individual retirement account designated by the Committee, unless otherwise elected. Upon termination, if a participant's account balance is greater than \$5,000, the participant (or beneficiary) may elect to receive a distribution of their account balance as a lump-sum payment, annual installments, a joint and survivor annuity, or postpone payment to a later date and remain in the Plan.

In addition to the foregoing, participants are permitted to request in-service distributions from their vested Plan accounts at any time after having attained age 59½ and older. In certain circumstances as described in the plan document and in accordance with IRS regulations, participants may qualify for a hardship withdrawal.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management of the Plan sponsor to make estimates and assumptions that affect the reported amounts of assets and liabilities and the change therein, and disclosure of contingent liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments in separate accounts are reported at net asset value (NAV) as a practical expedient to fair value as reported by the issuer. The Plan's investments in benefit-responsive investment contracts are reported at contract value by the Custodian.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 5.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments represents realized gains and losses bought and sold, as well as held, during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Organization, which is the pay date. The Plan records receivables for participants' contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year. Employer discretionary matching contributions and discretionary nonelective contributions, if any, are recorded in the year they are earned by participants and to coincide with the year in which the Organization records the contribution in its general ledger. Rollovers are recorded when received by the Custodian.

Payment of benefits

Benefit payments to participants are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The Plan administrator, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, the Custodian, determined to be a qualified institution by the plan administrator, has certified to the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the Plan administrator, the Plan's auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Accounting standards require that fair value be determined based on the price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market, in an orderly transaction between market participants. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- *Level 1* - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the plan has the ability to access.

- *Level 2* - inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Separate accounts: Valued in the form of accumulated units based on the NAV of the underlying investments less estimated expenses. The separate accounts allow participants to invest in the following: various large-, medium-, and small-cap index funds, both foreign and domestic oriented, strategized to approximate the aggregate returns posted to the respective stock indices; target-date mutual funds which adjust their investment mix to better preserve a greater proportion of contributed capital as the respective investment approaches the respective target retirement date; mutual funds which specialize in the investment in under-valued or growth-oriented domestic stocks; and mutual funds which invest in bonds backed by either real estate or U.S. corporate bond holdings. All separate accounts have no unfunded commitments, a daily redemption frequency, and redemption notice period of 60 days.

Investments valued using NAV as a practical expedient to fair value are not subject to disclosure within the fair value hierarchy and total \$8,572,081 and \$6,969,896 as of December 31, 2024 and 2023, respectively.

5. INVESTMENT CONTRACTS

The AUL Stable Value Account (the "contract") is a guaranteed fixed annuity contract available as an investment option to Plan participants. Contributions into the contract are held with the general assets of AUL. The contract is fully and unconditionally guaranteed by AUL and has a balance of \$67,822 and \$49,240 as of December 31, 2024 and 2023, respectively.

For investment contracts that are benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the contract. Contract value represents accumulated cash contributions made under the contract, interest credited to the contracts, less participant withdrawals and transfers. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The AUL Stable Value Account is a benefit-responsive investment contract.

The Plan administrator is not aware of reserves against contract value for credit risk of the contract issuer or otherwise. The AUL Stable Value Account provides a guarantee of principal and that the effective annual interest rate may not be less than 0% while offering the opportunity for additional amounts of interest. When declared, additional amounts of interest remain in effect for the 12-month period beginning January 1st. Additional interest is not guaranteed for future years. The contract provides a guaranteed effective interest rate of 1.50% and 0.98% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable.

While the Plan holds assets with AUL, the Plan is required to keep the AUL Stable Value Account as an investment option in the Plan. AUL may terminate the contract with individual participants who fail to keep sufficient funds invested in the contract, as defined in the contract.

6. TAX STATUS

The Plan has adopted the OneAmerica Financial Partners, Inc. ("OneAmerica") 403(b) Volume Submitter Plan. The Internal Revenue Service has informed OneAmerica by a letter dated November 22, 2017, that its volume submitter plan is designed in accordance with applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. Although the Plan has been subsequently amended, the Organization believes the Plan is currently designed and has been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. The Organization did not identify any related parties to the Plan that were not also considered to be parties-in-interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation arrangements, expense allowances, or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Transactions conducted by the Custodian, and its affiliates, including fee offset and revenue sharing agreements, qualify as exempt party-in-interest transactions. Purchases and sales of investments managed by AUL, or their affiliates, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the plan documents and are specifically exempt under ERISA.

Some fees and expenses of the Plan relating to legal, accounting, and other administrative services are paid by the Company. The Plan is not required to repay expenses paid by the Organization on its behalf.

The Custodian retains as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions.

Certain Plan investments are managed by the Custodian, therefore, these investment transactions qualify as exempt party-in-interest transactions.

9. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available for issuance.

Effective July 1, 2025, the Organization terminated its contract with AUL and entered into a new service agreement with Standard Retirement Services, Inc. and Reliance Trust Company to provide custodial and record-keeping services, respectively.
