We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules for Reporting and Disclosure under ERISA.

Other Matter – 2023 Financial Statements

The financial statements of New York State Nurses Association Benefits Fund as of December 31, 2023, were audited by other auditors whose report dated October 7, 2024, expressed an unmodified opinion on those statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the New York State Nurses Association Benefits Fund (the “Fund”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Fund’s provisions.

General

The Fund is a multiemployer defined benefit welfare plan that was established in 1972 and was created to provide health and welfare benefits to participants, covered by the collective bargaining agreements (CBAs) between the New York State Nurses Association (“NYSNA”) and the employer facilities, and their families and dependents. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits

The Fund provides basic medical, major medical and hospitalization coverage to participants under a self-funded arrangement. This arrangement is administered by Anthem BlueCross BlueShield (“Anthem”) (formerly Empire BlueCross BlueShield). In addition, the Fund administers self-funded programs for long-term disability benefits and accidental death and disbursement benefits. Express Scripts administers the Fund’s self-funded pharmaceutical benefits and Aetna administers the Fund’s self-funded dental benefits. Life insurance, short-term disability insurance, and paid family leave insurance are provided through MetLife. Optical coverage is provided through Davis Vision.

Plan Eligibility

The Fund covers all full-time and substantially all permanent part-time registered nurses and other health care professionals employed by those employers (primarily medical institutions) whose CBAs with NYSNA for such employees include benefits coverage. Also covered are all full-time and substantially all permanent part-time employees of the Fund and the New York State Nurses Association Pension Plan (the “Pension Plan”), provided that contributions are made to the Fund on behalf of the employees.

Employer Contributions

Contribution rates are approved by the Board of Trustees semi-annually based upon the recommendation of the Fund’s actuary. The level of contribution each employer has agreed to make to the Fund is determined by the plan coverage option selected and is included in the CBAs between NYSNA and each employer. Certain employers may require active participants to contribute specified amounts as outlined in the CBAs between NYSNA and each respective employer, and these participant contributions are included in “employer contributions” in the financial statements.

Participant Contributions

Participants may contribute specified amounts determined by the Fund’s actuary to extend coverage beyond termination from the employer as required under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). The amounts are included in “participant COBRA contributions” in the financial statements.

Bridge to Medicare

Beginning January 1, 2020, certain facilities provided “Bridge to Medicare Continuation Coverage” to eligible retirees and their eligible dependents (“BTM Program”). The new benefit permitted eligible retirees to elect, upon their loss of coverage due to early retirement, to receive continuation coverage for themselves and their eligible dependents, including vision and dental coverage, from the date of their loss of coverage due to early retirement until the date the participant becomes Medicare eligible (age 65).

Under the terms of the CBA, the employer facilities would make a total of \$16,000,000 in contributions to the Fund for the period from January 1, 2019 to December 31, 2022 to subsidize the full monthly premium for such coverage. The Board of Trustees had no authority to increase the contribution beyond \$16,000,000. Retiree contributions were required if the projected or actual cost of coverage exceeds \$4,000,000 per year (plus any available reserves in excess of \$2,000,000).

The BTM Program was terminated effective June 1, 2021, and a new pre-65 Retiree Health benefit, to be known as the NYSNA Benefits Fund Bridge to Medicare Health Reimbursement Arrangement Plan (the “BTM HRA”) was implemented. Eligibility is limited to retirees and shall otherwise be the same as provided for in the BTM Program. Participant’s dependents are excluded from coverage. Beginning with the contributions for the month of June 2021, employer contributions went to the BTM HRA. The BTM HRA reimbursed eligible participants for qualified medical expenses, up to a maximum amount determined by the Fund Trustees.

1. DESCRIPTION OF THE PLAN (Continued)

Bridge to Medicare (Continued)

The BTM HRA is a separate plan from the Fund but is under the same trust and with the same Board of Trustees of the Fund. However, a separate Form 5500 is filed for the BTM HRA and the assets of the BTM HRA will be separately held and accounted for under the plan assets in trust for the Fund. Effective June 1, 2021, the assets, liabilities, and benefit obligations related to the BTM Program were transferred from the Fund to the separate BTM HRA and are no longer reported in the Fund's financial statements except for a cash reserve for run out of claims under the terminated BTM Program. Any portion of the reserve not required for payout of such run out of BTM Program claims shall be utilized for the BTM HRA. As of December 31, 2024 and 2023, the remaining BTM Program benefit obligation reported totaled \$221,445 and \$212,061, respectively, and is included in "Postretirement - Bridge to Medicare" in the financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Fund are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Fund management to make estimates and assumptions that affect certain amounts reported in the financial statements. Actual results could differ from those estimates, and such differences may be significant.

Cash and Cash Equivalents

The Fund's cash and cash equivalents consists of an interest-bearing operating checking account. The Fund maintains cash balances at a financial institution that may, at times, exceed federally insured limits. The Fund has not experienced any losses in these accounts and believes it is not exposed to any significant risk with respect to cash.

Investments

The Fund invests in a mutual fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the accompanying financial statements. The Fund's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Fund's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements

Accounting Standards Codification 820 (ASC 820) established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lower priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and,
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual fund: Valued using the market approach and Level 2 inputs at the quoted closing price of the underlying assets of the pool or using the income approach based on yields currently available on comparable securities of issuers with similar credit ratings.

The method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Fund believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Employer Contributions Receivable

Employer contributions receivable represents amounts due from medical units for contributions billed but not received net of allowances for credit losses. This balance is stated at the amount billed, which is due on the first of each month. Unpaid contributions with invoice dates over 60 days old are considered delinquent.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Employer Contributions Receivable (Continued)

An allowance for credit losses is established by the Fund for amounts that are probable of not being collected. Account balances are charged off against the allowance after all means of collection have been exhausted and the potential for recovery is considered remote. Management monitors outstanding balances and estimates uncollectibility based on specific economic conditions. Upon management's determination of uncollectibility, the specific balance of such account is written off through the allowance for credit losses for potentially uncollectible employer contributions. No allowance for uncollectible receivables was considered necessary at December 31, 2024 nor 2023.

Furniture, Fixtures, and Office Equipment, net

Furniture, fixtures, and office equipment is stated at cost less accumulated depreciation. Depreciation is provided using the straight-line method to compute depreciation over the estimated useful lives of the related assets, which range from three to ten years. The Fund capitalizes assets that exceed \$2,500 and have useful lives greater than one year.

Leases

The Fund determines if an arrangement is a lease at inception. Right-of-use (ROU) assets represent the Fund's right to use an underlying asset for the lease term and lease liabilities represent an obligation to make lease payments arising from the lease. Lease ROU assets and liabilities are recognized at commencement date based on the present value of lease payments over the lease term. The lease may include renewal and termination options, which are included in the lease term when the Fund is reasonably certain to exercise these options.

For all underlying classes of assets, the Fund has elected to not recognize ROU assets and lease liabilities for short-term leases that have a lease term of 12 months or less at lease commencement and do not include an option to purchase the underlying asset that the Fund is reasonably certain to exercise. The Fund recognizes fixed short-term lease cost on a straight-line basis over the lease term and variable lease cost in the period in which the obligation is incurred.

The Fund elected for all classes of underlying assets, to use the risk-free rate as the discount rate if the implicit rate in the lease contract is not readily determinable.

Variable lease costs paid to or on behalf of the lessor, consisting mainly of property taxes, are excluded from the measurement of the right-of-use asset and lease liability and are expensed in the period incurred.

In evaluating contracts to determine if they qualify as a lease, the Fund considers factors such as if the Fund obtained substantially all of the rights to the underlying asset through exclusivity, if it can direct the use of the asset by making decisions about how and for what purpose the asset will be used and if the lessor has substantive substitution rights. This evaluation may require significant judgment.

Claims Reserve

Fund liabilities for claims incurred but not reported are estimated by the Fund's actuary in accordance with generally accepted actuarial principles. Management believes these estimates are adequate to cover the ultimate cost of claims incurred through December 31. Such estimates, however, may be more or less than the amount ultimately paid when the majority of claims are settled during the next year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Rebates

Rebates from prescription and medical drug programs are recorded when earned from the administrator and netted with benefit payments for self-funded programs. Rebates that have been earned but not yet received have been reported as a component of “other receivables” as of December 31, 2024 and 2023, and are detailed further within note 6 to the financial statements. These amounts are monitored by management for collectability and have been received from respective programs subsequent to year end. As such, no allowance for uncollectible receivables was considered necessary as of December 31, 2024 and 2023.

Benefit Payments and Insurance Premiums

Benefit payments to participants are recorded when paid. Medical, life, accidental death and dismemberment, short-term disability, and paid family leave insurance premiums are recorded when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Benefits payments under self-funded programs, including medical, dental, pharmaceutical, and long-term disability and accidental death and dismemberment claims, administered by third-party claims processors are recorded when submitted to the Fund by the claims processor for reimbursement. Benefit claims paid by third-party claims processors prior to year-end that are not reimbursed by the Fund as of year-end are typically recorded as a self-funded benefits payable (benefit obligation) and are not recorded as benefit payments until the Fund reimburses the claims processors.

Administrative Expenses

The Fund and the Pension Plan incur certain administrative expenses which are common to both the Fund and the Pension Plan. These common administrative expenses were allocated to the Fund at percentages ranging from between 10% to 90% based upon usage.

Risks and Uncertainties

Fund contributions and the Fund’s benefit obligation are prepared based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to the uncertainties inherent in this process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Reclassifications

Certain amounts from the 2023 financial statements have been reclassified to conform to 2024 presentation. Such reclassifications had no impact on the reported change in net assets for the year ended December 31, 2023.

3. CLAIMS RESERVE

The Fund has established actuarially determined reserves for incurred but not reported (IBNR) benefit claims associated with their self-funded programs for medical, dental, pharmaceuticals, long-term disability, and accidental death and dismemberment. The actuarially determined reserves are calculated by examining past claims patterns and determining the portion of claims incurred during a month that are paid within specific time periods. For recent months, when paid claims data is too sparse to develop estimated incurred claims by this method, trend assumptions and average claims per participant projections are used to develop incurred claims.

Depreciation expense for the years ended December 31, 2024 and 2023 was \$20,875 and \$24,777, respectively, and is included in “office supplies, postage and other” in the financial statements.

8. LEASES

The Fund and the Pension Plan entered into two real estate lease agreements with an unrelated party for office space on November 19, 2018. The leases had an initial term of 5 years and ended on December 31, 2023. The rental payments were allocated between the Fund and the Pension Plan. On April 4, 2023, the Fund and the Pension Plan entered into a new lease agreement with an unrelated party for reduced office space for the period January 1, 2024 to December 31, 2028. The building lease is considered an operating lease and has no option to renew. Rental payments totaled \$75,284 and \$131,867 for the years ended December 31, 2024 and 2023, respectively, and are included “rent” in the financial statements. The weighted average remaining lease term is four and five years as of December 31, 2024 and 2023, respectively, and utilizes a 3.84% weighted average discount rate for each year.

9. TAX STATUS

The trust established under the Fund to hold the Fund’s assets has received an exemption letter from the Internal Revenue Service (IRS) dated December 13, 2002, stating that the trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC) and, therefore, the trust’s net investment income is exempt from federal income taxes. The Fund and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Fund has been amended and restated since receiving the determination letter. However, the Fund management believes the Fund is currently designed and being operated in compliance with the applicable requirements of the IRC.

9. TAX STATUS (Continued)

The Fund received a notice from the IRS dated February 19, 2024 regarding the automatic revocation of its tax-exempt status, retroactive May 15, 2023, due to the failure to file Form 990 for its 2020, 2021, and 2022 tax years. The Fund applied for retroactive reinstatement of its tax-exempt status under Revenue Procedure 2014-11, with all required elements completed and submitted by April 14, 2024. As a result, the Fund’s application was processed and accepted by the IRS and retroactive reinstatement was granted.

For employee benefit plans, their tax-exempt status itself is deemed to be an uncertainty since events could potentially occur to jeopardize their tax-exempt status. The Fund files the Return of Exempt organization from Income Tax (Form 990) and the Annual Return/Report of Employee Benefit Plan (Form 5500) in the U.S. federal jurisdiction.
