## INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Administrative Committee and participants of the McLarens, LLC Defined Contribution 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the financial statements of the McLarens, LLC Defined Contribution 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ### 1. Description of the Plan

The following description of the McLarens, LLC (the Company or Plan Sponsor) Defined Contribution 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all U.S. employees of the Company, who have completed one month of service and have attained the age of 18. Nonresident aliens and leased employees are not eligible to participate in the Plan. Part-time and temporary employees are eligible to participate in the Plan after completing a year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated effective September 4, 2024.

#### Contributions

All eligible employees are automatically enrolled into the Plan and pre-tax contributions are withheld at 3% of eligible compensation and will auto escalate by 1% each year to the maximum of 8%, unless the participant elects differently. Each participant may make pre-tax and/or Roth contributions of up to 75% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024. Eligible participants who have attained age 50 before the close of the Plan year are allowed to make "catch-up" contributions of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make matching contributions at the discretion of Board of Directors. These contributions are made each pay period. During 2024, the Company made matching contributions to participants in an amount equal to 50% of the participant's contribution to the extent matching contributions did not exceed 6% of the participant's eligible compensation, which totaled \$2,122,914.

The Company may also make discretionary profit-sharing contributions to the Plan. The discretionary profit-sharing contributions are allocated to participants' accounts based on compensation. There were no discretionary profit-sharing contributions made during the year ended December 31, 2024.

The Company may make additional true-up matching contributions for the Plan year. These true-up contributions will be made to the participant's accounts at the end of each Plan year. A participant must have met the eligibility requirements to participate in the Plan and must be employed by the Company on the last day of the Plan year except for death, disability, or retirement. As of December 31, 2024 and 2023, the true-up matching contribution receivable

totaled \$106,800 and \$73,704, respectively. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

### Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contribution, revenue sharing allocation, and earnings and losses on the investments in their account. Each participant's account is charged with a quarterly administrative expense fee and certain transaction fees. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis. The Plan also offers a self-directed brokerage account as an additional investment option for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions and rollovers plus earnings and losses thereon. Vesting in the employer contribution portion of their accounts is based on the number of years of service with the Company. Participants vest 50% after two years of service and 25% per year beginning in Year 3 until they are fully vested upon the completion of four years of service.

### Forfeitures

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$298,950 and \$174,564, respectively. These accounts may be used to reduce employer contributions or to pay administrative expenses of the Plan. During 2024, \$0 from forfeitures were used to reduce employer contributions or pay administrative expenses.

### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. A participant may have two notes outstanding at any time. The notes are secured by the balance in the participant's account and bears interest at rates determined by the Plan. During 2024, notes had fixed rates ranging from 5.25% to 10.50% for the term of the note (not to exceed five years, unless used for the purchase of a primary residence). Principal and interest are paid through payroll deductions. The notes receivable from participants also qualifies as party-in-interest transactions.

### Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account as a lump sum distribution, installment, or partial payments. Participants are eligible to receive hardship withdrawals when certain conditions are met and may take a withdrawal after reaching age 59 ½. If a participant

terminates employment and has a small account balance, the participant will receive a single-sum payment or rollover to an eligible plan equal to the value of the account as soon as reasonably practicable following the date of termination.

### **Administrative Expenses**

Transaction fees related to notes receivable from participants and distributions are charged directly to the participant that initiated the transactions. Each quarter, a recordkeeping fee is deducted from each participant's account and paid directly to the Plan. For 2024, a total of \$68,564 was deducted from participant accounts and used to pay administrative fees related to the Plan. The payments are included in administrative expenses when paid. A quarterly administrative fee is also deducted from each participant's account and transferred into the Plan's administrative budget account. The balance may be used to pay for fees and expenses associated with services related to the Plan or to pay vendors. For 2024, the Plan deposited \$67,286 into the administrative budget account from participant accounts and used \$51,798 to pay audit and administrative fees related to the Plan. Deposits to this account are included in net change in fair value of investments in the accompanying statement of changes in net assets available for benefits. Payments from the account are included in administrative expenses when paid. At December 31, 2024 and 2023, the balance in the administrative budget account was \$15,790 and \$482, respectively.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

### **Contributions**

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The employer matching and discretionary profit-sharing contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Board of Directors of the Company. Any unfunded participant or employer matching contributions are included in the employee or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

### **Investment Valuation and Income Recognition**

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net change in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on investments.

### **Notes Receivable from Participants**

Notes receivable are carried at their outstanding balance. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a deemed distribution is recorded.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

### **3. Information Certified by the Qualified Institution**

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, included the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by T. Rowe Price Trust Company (T. Rowe Price), the Plan's qualified institution.

### **4. Investments**

Certain plan investments include mutual funds, a stable value fund, and self-directed brokerage accounts managed by T. Rowe Price, therefore, transactions in these investments qualify as party-in-interest transactions.

Investments are exposed to various risks, such as market, currency, interest rate, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include public healthcare emergencies such as a pandemic, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The FASB established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets or liabilities in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds are stated at quoted market prices for the identical security in an active market (Level 1).

The Plan invests in a stable value fund held in a common collective trust. The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs. The stable value fund trades daily at the net asset value (NAV) per share of the fund, which is based on the contract value of the underlying investments (Level 1). The stable value fund includes certain redemption restrictions. If the Plan chooses to redeem all or a significant portion of the stable value fund, the issuer may require a 12-month wait period to redeem.

The self-directed brokerage account includes cash, common stock, mutual funds, and unit investment trusts. All investments in the self-directed brokerage account can be traded daily and are considered to be Level 1.

### 5. Income Tax Status

The Plan is operating under a non-standardized pre-approved profit sharing/money purchase/CODA plan document offered by T. Rowe Price Retirement Plan Services Inc (TRPRPS), an affiliate of T. Rowe Price. TRPRPS received an opinion letter from the Internal Revenue Service, dated August 19, 2020, which states that the plan satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter and has been amended since TRPRPS received the opinion letter. However, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns, since inception, are subject to examination by taxing authorities and may change upon examination.

The plan administrator has not completed the discrimination testing for the year ended December 31, 2024. Upon completion of this testing, the Plan may have to take corrective action by either 1) refunding excess contributions and earnings thereon to participants or 2) making a qualified non-elective contribution to identified non-highly compensated employees.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their account balance.
