Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Autism Speaks, 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Autism Speaks, 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions. Effective January 1, 2018, the Plan was amended and restated to become a Safe Harbor Plan.

General

The Plan is a defined contribution plan covering all eligible employees, as defined, of Autism Speaks, Inc. (Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustee is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible to make participant contributions and receive safe harbor matching contributions beginning the quarter after being hired, provided they have attained 21 years of age. For purposes of discretionary employer contributions, substantially all employees of Autism Speaks, Inc. who have at least one year of service (defined as 1,000 hours of service starting from the hire date to the first year anniversary) are eligible once they have attained 21 years of age.

Contributions

Each year, participants may contribute up to 100% of their eligible compensation up to certain Internal Revenue Service (IRS) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as permitted under the Internal Revenue Code (the Code). Participants may also contribute amounts distributed from other qualified plans. The Plan Sponsor will make a safe harbor matching contribution of 100% up to 3% of participants' eligible compensation and a 50% match on the next 2% of their eligible compensation. The Plan Sponsor may make a discretionary contribution for each Plan year in an amount determined by it. The Plan Sponsor has not made any discretionary contributions for the 2024 Plan year.

Participants direct the investments in their accounts into various investment options offered by the Plan, which include a fixed annuity contract, a pooled separate account and registered investment companies.

Participant Accounts

Each participant's account is credited or charged with: i) the participant's contributions; ii) The Plan Sponsor's safe harbor matching contributions; iii) net earnings (loss) on his or her account; and iv) an allocation of certain expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Forfeited balances of non-vested non-safe harbor employer contributions are used to reduce future employer contributions from the Plan Sponsor. Participants are immediately vested in their contributions and safe harbor matching contributions, plus actual earnings thereon. Upon reaching normal retirement, disability or death, a participant's account also becomes fully vested. Discretionary employer contributions and employer profit sharing contributions are subject to vesting of 20% after two years of service with an additional 20% vesting for each additional year of service thereafter, up to a maximum vesting in accrued benefits of 100%.

Payment of Benefits

Upon normal retirement, disability, hardship, death or separation from service, participants receive their vested benefit in a lump sum.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance, as adjusted, or \$50,000. Loans are payable over no more than five years (except for loans to acquire a principal residence), are secured by the participant's account and bear interest at a rate to be determined by the Plan Administrator. Interest rates ranged from 5.25% to 10.50% as of December 31, 2024 and 5.25% to 10.25% as of December 31, 2023. Principal and interest are payable through monthly payroll deductions.

Forfeited Accounts

At both December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0. These accounts are used to reduce future employer contributions or cover administrative expenses. During the year ended December 31, 2024, \$280 of forfeitures were used to reduce administrative expenses and \$29,621 were used to offset Plan sponsor contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's investments in fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The methods used to determine fair values for the Plan's investments are discussed in Note D.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought, sold and held during the year.

Fully benefit-responsive investment contracts held by the Plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive investment contract because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses to maintain the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administration expenses. Certain other management fees and expenses are deducted from investment income and, therefore, reflected as a reduction of investment returns.

NOTE C - INVESTMENTS AND INFORMATION CERTIFIED BY CUSTODIAN

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal Trust Company), record-keeper and a custodian of the Plan and Principal Life Insurance Company, a custodian of the Plan, have certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, contract value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment gain and interest income on notes receivable and notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4(i) - schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in registered investment companies: Investments in registered investment companies (mutual funds) are valued at quoted market prices, which represent the unit values per share held by the Plan at year end.

Investments at NAV (Pooled separate account): The pooled separate account invests in a wide range of mutual funds and other investments that have observable, quoted pricing inputs. While the underlying asset values are quoted prices, the net asset value (NAV) of a separate account is not publicly quoted. ASC 820 allows NAV per share to serve as a practical expedient to estimate the fair value of a separate account and common collective trust fund as long as certain requirements are met. The pooled separate account funds are available for immediate redemption within the Plan and participant transactions may occur once within a 30-day period. There are no unfunded commitments.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable values or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Principal Fixed Income Guaranteed Option is a guaranteed fixed annuity contract available as an investment option to Plan participants with a contract value of \$372,115 and \$414,878 as of December 31, 2024 and 2023, respectively. Each contract is fully and unconditionally guaranteed by Principal Life Insurance Company. The Plan's custodian maintains the contributions in a general account. The accounts are credited with earnings based on the crediting interest rate and charged for participant withdrawals and administrative expenses.

Since the contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive investment contracts. Contract value, as reported to the Plan by the custodians, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate was 1.55% at December 31, 2024 and 2023.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with the issuers. Such events include: (1) amendments to the Plan document (including complete or partial Plan termination or merger with

another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Plan management does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The investment contracts do not permit the issuer to terminate the contract prior to the scheduled maturity date.

NOTE F - TAX STATUS

The Plan was amended and restated effective January 1, 2018. The underlying volume submitter plan associated with the restated plan has received an opinion letter from the IRS dated June 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is tax exempt. In accordance with Revenue Procedures 2014-6 and 2011-49, the Plan Administrator has determined that it is eligible, and it has chosen, to rely on the current IRS volume submitter plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan Administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no material uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G - PLAN TERMINATION

Although it has not expressed any such intent, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

NOTE H - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST TRANSACTIONS

The Plan holds fully benefit-responsive investment contracts and units in a pooled separate account that are managed by the custodians. Certain administrative functions of the Plan are performed by employees of Plan Sponsor. No such employee receives compensation from the Plan. The Plan permits notes receivable from participants. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

NOTE I - PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Company failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States Department of Labor Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. Plan management is working to correct all late remittances.

NOTE J - RISKS AND UNCERTAINTIES

The Plan invests in several investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term. The changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE K - SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued. There were no subsequent events that would require recognition or additional disclosure in the Plan's financial statements.
